Bylaw No. 9954 makes amendments to Bylaw No. 9170, The Procedures and Committees Bylaw, 2014 to:

- (a) change the rules to extend Council meetings from requiring the unanimous consent of Council members present to requiring a two-thirds vote of Council members present at the time of the vote; and
- (b) make minor housekeeping amendments including the correction of a section reference and to update names of divisions to align with the City's current corporate structure.
