7. REPORTS FROM ADMINISTRATION

7.1 Environmental and Corporate Initiatives (File CK. 7550-1)

Director of Environmental & Corporate Initiatives Wallace was in attendance and updated the Committee on the following:

- The Solar City program initiative is not being pursued this year. City Council has recently requested information on property tax tools available to administer an energy efficient retrofit program in Saskatoon. Some of the tax tools available include tax abatements, grants, and possibly third-party city lending offering. The Saskatchewan Municipal Board will be contacted for their input on the matter. The Administration intends to submit a report on opportunities to use the property tax system to administer a program as noted-above to the Standing Policy Committee on Environment, Utilities & Corporate Services in April 2016.
- City Council put forth three resolutions pertaining to the Saskatchewan Environmental Society's letter on a GHG strategy (these will be forwarded to the Committee by Environmental & Corporate Initiatives Division).
- City Council resolved to write to the Provincial Government to discuss opportunities to partner to achieve the goal of 50% renewal energy by 2030; and that the Administration report back on solar installation on City or privately-owned property.

- 1. Advocate for the creation of a Climate Change strategy for the City of Saskatoon, including a comprehensive greenhouse gas (GHG) emissions reduction plan.
- A. SEAC will advocate for reduction in GHG emissions through strategic initiatives, as appropriate, in the domains of:
 - i) Building Codes and Neighbourhood Design
 - ii) Electricity Generation and Renewable Energy Sources
 - iii) Industrial Emissions
 - iv) Transportation
 - v) Public Education
- B. SEAC will advocate for the revival of the Solar City Initiative (or similar program), which had been developed by the City in 2014, but was not funded in 2015.

- C. SEAC will continue to monitor and advise on work related to water and wetland conservation and storm-water planning.
- 2. Continue to develop greater linkages with Council's Standing Policy Committee on Environment, Utilities & Corporate Services, through the provision of monthly in-person reports of SEAC members to the Standing Policy Committee, and formal communication of annual goals.
- 3. Continue to support city-wide waste diversion initiatives as opportunities arise, through formal advocacy (i.e. providing letters of support) on organic waste diversion options.
