#### 1. Core Neighbourhood Study Review 1990 Bylaw No. 7212 - Brunskill (File No. CK. 4353-1)

City Council considered Clause 1, Report No. 1-1992 of the Planning and Development Committee at its meeting held on January 6, 1992 and ADOPTED the following recommendation:

"5) that at the time of the Public Hearing, Council receive a report and recommendation from the Municipal Planning Commission."

The Municipal Planning Commission has considered this proposed amendment to the Development Plan and has determined that the owner-occupancy rate in this area is 80 percent or higher, which is the rate used as a measure of stability and commitment to the neighbourhood. The Commission has also determined that this proposed amendment would increase the number of non-conforming properties by only two. There are very few sites in the area that could accommodate a three or four unit dwelling because of insufficient frontages, and residents of the neighbourhood do not want the conversion zoning, they want to protect the residential nature of their neighbourhood.

The Municipal Planning Commission therefore supports this proposal for the following reasons:

- i) boarders are allowed to be kept in this area, which would accommodate the needs of university students;
- ii) conversions have not been taking place, even in better economic times, and therefore there is no demand for this zoning; and
- iii) residents of the area want to maintain the residential nature of the neighbourhood.

# **RECOMMENDATION:** that the following recommendation be brought forward under Item No. 4a) of Unfinished Business:

"that the proposed amendment to the Development Plan be APPROVED."

Report of the City Engineer, April 2, 1992:

"The section of roadway to be utilized by the Saskatoon and District Safety Council is the same section that was used during their motorcycle training in 1990 and 1991. There is no inconvenience to the general public because of this road closure.

The City Engineering Department will supply the necessary signing and barricading required for this road closure, and the Saskatoon and District Safety Council will be responsible for the proper erection and dismantling of the traffic controls."

# **RECOMMENDATION:** that City Council approve the requested closure of a portion of Malouf Road from 6 p.m. to 9 p.m., Monday through Friday, and from 9 a.m. to 12 noon every second Saturday, from the beginning of May to mid-August 1992.

#### A2) School Signing Replacement--Lawson Heights School (File No. 6280-1)

Report of the City Engineer, April 6, 1992:

"The Engineering Department has received a request from the Saskatoon Board of Education to review the signing on Redberry Road at Lawson Heights School and for the installation of a Handicapped Person's Loading Zone. The review has been completed and it is proposed that the following changes be made to the signing on this school frontage.

The investigation procedure for this school included:

- the preparation of a plan of the existing signing;
- a site meeting between a representative of the Engineering Department, the Saskatoon Board of Education, and the principal of the school involved; and,
- consultation with the Traffic Section of the City Police.

Based on the results of this investigation, a new school signing plan was formulated using the School Signing Guidelines and considering the needs of this particular school.

The signing required to improve pedestrian and traffic safety at this school is indicated on Plan No. L2-1M (S.S.) and is described briefly below. The signing changes will only affect the north side of Redberry Road between Reindeer Road and Frobisher Crescent.

It is proposed that the existing signing be removed and replaced with the following:

- a 'No Stopping' zone at the main school entrance;
- a `Handicapped Person's Loading Zone' for a distance of 12m to the west of `No Stopping'

zone;

- a `School Bus Loading Zone' for a distance of 25 metres west of the `Handicapped Person's Loading Zone';
- a 'No Parking' restriction from the 'School Bus Loading Zone' to the far side of the Reindeer Road intersection;
- a 'No Parking' zone restriction at the entrance to the school parking lot; and,
- a `5-Minute Parking, 0800-1700, Monday to Friday' restriction between the `No Stopping' and `No Parking' zones.

No residential frontage will be affected by the signing changes. All of the above changes have been reviewed and approved by the City Police and the Saskatoon Board of Education and conform to present City policy with respect to school signing."

#### **RECOMMENDATION**:

that the signing changes at Lawson Heights School as shown on Plan No. L2-1M (S.S.) be approved.

A4) Request for Banner Installations Promotional Sale by Merchants in an Area from 33rd Street to Circle Drive and Quebec Avenue to Idylwyld Drive May 7, 8 and 9, 1992 (File No. CC 312-2)

Attached is a letter dated March 18, 1992, from the Promotions Coordinator of The StarPhoenix requesting permission to install promotional banners (i.e. vertically hanging pennants) from street light poles in the area bounded by 33rd Street, Quebec Avenue, Circle Drive and Idylwyld Drive as noted above.

A similar request was granted last year. The City Electrical Distribution Department installed the banners and charged the Star-Phoenix for the work. The Department is prepared to do the same again this year.

# A5) Supply of Aggregate for 1992 Contract No. 2-0005 (File No. CC 1000-4)

Report of the City Engineer, April 8, 1992:

"Tenders were received and opened publicly on April 7, 1992, for the processing, supply and delivery of aggregate to City projects during the period May 1, 1992, to April 30, 1993. This material will be used primarily for road construction, street and lane maintenance, street sanding, and pipe bedding.

The following local firms submitted tenders:

- 1. ASL Paving Ltd., Saskatoon,
- 2. Geransky Brothers Construction Ltd., Martensville, and
- 3. Revelstoke Redi-Mix Limited, Saskatoon.

The unit prices are summarized on the tabulation sheets attached. The tender documents specify that the City may accept any or all of a bidder's tendered prices, and may award the various bid items to different firms. Each bid item is individually evaluated in determining the recommended award.

The bidder quoting the lowest total unit price is recommended in all cases. Revelstoke Redi-Mix Limited has satisfactorily supplied similar materials to the City in the past. ASL Paving Ltd. has been a regular asphalt supplier to the City, and has provided its own base aggregate for a past City road paving project. Geransky Brothers Construction Ltd. has been a regular concrete supplier to the City and is qualified to produce the recommended material.

Based on estimated quantities, the total cost for the recommended awards is \$555,455.05, including G.S.T., P.S.T., and G.S.T. rebate. By comparison, the total cost at 1991 prices would have been \$460,436.34. Substantially reduced quantities in the 1992 contract, down 28.4% from 1991, are the most likely reason for the 20.6% price increase over 1991. Several large construction projects in 1992 have contractor-supplied aggregates, thus limiting this contract's requirements mainly to maintenance work."

**RECOMMENDATION**: 1) that City Council accept the unit prices submitted by ASL Paving Ltd. for the supply of the following items for a total estimated cost of \$162,035.41 including G.S.T., P.S.T., and G.S.T. rebate:

Item 2 - 4,100 tonnes of base aggregate, west side of the river at \$6.20 per tonne, and

Item 3A - 21,500 tonnes of maintenance base aggregate to the City Yards at \$6.10 per tonne;

Report of the City Engineer, April 8, 1992:

"Tenders for the 1992 supply of types 3 and 4 asphalt mix were received and opened publicly on April 7, 1992. This material is used primarily for street maintenance and pavement restoration.

Tenders were received from the following firms:

- 1) ASL Paving Ltd., Saskatoon, and
- 2) Central Asphalt and Paving Inc. Saskatoon.

Bid prices include G.S.T. and P.S.T., and are summarized on the attached tabulation form.

Under provision of this unit price contract, the City has the right to divide the contract into any number of bid items and to award the bid items to different bidders. Acceptance of the low bid prices is recommended for asphalt tender items. Truck box cleanings and weekend supply are split according to award of asphalt tender items.

The total estimated contract cost is \$752,821.09, including G.S.T., P.S.T., and G.S.T. rebate. This represents an average 0.25% increase from the asphalt mix supply tender of 1991."

#### **RECOMMENDATION:** 1)

that City Council accept the unit prices submitted by ASL Paving Ltd. for the supply of the following items at a total estimated cost of \$728,556.75, including G.S.T, P.S.T., and G.S.T. rebate:

Item 1 - 19,337 tonnes of type 3 asphalt mix at \$37.16 per tonne,

Item 4 - 195 tonnes of weekend or holiday supply of asphalt mix at \$3.25 per tonne, and

Item 5 - 1,934 truck box cleanings at \$2.03 each;

2) that City Council accept the unit prices submitted by Central Asphalt and Paving Inc. for the supply of the following items at an estimated cost of \$24,264.34, including G.S.T., P.S.T., and G.S.T. rebate:

Item 2 - 302 tonnes of type 4 asphalt mix at \$54.65 per tonne,

Item 3 - 200 tonnes of type 1 asphalt mix at 37.36 per tonne, and

Item 5 - 50 truck box cleanings at \$2.14 each; and,

3) that the City Commissioner and the City Clerk be authorized to execute the contract documents as prepared by the City Solicitor under the Corporate Seal.

ADOPTED.

A7) Request from The Partnership Sidewalk Sales (File No. CC 300-11)

At its meeting held on May 7, 1990, City Council approved that, on a trial basis, sidewalk selling within the Downtown Business Improvement District be allowed for Thursdays and Saturdays between May 1 and September 30 subject to certain conditions. No problems were experienced with sidewalk selling in 1990, and the approval was extended administratively to permit sidewalk selling in 1991 and to include the Broadway and Riversdale Business Improvement Districts. The Partnership has recently requested that sidewalk selling be allowed in the downtown area this summer.

Report of the City Engineer, April 9, 1992:

"The Engineering Department has reviewed the attached request from The Partnership to permit sidewalk selling in the downtown area on Thursdays and Saturdays. This practice has occurred during the past two summers without any major concerns. The following conditions applied during

1990 and 1991:

- 1. that a minimum 2.0 metre (6.5 feet) sidewalk clearance be maintained adjacent to the curb;
- 2. that the City reserve the right to restrict or prohibit sidewalk selling at certain locations due to safety or operational concerns;
- 3. that sidewalk selling be limited to Thursdays and Saturdays, between May 1 and September 30; and,
- 4. that sidewalk sales be limited to the Business Improvement Districts, with requests from other areas handled separately.

The Engineering Department recommends that sidewalk selling be permitted in 1992 subject to the above conditions.

It appears that the practice of sidewalk selling on Thursdays and Saturdays should be formally incorporated into the City's sidewalk selling policy. The Engineering Department will therefore initiate a review of this policy and forward a separate report on this matter to City Council at a later date."

#### **RECOMMENDATION**: 1

- 1) that the above report regarding sidewalk selling be received;
- 2) that sidewalk selling be allowed in 1992 on Thursdays and Saturdays between May 1 and September 30 subject to the conditions contained in this report; and,
- 3) that a further report be received regarding a review of the existing sidewalk selling policy.

# A8) Automated Residential Garbage Collection Reduced Winter Service (File No. CC 7830-3)

On January 6, 1992, while discussing the 1992 Operating Budget, City Council adopted the following resolution with respect to solid waste management:

Report of the City Engineer, April 6, 1992:

"City residents are starting to clean-up their yards, thus increasing the amount of residential waste. Therefore, effective April 13, 1992, the garbage collection will revert back to once per week pickup."

**<u>RECOMMENDATION</u>**: that the information be received.

This proposal has been submitted by the Authority and involves the construction of an extension to the Trail, as well as various associated amenities, within Cosmopolitan Park and along Saskatchewan Crescent East. The City will be required, under the proposed amended agreement, to provide for the on-going maintenance of these improvements.

The Administration has reviewed the amendment and supports the construction which has been proposed. If the agreement is approved by City Council, the Authority plans to undertake this work in 1992.

"MasterCard Dive Canada '92 is an international diving event with Olympic-calibre divers from at least nine countries competing April 27 to May 3, 1992, at the Harry Bailey Aquatic Centre.

The potential amusement tax could amount to \$6,500.

Inasmuch as the competition is an international event similar to others that have been exempted in the past, we would recommend it also be exempted."

**RECOMMENDATION:** that MasterCard Dive Canada '92 be exempted from amusement tax for its competition April 27 to May 3, 1992.

Council also requested me to report on whether the Council Procedure Bylaw allows any debate on third reading, and whether the provisions of the Council Procedure Bylaw can be overruled.

The Council Procedure Bylaw states that there shall be no debate on the motion to read a bylaw for the first time, and that a bylaw cannot have more than two readings at one meeting except by unanimous vote of Council. The absence of a statement regarding debate on third reading is interpreted as allowing it. Normally, City Council does not debate on third reading because unanimous approval is usually given to have third reading at the same meeting as the bylaw is introduced. Any debate is therefore done at the Committee stage, between second and third readings. However, in the case where third reading is to be given at a subsequent Council meeting, it would seem logical that debate be allowed.

In terms of Council overruling any provisions of the Council Procedure Bylaw, Section 40 states that any or all of the rules contained in the Bylaw may be suspended at one meeting by a unanimous vote of all Council."

# C6) 1992 Operating Budget Letter - North Saskatoon Business Association (File No. CC 1704-1)

At its meeting of April 9, 1992, City Council received a copy of a letter from the North Saskatoon Business Association in which that organization identified expenditures in the 1992 City of Saskatoon Operating Budget which they felt could be reduced. Council referred the letter to the Administration for a report on any items identified in the letter which would result in a further reduction to the mill rate.

In many cases, this was not possible, and Council recommended changes to service levels. To suggest that further cuts are possible without affecting service, is incorrect. It is therefore our recommendation that no further budgetary reductions be proposed.



# 1. Second Avenue Redevelopment -Temporary Street Closure (File No. CK. 6295-1)

The scheduled redevelopment of Second Avenue will require the temporary closure of portions of such street throughout the period May 1, 1992, to August 31, 1992. While *The Urban Municipality Act, 1984* and Traffic Bylaw No. 7200 confer sufficient authority on the City Engineer to effect such temporary closure, where the closure relates to a major street for a prolonged period, the Administration has adopted the practice of referring the matter to City Council for express authorization.

In this regard, the City Solicitor's Office has prepared proposed Bylaw No. 7289, being "A bylaw of The City of Saskatoon to provide for the temporary closure of a portion of Second Avenue, in the City of Saskatoon." The proposed Bylaw authorizes the City Engineer to close effected portions of Second Avenue to vehicular and pedestrian traffic from time to time throughout the period May 1, 1992, to August 31, 1992, as construction conditions and the safety of the public warrants. A copy of the bylaw is attached.

**RECOMMENDATION:** that Council consider Bylaw 7289 at this meeting.

ADOPTED.

2. Engineering Services Agreement High Lift Pumping Facility Upgrade Project Number 715 Water Treatment Plant (File No. CK. 670-2)

The following is a report of the Manager, Water and Pollution Control dated March 27, 1992:

"The current Water and Sewage Utility Capital Budget includes \$1,591,000 for the upgrade of a high lift pumping facility at the City of Saskatoon's Water Treatment Plant. The purpose of this project is to replace three small, forty year old pumps, which have reached the end of their service life, with one 20 MIGD pump. The replacement of three small pumps with one large unit will result in a significant savings on maintenance costs as well as an increase in flexibility and efficiency of the high lift pumping system with the installation of a variable speed drive controller in the future.

The project will be carried out in two stages. The first stage included the design and construction of a new pump room to house the replacement pump. On February 3, 1992, Council approved awarding the contract for the construction of this first stage to the firm of Stuart Olson for a Contract Net Price of \$479,877. The work included inlet piping connecting the new pump room to existing clear wells, a 12.8 m x 10.0 m x 12.7 m building structure, and appropriate heating, lighting, and ventilation. The construction began in late February and is scheduled to be completed in the fall of 1992. The preliminary conceptual design, the detailed structural design and general engineering services for the first stage of the project were provided by the firm of Catterall & Wright.

The second phase of the project includes the supply and installation of a 20 MIGD pump and 1500 HP motor, its high voltage switchgear and starters, valving, a flowmeter, and all piping necessary to connect the pump to the City's distribution system. The estimated construction cost of this work is \$700,000.

Terms of reference for engineering design and construction supervision were prepared. Because of their familiarity with the project, Catterall & Wright was asked to submit a proposal for the design and engineering services during construction for this phase of the project. Their attached proposal includes a scope of engineering services that entails 866 staff hours to provide the following services:

- finalize the requirements, conditions and scope of work with Department staff;
- prepare design drawings and specifications for incorporation into tender documents;

- answer bidder's questions and consider requests for equivalent status from suppliers during the tendering process;
- · review tenders and recommend award;
- inspect construction;
- · review and prepare progress certificates for payment;
- assist in negotiations with the contractor to order changes or to resolve problems; and,
- prepare as-built drawings.

The total cost of the engineering fees is estimated at \$50,000.

This firm's proposal is acceptable to the Department based on the following factors:

- 1) They have provided all engineering services for the first stage of this project in a satisfactory manner and are familiar with the work to be done.
- 2) The scope of engineering services offered for this stage of the project is acceptable.
- 3) The upset fee representing 7.1% of the estimated construction cost is reasonable for this work."

Your Committee has reviewed the report and

- **RECOMMENDS:** 1) that the engineering services required for the design and construction of Stage 2 of the High Lift Pumping Facility Expansion be awarded to Catterall & Wright Limited for an upset fee of \$50,000 including GST; and
  - 2) that the City Commissioner and City Clerk be authorized to execute the contract documents, as prepared by the City Solicitor, under the Corporate Seal.

# 3. Proposed Revision to Sunday Transit Service in Sutherland (File No. 7311-1)

City Council, at its meeting held on March 16, 1992, revised the Sunday transit route in Sutherland. The route was shortened in length in order to maintain the schedule.

The following is a report of the Transit Manager dated March 25, 1992:

"We have reviewed the routing and have determined that a revised routing can be operated that will provide improved coverage of Sutherland on Sundays, yet be operable within the existing schedule constraints. The proposed routing, as shown on the attached map, is as follows:

Eastbound on College Drive, northbound on Central Avenue, eastbound on 115th Street, southbound on Dunlop Street, westbound on Gray Avenue, northbound on Central Avenue, westbound on 115th Street, southbound on Egbert Avenue, westbound on 108th Street, southbound on Preston Avenue to College Drive and continue to downtown via the 25th Street Bridge."

A map indicating the proposed routing is attached.

**RECOMMENDATION:** that the Sutherland Sunday transit route outlined in the report of the Transit Manager dated March 25, 1992, be approved.

# 4. Proposed Bus Stop for Route 3 Rusholme Road and Witney Avenue (File No. CK. 7311-1)

City Council, at its meeting held on March 16, 1992, approved combining Routes 5 and 3 in the Mount Royal/Westmount areas in the evenings and on Sundays and holidays, commencing April 26, 1992.

Attached are diagrams indicating the location of existing bus stops and the proposed location of a new bus stop.

**RECOMMENDATION:** that City Council approve the proposed new bus stop on Rusholme Road and Witney Avenue.

# 5. Frequency of Peak Hour Service Routes 4 and 5 (File No. CK. 7310-1)

The following is a report of the Transit Manager dated April 6, 1992:

"Patronage on Saskatoon Transit is significantly less than estimated for the first three months of 1992. It is assumed that the major factor is the extremely warm weather that has occurred since the middle of January. Saskatoon Transit has made a preliminary review of expenditures and it is estimated that the reduced costs to date will not be sufficient to offset the decrease in revenue.

Our ongoing review of existing services indicate that the present weekday peak hour frequency of 15 minutes can be reduced to 30 minutes for both the Route 4 (Broadway and Clarence South) and Route 5 (Mount Royal/8th Street East). This will result in passengers standing, but not to the point where peak hour extras are required.

The change would be effective May 31, 1992, and the estimated cost savings would be \$73,000 in 1992. It would appear that the staffing plan can be adjusted so as to incorporate the change without a reduction in staff in 1992."

The Transit Department will consult with the School Board concerning the effect of the changes on the movement of children to and from Vanier School.

## **RECOMMENDATION:**

that the peak hour frequency on Routes 4 and 5 be reduced to every 30 minutes.

**REPORT OF CITY CLERK:** 

"Attached is a copy of Clause B5, Report No. 6-1992 of the City Commissioner, which was ADOPTED by City Council at its meeting held on March 16, 1992.

Also attached is a copy of notice which appeared in the local press under dates of March 21 and 28, 1992.

Report of the City Solicitor, April 8, 1992:

City Council, at its meeting on March 16, 1992, instructed the City Solicitor to prepare a bylaw to authorize the sale of Municipal Reserve MR4, Plan 79-S-22381. I have enclosed Bylaw No. 7285 for Council's consideration.

City Council also instructed the Administration to advertise Council's intention to consider this Bylaw in accordance with the requirements of Sections 201 and 207 of *The Planning* 

*and Development Act, 1983.* The *Act* requires that Council give notice of its intention to pass this kind of bylaw by advertisement inserted at least once a week for two consecutive weeks in a newspaper published or circulated in the area affected by the bylaw. The first of the notices must be published at least three weeks before the date for the public hearing to consider any representations about the bylaw. The required notice was advertised in the Saskatoon *Star Phoenix* on March 21 and March 28, 1992. The notice requirements set out in the *Act* have been met.

SaskTel and SaskPower have no facilities in this Reserve. They have no objection to the sale.

The civic departments who will be providing services to the site if it is sold have been consulted and anticipate no difficulties in providing services to the site. They have no objection to the sale.

We are also enclosing a copy of the Title to the property for Council's information.
