## PUBLIC NOTICE

### INTENT TO BORROW

City Council will be considering a report from Administration at a City Council meeting to be held on **Wednesday, September 27, 2023, at 6:00 p.m., hosted in the Council Chambers, City Hall** recommending:

That City Council authorize the following planned borrowing:

- Up to \$3,500,000 for Capital Project P.02599 Waste Utility Program Development to fund the purchase of Variable Black Carts; and
- An allowable 10% variance on the borrowing requirements for the project identified. Any variance greater than 10% of the borrowing amount identified would require a new public notice.

*The Cities Act* and The Public Notice Policy Bylaw No.8171 require that City Council give public notice before borrowing money, lending money or guaranteeing the repayment of a loan.

## 2024 WARD BOUNDARY REVIEW: PROPOSED WARD CHANGES

### Plan to share your input at PUBLIC ENGAGEMENT SESSION #2

Early planning for the City of Saskatoon’s municipal/school boards’ elections to be held in fall 2024 is underway. One of the first steps is to have the Municipal Wards Commission review the boundaries of the city’s ten current wards to ensure they all have similar population numbers, according to *The Cities Act*.

Under the existing provisions of *The Cities Act*, **Ward 2** and **Ward 7** are currently outside of the allowable 10% population variance threshold that triggers a ward boundary review. Changing ward boundaries to ensure all ten wards comply with the legislated population range could change the City Councillor you currently have if the ward you live in moves to join another.

Having considered the first round of public engagement, the Municipal Wards Commission is now presenting **Option A & Option B** proposed ward changes for public input.

#### Option A: Proposed Ward Changes

- Confederation Urban Centre currently **Ward 3 - moves to Ward 2**
- Nutana Park currently **Ward 7 - moves to Ward 9**

#### Option B: Proposed Ward Changes

- Hudson Bay Park currently **Ward 1 - moves to Ward 2**
- Downtown currently **Ward 6 - moves to Ward 1**
- Nutana Park currently **Ward 7 - moves to Ward 6**
