4. Rabies Vaccination (File No. CK. 151-17)

The Committee Secretary submitted a copy of an excerpt from minutes of meeting of the Advisory Committee on Animal Control, dated June 27, 2013, regarding rabies vaccination. At that meeting, the Committee resolved that the subcommittee on rabies vaccination report further on the matter in fall 2013. Due to time constraints at the last meeting of the Committee, this item was deferred to this meeting.

At the meeting of the Committee on June 27, 2013, it was suggested that mandatory rabies vaccination be part of the City's pet licensing program.

Dr. Edward Hudson circulated a report entitled Rabies Vaccination Update.

Dr. Hudson gave a brief overview of his submission to the Committee and answered questions from Committee Members.

He also addressed an article in The StarPhoenix that was published on Thursday, November 28, 2013; the day of the meeting.

Dr. Judy Currie, Registrar, College of Veterinary Medicine, was in attendance and requested permission to address the Committee regarding the article. Dr. Currie expressed concern regarding misinformation stated in the article.

Discussion ensued regarding the article as well as the proposal to link mandatory rabies vaccinations with pet licensing.

RESOLVED: 1) that the Director of Media Relations be consulted for advice as to whether a retraction or other suitable vehicle be used to clarify information and rectify misquotes contained in The StarPhoenix Article entitled "Retired Vet Calls for Mandatory Vaccinations" as it appeared in the November 28, 2013 edition; and

2) that the subject of rabies vaccination be reviewed at a future meeting to develop specifics on how to proceed.
