Your Worship, Councilors, and Commissioners:

Initially, you might think that this is a letter of protest but it is not. Please read this letter as one of support and information regarding the issue whether organizations should pay for special police duty officers at their events that served alcohol in Saskatoon parks.

First, some information: On Apr. 29, 2014, The Star Phoenix reported on Monday's meeting of the Executive Committee of Council, "[Police Chief] Weighill noted the affected events are for-profit affairs, rather than charitable events." I want to be clear that the Saskatchewan Jazz Festival is a not-for-profit corporation with charitable status. More particularly, Club Jazz, our event in question, costs the Festival about \$40,000 each year.

Now a bit about Festival attendance: While we proudly say that 85,000 people attend, that is for all events at all fifteen venues. The "beer garden" at Club Jazz is licensed for 650 people. It runs from noon to 10:00 PM for 10 days and only once have we counted 3,000 as the day's attendance. Finally, while I understand that things can get out of hand quickly, I am unaware of a major incident occurring.

Regardless, the Festival is concerned about the safety of those participating and sees value in having the police present. Our difficulty is that in order to be licensed, SLGA mandates the number of security personnel we must employ at a cost of \$27,500 (est.). The police, at an estimated cost of \$8,232, would be in addition to that.

I look forward to a successful resolution to this problem and am willing to discuss it any time.





I wish to pass on to you our sincere thanks and admiration for the work of Constables Kowalenko and Skinnider.

They responded to a call to our residence at approximately 0130 on April 18/14, in relation to our 21 year old son who struggles with depression and at the time was under the influence of alcohol. Although this has unfortunately been a long intermittent struggle for him, this particular night was particularly worrisome in that he was becoming physically aggressive and unpredictable.

Constables Kowalenko and Skinnider were able to very calmly and compassionately deal with the situation, were able to reason with him as best as could be expected with alcohol in the picture, and showed a very profound understanding of his state of mind and the feelings he was having. The situation was managed in a controlled, non-confrontational and non-judgemental manner, and ultimately resolved with my son agreeing to have them escort him to the hospital for evaluation.

Their kindness, patience, compassion, and understanding of the situation were exemplary, and I hope you can share with them my sincere appreciation for truly being consummate professionals in their chosen field. You are fortunate to have such individuals in your service, as am I.

We had been alerted to our son's situation approximately an hour earlier when two other members of the Police Service responded to our house after being dispatched apparently in relation to a phone call from a friend of our son's. Unfortunately I did not get their names, but would appreciate if you have the ability to identify them, please express similar admiration and thanks for their professionalism and caring.

I am writing this letter because I feel that I should acknowledge and make known of the action of one of your constables.

On or around January 19th of this year I was helping to prepare a meal at the second second

I was shredding carrots and was chewing on a piece of carrot when I laughed at a comment. Unfortunately this caused me to aspirate a piece. I found myself unable to breathe; there was absolutely no air movement.

I was being monitored to see if I could clear it myself and it was soon recognized that I could not. Matt heard the commotion and came into the kitchen to check what was going on. He quickly took control of the situation. He directed **Theorem** to call 911 and then started to apply the Heimlich maneuver. It took several attempts to dislodge the piece of carrot. When I was able to get air into my lungs again he directed Emily to tell the 911 operator to cancel the ambulance. I have absolutely no doubt in my mind that if I had been alone I would not have survived this event. And although I was struggling I wasn't really afraid because I felt that Matt was taking all the appropriate actions.

He then underplayed it; but his actions probably saved my life. I thanked him at the time but I feel that I should let the Saskatoon City Police know that they have a great young constable in their employ.

His name came up after I had sent an email out asking for information on a guy named Darren from Meadow Lake. One of the RCMP officers that works in the police station here sent my email to an officer in Meadow Lake and they came up with a name to try. Turns out it was the right guy, kind of a long shot but it worked out."

Needless to say I wanted to make sure that SPS got the credit and Gratitude it deserved.

(IDTIDY YO

ISSUE:

Use of Force statistical reporting will be submitted to the Board of Police Commissioners on a yearly basis. The attached report details Use of Force reporting from January 1, 2013 to December 31, 2013. Included in the 2013 Use of Force numbers at the request of the Provincial Complaints Commission are Police Pursuits. There were 49 Police Pursuits included in the 2013 Use of Force numbers.

<u>RECOMMENDATION</u>:

This report is received as information.

BACKGROUND:

Members of the Saskatoon Police Service are required to complete and submit a Use of Force report each time force is used in the performance of their duties. The Saskatchewan Police Commission has mandated this report.

The Use of Force Review Committee is responsible for the review of Use of Force forms submitted by members of the Saskatoon Police Service. The information from these forms is used to address training issues and to identify emerging trends.

DISCUSSION:

The Use of Force form requires members to indicate actions taken from a list of fifteen different types of force. There may be more than one type of force used during any one incident. It is for this reason the numbers in the type of force used categories are not consistent with the number of occurrences.

In 2013 there were 160 reports submitted. The number of Use of Force reports is up in 2013 compared to 2012. The seven year average of Use of Force reports has been 111

per year. Of note is that in 2013 police pursuits (49) have been added to the report so that reporting procedures are consistent with provincial expectations.

CONCLUSION:

In 2013 there were 160 Use of Force reports submitted compared to 109 in 2012, 77 in 2011, 99 in 2010, 111 in 2009, 111 in 2008, 112 in 2007 and 160 in 2006. The Police Pursuit numbers included in the Use of Force reporting beginning in 2013 needs to be taken into account when comparing year to year numbers.

ISSUE:

Police criminal pursuits create special concerns for police agencies due to the risk to the public and the police. The reasons for these pursuits vary from stolen vehicles, impaired drivers and various other criminal violations. The goal of the Police Pursuit Review Board is to ensure that all police pursuits are done in a safe manner in keeping with the law and Saskatoon Police Service policy and procedure.

<u>RECOMMENDATION</u>:

That this report be received as information.

BACKGROUND:

The Pursuit Review Board consists of four senior members of the Saskatoon Police Service. Three of the members are from the rank of Staff Sergeant and the Board is chaired by the Inspector i/c of the Investigational Services Division. All Board members are assigned to Criminal Investigations and are at arm's length from members of Patrol where a high number of these pursuits originate.

The Board reviews all pursuits in relation to police officers conduct regarding the law and police policy and procedure. It reviews the supervision and communications involved in pursuits and where required makes recommendations. Policy is designed to provide supervisory accountability balancing public safety with effective law enforcement, bearing in mind the pressures on those engaged in carrying out those duties.

EVALUATION AND PERFORMANCE MEASUREMENTS:

In 2013 the Pursuit Review Board reviewed 49 reported incidents. Any Policy violations were minor in nature and handled at the supervisory level with the exception of one which was concluded with discipline by Chief Weighill. Supervisory review includes:

• Policy review by supervisors and members.

- Members being counseled by their Platoon Watch Commander as to future conduct.
- Platoon education by the Watch Commanders as to the standard of care expected and reviews of Policy and Procedure involving pursuits.



ISSUE:

The impact of the Adult Service Bylaw 9011 since its inception in 2012 from the perspective of Saskatoon Police Service:

<u>RECOMMENDATION</u>:

The Adult Service Bylaw has given Saskatoon Police Service (SPS) members a tool to connect to escorts, agencies, workers, and performers to a greater degree. It not only has opened up the doors of communication with these individuals, but has developed a good positive working relationship with most. Our main concern for the performers is that they are doing it voluntarily, that they are not being exploited and that they are of age.

BACKGROUND:

July 2012

The Adult Service Bylaw 9011 came into effect. SPS Vice Unit members began investigating and educating individuals about the new Bylaw.

The Vice Unit conducted investigations into 2 massage parlors that were not licensed under the Adult Service Bylaw 9011. The investigations resulted in 4 Summary Offence Tickets being issued under the Adult Services Bylaw 9011. Both businesses were shut down as a result of the investigations.

2013

In 2013 the Vice Unit continued to educate the public about the bylaw. The Vice Unit also conducted compliance checks for the Adult Services Bylaw 9011 of local Adult Service Agencies, and Agencies that conduct business in Saskatoon which are based out of town.

Two separate investigations were conducted into 2 massage parlors not complying with Adult Service Bylaw 9011. At the first location 3 Summary Offence Tickets were issued under Adult Service Bylaw 9011. At the 2nd location 3 more Adult Service Bylaw 9011 tickets were issued after a search warrant was conducted at this massage parlor. Each location was issued a ticket for Operating an Adult Service Agency without a license and each location had 2 performers operating without a license. Both massage parlors were shut down as a result of the investigations.

The Vice Unit also conducted an investigation into a local Escort Agency. From this investigation officers identified a 17 year old female victim working as a escort. The Escort Agency owner was charged with procuring and living on the avails of prostitution of a person under the age of 18 years of age. This file is still before the courts. Without the Adult Service Bylaw 9011 in place police most likely would not of been able to identify the underage victim.

Note** An Independent Adult Service Agency is defined as a agency in which the owner is also the performer. An Adult Services Agency is a Agency in which the owner also has one or more performers.

Vice Unit utilize the Adult Service Bylaw 9011 as a tool to keep track of escorts in the city and issue necessary tickets. This Bylaw also assist with monitoring the agencies which performers work for, this has enabled SPS to monitor who is coming into the city. Adult Service workers in the adult services industry have expressed they feel more secure coming to Police with issues that arise in their industry. They have expressed that they feel a greater sense of trust dealing with Police.

DISCUSSION:

In consultation with Jo-Anne Richter, CY - Planning and Development, it is noted to date the City have had no applications for adult services venues. Until a few applications for venues have taken place, it is hard to perceive if a task force is needed at this time. The City Administration will continue to monitor this.
