4.1 Report of Access Transit Manager (File CK. 225-70)

Access Transit Manager Howe was in attendance and provided an update to the Committee. Access Transit has seen an increase in registered customers over the last 5 years. 69% of the riders are seniors; both medical needs and rural migration are contributing factors to the increase for the service. Access Transit meets 90% of its service demands and typically has 19 buses on the road at one time. 2016 will mark the last year busses will be fueled with diesel, as the switch to gas will be made.
