#### 1. APPEAL NO. 16-2015

Refusal to Issue Development Permit Proposed Addition to a One-Unit Dwelling (With Rear Yard Setback Deficiency) 725 9<sup>th</sup> Avenue North – R2 Zoning District Jim Siemens on behalf of Chris and Sue Wall

## **Grounds and Issues:**

THE APPELLANT, Jim Siemens, on behalf of Chris and Sue Wall, has filed an appeal under Section 219(1)(b) of *The Planning and Development Act, 2007* in connection with the refusal to issue Development Permit for a proposed addition to a one-unit dwelling with a rear yard setback deficiency, for the property located at 725 9<sup>th</sup> Avenue North.

The property is zoned R2 under Zoning Bylaw 8770.

Section 8.4.2(2) of the Zoning Bylaw states that in a R2 district, all buildings on interior sites are required to have a minimum rear yard setback of 7.5 metres.

Based on the information provided, the rear yard setback is 5.182 metres. This equals a rear yard setback deficiency of 2.318 metres.

The Appellant was seeking the Board's approval for the Development Permit as submitted.
