- Draft handouts on the 2015 Composting programs: Composting Education and Incentives along with Subscription Food Waste Collection Program Options were circulated to the Committee for comment.
- A Waste Diversion Request for Proposal has gone out and the closing date for the proposal is February 17, 2015.
- Water Conservation the outdoor water campaign for residential areas continues. A new 2015 program "Healthy Yards Program" has been created. There are future plans to create a Healthy Yards webpage on the City's website for public access to information.

- The Wetlands Request for Proposal will be awarded by March 12, 2015 and an assessment will be done by August 2015. This will involve a more comprehensive look at wetlands in order to help meet the needs of the Wetlands policy.
- Energy Performance Contracting is currently being considered by the City.
 A Request For Proposal will be released this summer, no contract has been awarded.
