> The Heritage Property Review Board has met regarding the property at 1102 Spadina Crescent East, and is recommending that the home not be designated due to the renovation that has occurred. The Board's decision is non-binding, and the matter will go back to City Council who will decide to grant or not grant the designation.

 Broadway Theatre renovation – funding has been requested; however, because funding has previously been accessed for the rehabilitation of the overhanging sign, they are not eligible to receive additional funding under the current policy.
