## 4. PRESENTATION - NORTHEAST SWALE MASTER PLAN (File No. CK. 4131-5)

Ms. Nola Stein and Mr. Alan Otterbein representing Meewasin Valley Authority (MVA) were in attendance to provide an overview of the Northeast Swale Master Plan for the Committee's information. A copy of the Draft Conceptual Design was distributed to Committee members.

Ms. McGillivray entered the meeting at 11:35 a.m. and Mr. Deprez entered the meeting at 11:39 a.m. during consideration of this matter.

The delegation provided information on the cultural and heritage elements of the northeast swale and noted that it is a significant asset in terms of biodiversity, and rare plant and animal species. The MVA is involved in terms of conserving the site, and doing resource management to maintain the ecosystem as much as possible, given the adjacent development.

The delegation reviewed the history of the 25 km long area, 10 percent of which is within city limits, and noted that the typography and water on the site makes it unsuitable for residential development. The MVA is interested in providing an interpretative opportunity on the site with respect to the natural history that exists, with a focus on passive recreational opportunities; for example, walking/hiking trails and cross country skiing, along with interpretive nodes throughout the area. The site provides a unique opportunity as there has been no real development of the land for thousands of years which provides an interesting example of untouched native prairie.
