 - 6.1 Proposed Official Community Plan Amendment and Rezoning from R2 to MX1 318 and 320 Avenue F South [Files CK. 4351-015-009 and PL. 4350-Z21/14]

Planner McAdam reviewed the submitted report and answered questions of the Commission.

Dr. Kris Stewart addressed the Commission regarding the proposal to use 320 Avenue F South as an office for medical research purposes and the continued use of 318 Avenue F South as a residence.

Discussion followed and the following further information was provided:

- Research will be done on an ongoing basis for internal medicine and will be prepared and documented with by computers and paper files;
- Six parking spaces have been allocated for the property to be used by employees and patients;
- Parking requirements is based on the floor area of the building; and
- Property ownership is not a non-profit organization, only the sublet is non-profit.

1. That the proposed amendment to Official Community Plan Bylaw No. 8769 - Riversdale Land Use Policy Map to redesignate 318 and 320

- Avenue F South from "Low-Density Residential" to "Mixed-Use", as outlined in the report of the General Manager, Community Services Department dated May 26, 2015, be approved; and
- That the proposed amendment to Zoning Bylaw No. 8770 to rezone 318 and 320 Avenue F South from "R2 - One and Two-Unit Residential District" to "MX1 - Mixed-Use District 1", as outlined in the report of the General Manager, Community Services Department dated May 26, 2015, be approved.

6.2 Proposed Rezoning - Brighton Neighbourhood - Phases 1, 2 and 3 [Files CK. 4351-015-008, PL. 4350-Z10/15, PL. 4350-Z11/15 and PL. 4350-Z12/15]

Planner McAdam reviewed the submitted report and answered questions of the Commission.

Representatives of Saskatoon Land were also presented to answer questions of the Commission.

Discussion followed and the following further information was provided:

- Retail stores are permitted subject to floor area size;
- RMTN is a townhouse residential zoning district;
- Roadways will be 16 metres to 18 metres in width; and
- Area was designed with the intended land uses and functions when the concept plan was approved.

6.3 Proposed Rosewood Neighbourhood Concept Plan and Proposed Rezoning - Village Square [Files CK. 4351-015-010 x 4110-40 and PL. 4350-Z29/13]

Planner McAdam reviewed the submitted report and along with Development Review Manager Dawson answered questions of the Commission.

Representatives from Saskatoon Land were also present to answer questions of the Commission.

Discussion followed and the following further information was provided:

- Two streets removed from the original Rosewood Neighbourhood Concept Plan were intended as lanes providing access;
- Proposal extends the lane straight through the area;
- Final design of the property is the decision of the builder or developer;
- The Municipal Reserve will be designed as the community focal point;
- Area is intended to be more pedestrian friendly;
- Roadways changed from 20 metres to 12 metres in width to make a shorter crossing distance for pedestrians; and
- Developer could include pedestrian access in place of the lanes that were removed from the original Rosewood Neighbourhood Concept Plan.

- 1. That the proposed Rosewood Neighbourhood Concept Plan amendment be approved; and

6.4 Mayfair and Kelsey-Woodlawn Local Area Plan [Files CK. 4000-16 and PL. 4110-73]

Senior Planner Andre reviewed the submitted report and along with Planning and Development Director Wallace answered questions of the Commission.

Ms. Weber entered the meeting at 12:36 p.m.

Councillor Olauson excused himself from the meeting at 12:48 p.m.

Discussion followed and the Commission were informed that the yield signs were part of the traffic management process from 2014 and were installed to help slow down traffic in the area. Concerns were raised regarding safety in the neighbourhoods, paving side streets, sidewalk installation and the operation of the industrial area.
