## 6.1 Proposed Rezoning from MX1(H) to MX1 – 401 and 475 Avenue L South – West Industrial [Files CK. 4351-015-007 and PL. 4350-Z22/13]

Councillor Olauson arrived at 11:52 a.m. during discussion of this matter.

Planner McAdam reviewed the submitted report and along with Development Review Manager Dawson answered questions of the Commission.

Mr. Shane Olson, Shercom Industries, was also present to answer questions of the Commission. Mr. Olson supplied handouts to the Commission, they have been added to the file.

Discussion followed regarding the proposed amendment and rezoning and the following further information was provided:

- Shercom Industries completed a remediation process on the property up to Ministry of Environment Saskatchewan residential standards;
- The remediation process started with an environmental phase 1 which identifies contaminates in the soil;
- Ministry of Environment Saskatchewan would not approve the application until certain the remediation process was complete;
- The residential standards for the remediation process contains every range of chemicals;
- The property owner is liable for any contaminants on sight;
- The contaminants on site and inspections are dealt with through the Ministry of Environment Saskatchewan;
- The rezoning and amendment is based on the consultation process and community driven neighbourhood plan for the area;

- The neighbourhood plan for the area does include a mixed use area;
- Utilities for the property will be determined through the development permit process; and
- The MX1 zoning district contains many discretionary uses, offices and office uses are permitted uses in the zoning district.

Concerns were raised regarding the liability the City of Saskatoon would have on the property if approved for the rezoning. Mr. Olson informed the Commission that the Planning and Development Department would not move forward on the application until they received an approval letter from Ministry of Environment – Saskatchewan.
