# 6.1 Community Support Program Supervisor's Report [File No. CK. 5605-3]

The Committee Assistant submitted a report from the Supervisor, Community Support Program and noted that Community Support Program (CSP) staff attended a total of 263 calls and assisted a total of 396 individuals in May and June.

Community Support Program Supervisor Prefontaine reviewed her report for the reporting period May - June 2015 and the following was noted:

- There were 848 connections made, which is an all-time high.
- Increase in number of calls involving bylaw enforcement.
- Participated on the advisory committee and provided three
  presentations to volunteers for the Point-in-Time homelessness count
  which was done on June 22, 2015 to track the level of homelessness
  in Saskatoon.
