7.2.1 Bicycle Program Update - Feasibility of Protected Bike Lanes [Files CK. 6000-5 and PL. 6330-4]

Pursuant to an earlier resolution, communications from Brent Penner, The Partnership and Everett J. Kearley, Waldegrave Properties Limited, were considered with this item as well as a request to speak from Saskatoon Cycles.

Long Range Planning Manager Cook reviewed the report and together with Director of Transportation Gardiner answered questions of the Committee.

Ms. Cathy Watts, Saskatoon Cycles, spoke in support of the protective bike lanes downtown and asked that the 4th Avenue project not be delayed until 2016.

Discussion followed regarding the maintenance plan for the bike lanes during the winter months and whether any studies are available from other cities that experience a similar winter season. As well the Committee discussed the collection of cycling data and

> the desire for not only downtown bike lanes but the need for suburban connectivity as well.

The Committee requested that the Administration provide a cost breakdown for what portion of the estimated \$225,000 is for the proposed 23rd Street project, and what portion is for the proposed 4th Avenue project when the report is before City Council.
