

Saskatoon Municipal Review Commission Elections Committee Recommendations - Request to Amend Legislation

Recommendation

That the information be received.

Topic and Purpose

In accordance with City Council's instructions of January 25, 2016, the City Solicitor communicated with the Province requesting various amendments to The Local Government Election Act and The Cities Act. A response was received from the Province. This report provides a summary of the Province's response to the Governance and Priorities Committee for its consideration.

Report

At its Regular Business Meeting on January 25, 2016, City Council considered a report of the Saskatoon Municipal Review Commission Elections Committee and made the following resolutions:

- 1. "That the matter of allowing for the opening and exclusive use of campaign bank accounts be forwarded to the Province to request an amendment to legislation for authority to adopt a bylaw accordingly.";
- 2. "That the matter of requiring a candidate or their agent to open a bank account prior to filing of nomination papers, and such information being provided as part of the official filing of nomination papers, be forwarded to the Province to request an amendment to The Local Government Election Act to empower City Council to adopt a bylaw accordingly.";
- 3. "That City Council request the Province to amend *The Cities Act* to apply the penalties for breaches of Bylaw No. 8491 to defeated candidates as well as elected candidates and that upon the passage of this amendment by the Province, Bylaw No. 8491 be amended to incorporate this language as well."; and
- 4. "That City Council request that the Province amend *The Local*" Government Election Act to empower Council to adopt a bylaw to establish limits on contributions to candidates for municipal office."

In accordance with City Council's instructions, the City Solicitor wrote to the Minister of Government Relations requesting the relevant legislative changes.

The correspondence seemed to be well-received. The Minister responded to the City Solicitor indicating that the suggested amendments have been noted and requested that they be brought to the Ministry's attention again after the 2016 municipal election when *The Local Government Election Act, 2015* is reopened for consideration.

Further, the Minister suggested that the City may wish to consult other cities and the Saskatchewan Urban Municipalities Association ("SUMA") to see whether there is any support for these proposed amendments. As a matter of course, the Administration consults on various proposed legislative changes with SUMA and other cities. It is the intention of the Administration to consult with SUMA and the other cities about these proposed legislative changes as well as the proposed change to *The Cities Act* to make remuneration for members of City Council fully taxable as instructed by City Council on June 27, 2016.
