# 7.2 Pet Licensing - Market Research Project (File CK. 151-17)

Open Space Consultant Ariss reviewed the submitted Executive Summary from Insightrix Research Inc. regarding pet licensing highlighting the following: Pet Ownership Profile; Barriers & Motivators to Licensing; Licensing Understanding; and Takeaways. The following information was also provided: in 2015 approximately 16,000 dog licenses were issued and approximately 6,000 cats in Saskatoon are licensed.

Implementation of the information obtained is the next step in this process. Animal Services will apply the information provided in this report to its

Operation Strategy, Marketing Strategy, update the City's website and make minor changes to marketing items.

Clarification on the project overrun was provided. Animal Services undertook the project knowing the cost for the project was \$24,000 this was discussed with the Committee in November 2015. There is no overrun for the project, this was misstated at the last meeting. The research scope did not change, the cost presented is the cost for obtaining qualified research. Animal Services proposes it pay \$3,000 of the remaining \$12,000 owing Insightrix and ACAC pay \$9,000 from its 2016 budget.

Discussion ensued revolving around the various initiatives the Committee has pursued in the past and the option for doing so again in 2016 and possibly pursuing different initiatives in 2017. Also discussed was the option to change the name of the Pet Wellness Brochure to a name that conveys more appropriately the information provided in the circulation; the content of the brochure; using a different media tool for distribution; along with reallocating the 2016 Budget line items.

# Moved By: E. Hudson

- 1. That an additional \$1,600 be allocated to the *Pet Wellness Brochure* from *Research* for a total cost of \$6,000,
- 2. That \$5,800 from the *Pet Reward Program* and \$3,200 from *Other Initiatives* line items be re-allocated toward the cost of Insightrix's market research project for a total of \$9,000 and that Animal Services pay \$3,000 toward the cost of Insightrix's research; and
- 3. That \$5,400 from *Educational Brochures* and the remaining \$900 from *Research* for a combined total of \$6,300 be divided equally in the amount of \$3,150 toward *Dog Bite Awareness Campaign* and a *One-page Informational Brochure*.
