#### **Grounds and Issues:**

THE APPELLANT, Russell Munker has filed an appeal under Section 219(1)(b) of *The Planning and Development Act, 2007* in connection with the City's refusal to issue a Development Permit for a proposed attached deck to a one-unit dwelling at 511 Kloppenburg Crescent.

The property is zoned R1B under Zoning Bylaw No. 8770.

Section 5.8(4)(b) states that a raised patio or deck measuring more than 0.6 metres in height above grade can project no more than 25% of the width of the required side yard – 0.75 metres. The attached deck can therefore project no more than 0.188 metres into the required side yard.

The site plan submitted shows the proposed deck projecting 0.445 metres into the required side yard which is 0.257 metres more than allowed under *The Zoning Bylaw*.

The Appellant is seeking the Board's approval to construct an attached deck to a one-unit dwelling with the deck projecting farther into the side yard than allowed.
