#### 1. APPEAL NO. 8-2016

Refusal to Issue Development Permit
New Residential Care Home Type II
Exceeding Maximum Allowable Site Coverage)
1134 Evergreen Boulevard – R1A Zoning District
Brett Johnson, Final Draft Co. Ltd., on behalf of Entech Plus Ltd.

## **Grounds and Issues:**

THE APPELLANT, Brett Johnson, Final Draft Co. Ltd., has filed an appeal on behalf of Entech Plus Ltd. under Section 219(1)(b) of *The Planning and Development Act, 2007* in connection with the City's refusal to issue a Development Permit for a New Residential Care Home Type II at 1134 Evergreen Boulevard.

The property is zoned R1A under Zoning Bylaw No. 8770.

Section 8.2.3(3) states that the maximum site coverage provided for a residential care home type II can be more than 40%. The area of the property as per the registered plan is 649.71m2. Proposed is a site coverage of approximately of 294.564m2, or 45.338%. This results in approximately 5.338%, or 34.68m2, over the maximum site coverage.

The Appellant is seeking the Board's approval for the Development Permit as submitted.
