Grounds and Issues:

THE APPELLANT, Persephone Theatre has filed an appeal under Section 219(1)(b) of *The Planning and Development Act, 2007* in connection with the refusal to issue a Sign Permit for a wall sign – sign group 5 at 100 Spadina Crescent East.

The property is zoned DCD1(AC) under Zoning Bylaw 8770.

Section 2.1.12 of the Zoning Bylaw states that no internally lit signs, other than for internally lit awnings, will be permitted.

Based on the information provided the proposed sign includes white lettering that is internally lit. Only awnings are permitted to be internally lit in a DCD1 zone.

The Appellant is seeking the Board's approval for the Sign Permit as submitted.
