1.5.1 Conflict of Interest - Funding for Police Services in Province

Mr. Neil Robertson, Chair of the Saskatchewan Police Commission was in attendance.

Mr. Robertson addressed the matter of a policy to address conflict of interest in the mechanism of funding for police services in the province and the request from the Saskatchewan Police Commission for input into the draft policy. He spoke to the removal of a paragraph from the policy allowing foundations to be established to raise money from individuals for police and the rationale behind removal.

Mr. Robertson noted the Commission is consulting with all Boards in the province with respect to the draft policy and is interested in

input from the Saskatoon Board of Police Commissioners. It is expected a final report will be available in April.

Discussion followed regarding the establishment of a police foundation, the perception by the public, and the ability for applications for exemptions from the policy.

The Board expressed its interest in reviewing the "foundation" clause which was subsequently removed from the draft policy.
