General Manager, Community Services Department Grauer introduced the item.

Planner Grenwich provided a PowerPoint presentation outlining the current policies compared to other municipalities and proposed approach for City Centre office development.

Director of Planning and Development Wallace answered questions regarding consultation with stakeholders, and incentive programs.

Mr. Konrad Andre, North Prairie Developments Ltd, provided a PowerPoint presentation addressing the negative effects as a result of the proposed policy including the impact on economic competitiveness. He provided suggested solutions to parking, creating partnerships, zoning and increased regulatory speed and flexibility, and consideration of lowering redevelopment levies downtown. He provided a copy of his presentation.

Mr. Josh Walchuk, ICR Commercial Real Estate expressed concern with the negative impact this policy direction will have on the suburban offices. The Committee requested the speaker provide a copy of his comments.

Mr. David Gauthier, SREDA, addressed the Committee encouraging the use of incentives and suggested enhancing current policies to meet the changing business dynamics.

Mr. Paul Ledoux, Muskeg Lake Cree Nation, provided a brief history regarding urban reserves. He expressed concerns regarding the negative impacts and requested further review of the policy with consideration for urban reserves.

Mr. Mike Icton, Muskeg Lake Cree Nation, expressed concerns with future developments in relation to the square footage being proposed.

Discussion followed and Director of Planning and Development Wallace and Planner Grenwich addressed questions of the Committee.
