Attached is a current Statement of Expenditures.

The Committee Assistant at the October 26, 2017 meeting undertook to obtain information regarding costs and process for utility bill inserts.

Also attached is a copy of the City's inserts information and procedures. A freelance graphic designer or advertising agency will need to be hired to design the utility bill stuffer per specifications.

- 80,000 copies are required for stuffing with the City's utility bill statements (estimated printing cost for budgeting purposes is \$1,700 + tax).
- The City's mailroom must receive 200 samples 30 days prior to distribution for testing.
- You must schedule your Utility Bill Insert there is a maximum of two
 inserts per month; lead time varies, however, it is best to check availability
 and then book at least one month in advance.

Should the Committee wish to proceed, Community Services - Communications will need to be contacted for further assistance with this project.

Verbal Update - P. Cameron, Executive Director, Saskatoon SPCA

Attached for the Committee's information is the October statistics.

At the October 26, 2017 meeting the Committee requested information regarding adoption and euthanasia. The following has been provided:

- Once an animal is deemed adoptable (health and behavior), there is no time or space limit on their continued care. The SPCA cares for an adoptable animal until it finds a home.
- Euthanasia decisions are based on untreatable or unaffordable medical issues (e.g. the SPCA will not spend \$10,000 on one animal when it has over 4,000 needing care), or because the animal is deemed unsafe in the home/community.
- The Canadian Federation of Humane Societies does an annual survey of shelters and found the national average for euthanasia to be 22% - down significantly from rates a decade ago.
- In late 2014, the SPCA's euthanasia rate was 37%. It is now below 15%,

- one of the lowest in the country.
- Should cat overpopulation numbers continue to climb, this rate may go up.
 The Saskatoon SPCA is committed to operating in keeping within its
 capacity for quality care and also running in a financially sustainable
 manner.



Where dog bites happen



The facts (Saskatoon Health Region)

- 1. 60% increase in reported dog bites in the last five years in our health region.
- 2. All breeds of dogs can bite.
- 3. The majority of reported bites occur to adults.
- 4. On average there are 300 dog bites reported per year in our health region and that number is increasing. It's important for people to report dog bites for the safety and well being of the person bitten and the dog involved.
- 5. Without vaccination, rabies is fatal.

Everyone can prevent bites from happening – including you!

What to do if bitten

- □ Get owner's name and phone number
- □ Call Animal Control 306-385-7387
- □ Call Public Health 306-655-4612
- □ Contact doctor and discuss:
 - Rabies
 - Tetanus immunization
 - Possible infection

If your dog has bitten, take steps to avoid further bites.

Common tips for dog ownership

- Research which breed fits best with your lifestyle.
- Socialize and exercise your dog regularly.
- License your dog.
- Attend positive reinforcement training classes





Tips for bite prevention

- Maintain control of your dog and always use a leash in public.
- Ask if people are comfortable around dogs. Don't assume.
- Act as a barrier on a path or sidewalk by walking between your dog and other people.
- Avoid putting your dog in uncomfortable situations where they may bite.
- Always ask the owner before approaching a dog.
- Avoid approaching a dog with no owner present.
- Never put your hand in the way of a dog's food.

- Supervise children around dogs.
- Do not tease dogs (i.e. pulling tails, ears, fur, etc).

Recognize the warning signs of a dog that is about to bite

When most dogs bite they do so out of fear, so it is important to recognize when a dog looks fearful. For most dogs that will look like:

- Wide eyes
- Ears lowered
- Tail tucked
- Avoiding eye contact




It's important to Spay or Neuter your cat

- Reduces unwanted litters and cat overpopulation
- Reduces the incidence of disease and infection
- Eliminates female heat cycles and reduces male spraying
- Helps make cats more sociable and affectionate



An unaltered female cat can produce THREE LITTERS PER YEAR with average litter sizes ranging from FOUR TO SIX KITTENS



A single unspayed female cat and her offspring can produce

more than 400,000 cats in their lifetime

Owning a cat in Saskatoon

Cats make great pets to have around the home. Every cat has a unique personality and quickly become a part of your family. While cats are typically known for being relatively low maintenance, there are a lot of things to consider to ensure they are at their happiest and healthiest.

Licensing your cat

- In Saskatoon, all cats 4 months and older require a valid pet license
- If your cat ever escapes, a valid pet license provides identification, safe shelter and direct return home
- Cat licenses are valid for one year and must be renewed annually

 Pet license fees help to provide food, shelter and vet care for thousands of lost cats in Saskatoon each year

Essentials of cat ownership

Getting started

 Spay or neuter, food and water dishes, collar and leash brush, litter box, scratching post, cat carrier, toys, etc

Ongoing

 Annual licensing fees, cat food and treats, vet check-ups, grooming, litter, medication and vacation pet-sitting.

If you are looking for ways to save, consider adopting from your local shelter, so that shots, spaying or neutering and microchip services are included in the adoption cost.

Outdoor play

Despite popular belief, cats don't need to go outdoors by themselves. If you want your cat to take in the fresh air and experience the stimulation of the outdoors, consider teaching him/her to walk with a harness and leash or invest in a Catio (cat patio). There are many ways to ensure your cat can safely enjoy the outdoors.

Inserts Information & Procedures

Specifications and Packing Requirements

Quantity: 80,000

• Finished size: 3.5" x 8.5" (no fold)

Paper finish: Uncoated

Paper weight: A recommended insert solution is 80 LB Husky Offset

- Note: Must be packed flat in box (not on end) and must have vertical dividers, with each box weighing no more than 35 pounds
- Note: No bundling, horizontal dividers, elastic banding, shrink wrapped bundles, count markers of any kind
- Note: Please advise the printer that the inserts must have a "gassing off period" of a minimum of 3 to 4 days
- **Note:** It is possible for the folder inserter to handle other styles of inserts (folded brochure, postcard) ... testing of material & format is required prior to printing.

Prior to Printing

- Communications Branch to receive <u>200 paper samples</u> at approximately <u>30 days prior to distribution</u>.
 - These samples will be tested to confirm compatibility with mailing equipment.
 - If the same Insert is printed annually, the paper samples must still be tested for each mail out.
 - The Communications Division must approve all copy/design of proposed Inserts prior to printing – work with the Communication Consultant/Marketing Coordinator responsible for your portfolio.

- Request scheduling of Utility Bill Insert as soon as you know when you'd like it delivered - contact Printing & Mail Services @ 306-975-2699 to your insert request scheduled. There is a maximum of two inserts per month.

- Deliver Utility Bill Insert maximum 4 business days prior to the first of the month for your insert to Mail Room, City Hall.

NOTES:

- 45% of animals admitted (the majority being adult cats) were brought in by SACA.
- Admissions of Cats 6 months and older in Oct. 2017 were 26% higher than Oct. 2015 and 46% higher than Oct. 2016, pointing to a problem with cat overpopulation, homelessness, or failure of owners to comply with Bylaws and responsible pet ownership practices.
