The Deputy City Clerk reported that at its meeting held on September 8, 2017, the Public Art Advisory Committee finalized its annual report on its activities from 2015 and 2016 for submission to the Standing Policy Committee on Planning, Development and Community Services to forward to City Council for information.

Mr. Jeremy Morgan, Chair, Public Art Advisory Committee presented the annual report to the Committee and asked for guidance with respect to the Truth and Reconciliation Commission of Canada Calls to Action Report and how it applies to Public Art Advisory Committee. He advised that there is no indigenous representation on the Committee. He asked that this be looked at, with a view perhaps to increasing membership from 7 to 9 members to include the indigenous representation.

Dear City Clerk, Secretary of the Governance and Priorities Committee:

#### Re: Composition of the Public Art Advisory Committee

I am writing to follow up on my presentation on behalf of the Public Art Advisory Committee to the City Council Standing Policy Committee on Planning, Development and Community Services and on my telephone conversation on November 3 with the Mayor respecting the composition of the Public Art Advisory Committee.

To recap the comments to the Committee on the matter, the PAAC consists of seven individuals but has no Indigenous members, a situation which in the eyes of some might undermine public perception of the City's commitment to Truth and Reconciliation. While acknowledging that membership on the PAAC is based on a self-nomination process, it is problematic that the civic program dedicated to the creation of meaningful public space for all citizens has no ongoing Indigenous input. It might be that no Indigenous persons submitted their names or that none who did were considered suitable for appointment by Council. This is not information we are privy to. We do know that there are any number of Indigenous Saskatoon citizens qualified for membership on the PAAC and would be pleased to work with Council to see if that might happen, and sooner rather than later.

The shortcomings of this situation need no further elaboration on our part so let us stress the benefit of acting on it. The inclusion of two or more Indigenous members on the Committee will be a clear affirmation of Council's commitment to TRC and will give added legitimacy to the public art program. It will also give a broader and deeper perspective to Committee deliberations and recommendations to City Council, leading to a greater richness and sense of community for all our citizens in all our public spaces.

Let me reiterate our willingness to work with the City on this next step in our public art program and thank you once again on behalf of the entire Committee for your interest and support.
