She presented verbally a funding request of \$15,000 overall for dog bite pamphlets (includes previously approved expenses) and circulated the breakdown for discussion later in the meeting.

8.2 Court Report - Animal Control Bylaw Prosecutions [CK. 435-17]

Solicitor Manastyrski presented the September 2017 Court Report, noting once again a decline in fines from this time last year - could be attributed to better education and awareness of the Bylaw and/or more people choosing to pay rather than go to court.

Councillor Jeffries entered the meeting at 11:45 a.m.

The Committee requested an update on the report that was recently before the Standing Policy Committee on Planning, Development and Community Services regarding the proposed amendments to Bylaw Nos. 7860 and 8176. Solicitor Manastyrski advised that the Committee was supportive of the amendments and that the matter will soon be considered by City Council, along with an additional proposed amendment to the *Animal Control Bylaw* prohibiting domestic animals from the Ecological Core of the Northeast Swale being considered at the next Standing Policy Committee meeting on October 30, 2017.

9. ANIMAL IMPOUNDING SERVICES - STATISTICS [CK. 435-6]

The Committee Assistant submitted the September statistics. Ms. Cameron was not present at the meeting; however discussion occurred regarding final disposition of impounded animals. The Committee asked that information regarding adoption and euthanasia be included with November's verbal update.

10. STATEMENT OF EXPENDITURES [CK. 1704-5]

The Committee Assistant submitted the current Statement of Expenditures for continued discussion of 2017's budget allocation.

Open Space Consultant Schafer discussed the Administration's previous budget requests, \$5,500 of which was approved in June for costs related to Pets in the Park, and presented the new asks to fund the Cat Coalition and Dog Bite campaigns:

- \$3,500 content marketing
- \$2,500 billboards
- \$1,000 brochure printing
- \$1.000 brochure distribution
- \$ 300 social media

Discussion followed regarding:

- definition of content marketing and target demographics
- brochure distribution Canada Post vs. Cosmo; city-wide drop vs. core neighbourhoods; value for money; greater focus on social media vs. hard copy
- status of cat brochure currently being drafted
- opportunity to include brochures as utility bill insert

The Open Space Consultant committed to providing to the Committee Assistant for inclusion in the next agenda, a copy of the cat brochure and a detailed breakdown of the budget requests presented verbally and noted above. The Committee Assistant reported she would endeavor to also include current information on the costs and process for utility bill inserts.
