6.1 21st Streetscape Project - Presentation by H. Lau, Urban Design

A letter requesting to speak from Henry van Seters, dated January 30, 2017 and a letter in support from Brent Penner, dated January 26, 2017 were provided.

Senior Planner Lau provided an update regarding the City Centre Plan related to the streetscaping improvements. The median green space located on Spadina Crescent and Fourth Avenue for pedestrians has been abandoned and will be changed to have this area as a focal point. The location in front of the Delta Bessborough currently has one vacant space that would suit a main attraction.

Mr. Henry van Seters addressed the Committee regarding the need of a significant piece of art in the downtown area to celebrate local and Saskatchewan artists.

Mr. Brent Penner addressed the Committee in support of obtaining a significant piece of art for a downtown location tied to a local or Saskatchewan artist.
