The Administration provided a powerpoint presentation and video depicting a landscape project to mitigate jaywalking across Clarence Avenue.

Ms. Cate Soffer, Aden Bowman School Community Council, stated that building a wall to address the issue of jaywalking is not a viable option, and noted that speed is still an issue as drivers don't obey the school zone speed limit. She suggested solutions including installing a permanent crosswalk, installation of radar speed signs, and increased speed enforcement.

Mr. Alex Hanson, Colliers International, stated a fence is not the best solution and noted that speed control should be looked at more closely.
