Mr. Malik Umar Draz spoke in support of installation of safety shields in cabs to protect drivers and customers, and also advised of concerns regarding insurance coverage.

Mr. Carlo Triolo, United Group, advised that individual registered owners may install safety shields if they choose, and noted that the cost of additional insurance would be the responsibility of the owner.

Mr. Kelly Frie, General Manager, Comfort Cab, stated that safety shields should not be mandatory and noted that proper training has to be done with drivers so that possible situations can be resolved accordingly.
