6. REPORTS FROM ADMINISTRATION

6.1 Naming Advisory Committee Report - Second Quarter 2017 (File No. CK. 6310-1)

As per earlier resolution, Item 6.1 was brought forward for consideration.

Administrator McLaren presented the report, noting applicants were present to speak to the submissions being considered by the Committee.

<u>Barnsley</u> - Miss Laura Stasiuk, alongside her father, provided a presentation in support of her general request to have her grandfather's name added to the Names Master List. She circulated photos and spoke to his life, career, and many contributions to Saskatoon.

<u>Victoria Park to 'Reconciliation Park'</u> - Ms. Shirley Isbister, President of Central Urban Metis Federation Inc. spoke to her renaming request, asking the Committee to consider even a portion be renamed.

<u>Traffic Bridge to 'Truth and Reconciliation Bridge'</u> - Ms. Ruth Elliott, Teacher-Librarian, Lawson Heights and Sutherland School and her associate Ms. Erika Bakker, Librarian from Saskatoon Misbah school spoke to the Committee about the renaming request. They introduced some of their students who also provided presentations in favour of the renaming.

The applicants were excused and the Committee moved *In Camera* at 11:17 a.m. to discuss matters exempt under Section 16(1)(b) of *The Local Authority Freedom of Information and Protection of Privacy Act.*

The Committee reconvened publicly at 11:46 a.m.

The Committee Assistant recapped the important affecting factors the Committee agreed must be considered and further researched before a decision could be made regarding renaming of Victoria Park and/or the Traffic Bridge:

- Naming of the North Commuter Parkway Bridge and consultation with that working group;
- Process for naming of a portion of the existing park need geographic determination of boundary - or the plaza/amenities within;
- Community and stakeholder consultation;
- Legal implications:
- Timing and installation of Commemorative Artwork "Where Our Paths Cross".
