Report of the City Solicitor, May 11, 1995:

"In accordance with the instruction of City Council at its meeting held on May 8, 1995, when dealing with Addendum to Report No. 10-1995 of the City Commissioner, I have prepared and forward herewith for consideration form of debenture amending Bylaw No. 7484 to provide for the issue and sale herein.

Proposed Bylaw No. 7484 specifically provides for the issue and sale of debentures in the principal amount of \$20,000,000.00 to pay a portion of the cost of constructing a secondary sewage treatment facility at the H. McIvor Weir Pollution Control Plant, as authorized by underlying Bylaw No. 7396. The debentures proposed to be issued are fully registered, serial type, ten-year term, with semi-annual interest varying with the maturity date of the debentures. The debentures are to be dated June 15, 1995, maturing in the years 1996 to 2005, inclusive.

Our application with respect to this issue and sale, together with proposed amending Bylaw No. 7484, have been placed before the Saskatchewan Municipal Board, and in a telephone attendance with the Board on May 10, 1995, I was advised that the Board had completed its consideration of this matter and approved the passage of proposed Bylaw No. 7484 under Section 216 of *The Urban Municipality Act, 1984*. Formal documentation will follow in due course. Further formal approvals will be required from the Saskatchewan Municipal Board following passage of the Bylaw, and I shall attend to obtaining all such approvals.

Proposed Bylaw No. 7484 has also been placed before Messrs. MacPherson Leslie & Tyerman, Barristers and Solicitors, being the reviewing solicitors appointed by our fiscal agents, and has similarly received their approval.
