Attached is a copy of a report of the Planning and Building Department dated March 20, 1996, regarding a proposal to amend the text of Zoning Bylaw No. 6772 and Building Bylaw No. 7306 to include a set of land use and building regulations regarding the erection, placement and usage of signs in Saskatoon. Council will note that this proposal deals with signs on private property and does not include signage in rights-of-way, roadways, medians, buffer strips, boulevards or ditches. Furthermore, it is being proposed that License Bylaw No. 6066 be amended to include provisions to allow for the collection of annual licensing fees for portable signs.

Your Commission has considered this matter in detail and has also heard presentations from the Saskatoon Portable Sign Association, Mediacom Outdoor Advertising, Claude Neon and the Saskatchewan Permanent Sign Association. During the discussion of this matter, additional issues arose and your Commission subsequently requested the Administration to take the following into consideration during the drafting of the Bylaws:

- · information signs for schools and churches;
- · electrical and construction standards for portable signs;
- · additional separation distances between different types of billboards;
- potential increase in time limit for use of portable information signs by community associations and non-profit organizations in residential areas.

It is noted that the above issues described in detail under Clause B4, Report No. 12-1996 of the City Commissioner, should be considered together with this report.

#### **REPORT NO. 12-1996 OF THE CITY COMMISSIONER**

B4) Report of the Municipal Planning Commission - Proposed Amendments to the Zoning Bylaw, Building Bylaw and License Bylaw to Adopt New Sign Regulations (File No. 4350-13)

#### **RECOMMENDATION:**

that City Council request the City Solicitor to include additional signage provisions in the drafting of the Bylaws to adopt new sign regulations in the Zoning and Building Bylaws which will address the following issues:

- a) information signage for schools and churches;
- b) electrical and building construction standards for portable signs;
- c) additional separation distances between different types of billboards; and,
- d) potential increase in time limit for the use of portable information signs by community associations and non-profit organizations in residential areas.

Report of the General Manager, Planning and Building Department May 23, 1996:

"On May 7 and 21, 1996, the Municipal Planning Commission considered a report from the Planning and Building Department which recommended to City Council that amendments be made to the Zoning Bylaw to adopt new sign regulations for Saskatoon.

During the meetings, the Commission heard presentations from the Saskatoon Portable Sign Association, Mediacom Outdoor Advertising, Claude Neon and the Saskatchewan Permanent Sign Association. As a result of those presentations and the Commission's deliberations on this matter, several issues arose which required addressing in the new Bylaw. Each issue is described below:

a) Information Signage for Schools and Churches:

The Public School Board made a request that the Administration consider allowing schools and churches to have permanent information signs with changeable lettering. The Public School Board was hoping for signage which would be freestanding structures and larger in height and area than the proposed limits in the new sign regulations. Specifically, these signs would be used to inform students and the public of upcoming events and activities associated with schools and churches. These signs would not be used for commercial advertising purposes. Presently, some schools and churches are renting portable signs for informational purposes. By permitting a permanent structure on site, the school or church management would have the choice of renting a portable structure or installing a permanent information sign.

The Planning and Building Department is supportive of permitting permanent information signs for schools and churches subject to certain height, size, illumination and use restrictions. It is the intent of the department to contact representatives of the permanent

sign association and Public School Board to discuss what appropriate standards should be adopted.

b) Electrical and Construction Standards for Portable Signs:

The Saskatchewan Permanent Sign Association representative expressed concerns that many businesses were now using portable signs on a permanent basis. Many of these signs were never designed or constructed for permanent use. Permanent signs are required to meet minimum electrical and construction standards, however, portable signs are currently not required to meet the same standards. As a result, many portable signs are electrified with extension cords which run across parking lots, or are erected on roofs of buildings without being properly affixed. At present, these situations represent safety hazards.

The Planning and Building Department is in agreement with the Saskatchewan Permanent Sign Association in that portable signs should not be used on a long-term or permanent basis. If portable signs become permanent fixtures, they should be subject to the same electrical and/or construction standards as permanent signs. The Planning and Building Department will contact the affected agencies in this regard and prepare specific standards for the construction and use of portable signs. The specific standards will likely become part of the Building Bylaw amendments.

c) Additional Separation Distances between Different Types of Billboards:

According to the representative from Mediacom Inc., the outdoor advertising industry is a very competitive industry made up of two major players - Mediacom and Hook Outdoor Advertising. As a result of competition, the two companies have increased the variety and types of billboards for their clients. Most billboards in Saskatoon are of a 10'x20' single face variety. However, many more variants exist such as stacked billboards, double, triple and quadruple panel billboards, 14' x 48' superboards, etc. Because such a product mix exists in the industry, Mediacom has requested that other separation standards be considered for the different types of billboards.

The new sign regulations are proposing a new separation distance between all billboards of 90 metres (300 feet). Although Saskatoon is somewhat unique in that billboards are restricted to fewer locations than in other cities, there is merit in investigating what other types of billboards could be used in Saskatoon and what separation distances between these structures should be imposed. Accordingly, both Mediacom and Hook company representatives will be invited to submit recommendations.

d) Potential Increase in Time Limit for the Use of Portable Information Signs by Community Associations and Non-Profit Organizations in Residential Areas:

At the present time, many Community Associations are using portable signs to inform neighbourhood residents of events and activities. These signs are located in residential zones and are usually placed in parks or on vacant lots. The new sign regulations propose

to accommodate portable, temporary, information signs in residential areas but to restrict the usage of the signs to fourteen (14) consecutive days. The sign would then be required to be removed for an equivalent fourteen day (14) period before it could be used again.

Members of the Municipal Planning Commission wondered whether fourteen (14) days was sufficient time for an information sign. It was cited that most events require more than fourteen days notice. It was agreed that the Planning and Building Department would review the fourteen (14) day restriction.

The Planning and Building Department is supportive of investigating and/or adding provisions to cover the issues raised during the May 7 and May 21, 1996, Municipal Planning Commission meetings. Although the issues raised above during the Municipal Planning Commission meetings are important, the Planning and Building Department is confident that any additional amendments can be handled in the drafting of the amendment bylaws. The proposed amendments to the Zoning, Building, and Licensing Bylaws will take considerable time to complete prior to a Public Hearing. This time will allow the Planning and Building Department to include specific standards related to the issues raised above.

The Municipal Planning Commission will be informed of the proposed additional amendments prior to the Public Hearing on this matter and will submit a further report to Council prior to the final drafting of the proposed amendments to the Zoning, Building, and Licensing Bylaws."

Mr. Alan Wallace, Senior Planner, Planning and Building Department, provided background information regarding the proposed new sign regulations and circulated additional material on the matter to Council members.

Attached is a copy of a letter dated May 14, 1996 from Mr. Bob Blackwell, Chair, 1997 UCI World Championship of BMX requesting that the City co-sign for interim financing for funding required for the two events noted above. Your Committee met with Mr. Blackwell and determined that the Province has approved co-signing for 50% of the total amount of \$166,205.00 providing the City

also co-signs the loan. Mr. Blackwell has made every attempt at securing funding without this requirement, however, all attempts have been unsuccessful. Without this arrangement, the event will be turned over to the second bidder, Kelowna, BC.

The current BMX track on the Exhibition Grounds is not suitable for the event, in that it does not have sufficient seating capacity. The Exhibition has upgraded the Grandstand, and that is where the BMX track will be set up. The dirt will be removed afterward, for use by the Exhibition in other areas.

Your Committee attempted to provide a recommendation on this matter, and came up with the following proposal, however, it was not accepted by majority vote:

- 1) that the City co-sign for an interim financing loan to the 1997 UCI World Championship of BMX organizing committee for up to 50% of the total loan of \$166,205, which is equivalent to the Province's commitment as co-signer;
- 2) that, should the City be required to finance any loss as co-signer for this loan, it be recognized the source of funding will ultimately be from the 1997 year-end results of the Operating Budget; and
- 3) that the Administration and Finance Committee be requested to consider the development of a Policy for this type of financial commitment."

Mr. Bruce F. Eaton, President, Saskatoon Hotels Association, expressed support for the request for the City to co-sign a loan for interim financing for the hosting of the 1997 UCI World Championship of BMX. He expressed the view that the city would greatly benefit from this event, and encouraged the City to provide whatever assistance is needed to ensure that the event is a success.

Ms. Susan Lamb, Executive Director, Tourism Saskatoon, indicated that hosting the 1997 UCI World Championship of BMX in Saskatoon provides an opportunity to showcase our community to the world. She highlighted the economic advantages of this event and noted that, as the event will be broadcast internationally, it will provide visibility to help market our community. Ms. Lamb expressed the view that with participation from riders across the world, it will bring international attention to our city.

Mr. Bob Blackwell, Chair, 1997 UCI World Championship of BMX, advised Council regarding the importance of the project to our city, and provided information regarding the business plan. He urged Council to offer its support in co-signing an interim financing loan for the 1997 UCI World Championship of BMX Organizing Committee.

Ms. Laura Holtorf, President, Bridge City BMX Club, provided information regarding the BMX Club, and asked Council to support the request by the 1997 UCI World Championship of BMX Committee to co-sign a loan for interim financing.

Upon evaluation of the bids, it was found that A.M.E. Systems Ltd. (the apparent low bidder), did not properly fill in one of the items on the tender form. Some time after the tender opening, it was determined that this item was not required.

An attempt to get written agreement from all bidders to delete this item was unsuccessful. The tenders were therefore evaluated as submitted. The Department has no choice but to deem A.M.E. Systems Ltd.'s bid as incomplete by the wording of the tender, and recommends that the tender be awarded to Wappel Construction Co. Ltd. as lowest qualified bidder.

The Public Works Department's estimate to supply and install the Fairbrother and Parkridge earthwork, mains and service connections is \$786,000.

Funds are provided under the 1996 Capital Budget, Prepaid Subdivision Services - Silverspring, Project Nos. 602-14 and 1391-1 (Water/Sanitary Sewer Mains, Storm Sewer Mains and Water/Sewer Connections).

The net cost for the construction portion of the project is calculated as follows:

Report of Chair, Social Services Subcommittee, May, 1996:

#### "REPORT

The Social Services Subcommittee is recommending funding of \$201,900, for twenty-nine (29) human care agencies delivering programs for Saskatoon residents. The Committee reviewed the requests for funds following City Council Policy C03-018 - Assistance to Community Groups. The Committee thanks the City of Saskatoon for maintaining the level of funding for the Cash Grants Program Social Services component given the changes to funding with the elimination of The Canada Assistance Plan Transfer Program.

The Subcommittee evaluated the proposals giving priority to those projects and programs which provide direct services to enhance the quality of life for Saskatoon residents, especially as they relate to the family; those which meet demonstrated areas of current and urgent need; those that demonstrate consumer group involvement; those who demonstrated, by the nature of their activities, the maintenance of a stable community and those who interface with existing City services.

In previous years, the Subcommittee has encouraged organizations to develop partnerships, co-ordinate programs, network and to work in a co-operative and collaborative climate to better deliver services to the community. Organizations with a community development focus and those who have developed partnerships with other organizations and are delivering or developing joint programs maintained or increased their allocations.

In 1996, thirty-nine (39) organizations applied for \$429,195.00 in funding. Fourteen applications totalling \$92,000.00 were received from organizations who had not received grants last year. The 1996 recommendation equals the total budget of \$201,900. Twenty-nine (29) organizational grants of \$750 to \$27,500.00 are being recommended. Six (6) organizations who did not receive funding in 1995 are recommended for funding of \$9,250.00. Although the grants are small, the support for the initiatives of these groups meet needs in the community. In line with past comments, the Committee was overwhelmed by the needs identified and the requests for funds.

Following the review process, the Subcommittee has identified a number of issues which it feels should be mentioned. The Subcommittee must restate that organizations who have depended on grants for general operations may not receive the same amount in future years. As mentioned, applicants were evaluated using the City policy and evaluation criteria. Those agencies who maintained or increased funding met the criterion. The Committee was impressed by those agencies who are working collaboratively, who have revisited their missions to ensure their organization is relevant and those whose programs meet the needs of at-risk children.

The Committee observed that a number of organizations requesting grants had considerable surplus and reserve equity. These groups must be encouraged to better plan for and utilize these dollars rather than maintain reserve accounts. As well, future budgets should be submitted for general operations as well as projects. Financial accountability by agencies is imperative.

Saskatoon requires a basic level of human care infrastructure. Given the dollars available, Government and community groups must continue to build upon their capacities to address the issues of our community. Community asset building must be encouraged to develop these strengths further. A social planning model of community development must be adopted.

The Committee also wishes to restate our previous recommendation that the City of Saskatoon look at other means of supporting organizations through gifts-in-kind, such as free rental space, tax exemption, and used equipment.

The Social Services Subcommittee has made specific comments relevant to each of the recommendations for the applicant profile. We would be pleased to answer any questions that you may have with respect to our recommendations."

## B9) Enquiry - Councillor Birkmaier (April 9, 1996) Woodlawn Cemetery (File No. 4080-1)

**RECOMMENDATION:** that the following report be received as information.

Report of the General Manager, Public Works Department, May 28, 1996:

"The following enquiry was made by Councillor Birkmaier at a meeting of City Council held on April 9, 1996:

"In light of the discussions with respect to vandalism in Woodlawn Cemetery,

would the Administration please report to Council on the costs for provision of lighting in Woodlawn Cemetery and the trimming of trees to above 10 feet."

Presently, only Memorial Drive, the entrance road to the Woodlawn Cemetery, is serviced by standard street lighting similar to that found on residential streets throughout the City. There is also some area flood lighting adjacent to the columbarium, and the service building within the property. In order to enhance the light levels within the Cemetery, the Electric System Branch was consulted regarding the installation and operating costs for a similar level of street lighting along 1500 linear metres of roadway in the older more wooded portion of the Cemetery.

Approximately 50 light standards would be required at a cost of \$2,700 per light standard. Installation of this limited set of lights would cost an estimated \$135,000 with annual operating costs of approximately \$12,000. This cost is considerably higher than the cost of fencing the site which was considered in the fall of 1995.

In view of the capital cost of standard street lighting which would serve only a limited portion of the Cemetery, the staff at Woodlawn are currently exploring the cost and effectiveness of strategically-placed area flood lights, which would provide a lower level of lighting spread over a larger area of the Cemetery. If such a solution is feasible, it will be considered for inclusion in the 1997 Capital Budget.

As an immediate response to vandalism at Woodlawn Cemetery, the Public Works Department has contracted a security company to perform random surveillance checks of the grounds during the night, early morning, and on weekends, along with associated signage. Security companies contacted indicated that an unexpected and unpredictable presence of security personnel, along with signage warning of such patrols, tends to discourage vandals from lingering in an area under such surveillance.

An inspection of the freestanding evergreen and deciduous trees in the Cemetery indicates that lower branches have been pruned up to a height of twelve to fifteen feet in previous years, in an attempt to remove foliage which tends to screen long distance visibility."

IT WAS RESOLVED: that the information be received and that the item with respect to area floodlights be included for consideration under the 1997 Capital Budget.

Report of the General Manager, Public Works Department, May 29, 1996:

"The Concorde Group, along with residents and other business groups, made a presentation to the Planning and Operations Committee on May 28, 1996, asking that a paved surface be applied to 107th Street east of Central Avenue to the CP tracks. The road is presently a gravelled surface and

the dust generated creates a nuisance to the businesses and residents of the area. The business community has committed to paying a portion of the capital cost of the work.

The City's Administration reviewed the proposal and has the following comments:

- this road carries one of the highest loading conditions of any road in Saskatoon and therefore needs an extensive pavement structure to avoid continual failures of the structure;
- · if the road was financed as a Local Improvement, and previous rules applied, the City's share for this road would be approximately \$100,000; and,
- the Roadways Branch of Public Works agrees that this street is a nuisance and takes a great deal of maintenance.

The Concorde proposal includes the following funding by the businesses that will benefit from the construction of the road:

Revelstoke Redi-Mix	\$ 7,500
CP Intermodal	7,500

Concorde Group 13,000
Total private contribution \$28,000

The Administration reviewed the City of Saskatoon's position for financing of the project and the City Comptroller advised that the only funds available would be from transferring funding already allocated to existing projects.

The Public Works Department reviewed the 1996 Capital and Operating Programs and is prepared to recommend that the following funds be transferred to the project:

- a) \$20,000 from Paved Street Maintenance Budget (1996 Operating Budget),
- b) \$20,000 from Earth Street Maintenance Budget (1996 Operating Budget),
- c) \$20,000 from Collector Preservation Budget (1996 Capital Budget); and,
- d) \$20,000 from Circle Drive Restoration Budget (1996 Capital Budget).

The consequences for transferring these funds will be that less planned maintenance will be performed on paved streets (e.g. pothole patching, or seal treatments), the Collector Preservation Program will be reduced by eliminating one of the streets on the Program, and the amount of permanent pavement markings installed on Circle Drive between the Circle Drive Bridge and Attridge Drive will be reduced. The \$20,000 from the Earth Street Maintenance Budget was previously allocated to be utilized on 107th Street.

As well, the Department will allocate funds to cover 50% of the engineering costs for the project. The private corporations would also contribute 50% of the funds. The engineering services will be completed by a consultant as City staff are fully utilized at the present time.

#### **OPTIONS**

- 1. Leave the street as is and have the dust and poor condition of the road remain. The dust would be worse as the dust palliation program budget was reduced by 50%.
- 2. Finance the project as a Local Improvement Program with the earliest possible construction being 1997. The City would have the same financial cost.
- 3. Place the project in the proposed 1997 Capital Budget and review with all other possible projects."

Quoted below is a report of the General Manager, Transportation Department, regarding a proposed increase in transit fares, effective July 1, 1996. While your Committee supports the proposed increases, it has also requested the Administration to report further on the use of tickets for seniors which would include a price for a package of 10.

Report of the General Manager, Transportation Department, dated May 21, 1996:

#### "<u>BACKGROUND</u>

As part of the 1996 Operating Budget for the Transit Utility, Council was informed that the Administration would be recommending a fare increase in 1996 in order to meet the budget objectives. Through discussions with stakeholders and further analyses, it is concluded that an average fare increase in the order of \$0.10 per ride is the most strategic.

The proposed fare increase recognizes that there should be a larger incentive for customers to purchase tickets, particularly when considering the mix of coins necessary for the proposed cash fares, and to reduce counting and collection activities. It is also recognized that seniors have disproportionately endured fare increases over the past number of years, so no increase is proposed at this time.

#### **JUSTIFICATION**

City Council, as part of the 1996 Operating Budget, resolved that the General Provision for operating the Transit Utility would not exceed \$6,997,100. The total operating expenses amount to \$15,589,500. This is estimated to require passenger fares from cash, tickets and passes to amount to \$6,670,600, which is \$560,500 more than the actual revenue in 1995. While Saskatoon Transit Services has been successful at attracting customers, it will be necessary to increase passenger fares to meet the \$6,670,600 target to balance the 1996 Operating Budget.

#### **OPTIONS**

There are three basic options to be considered:

- a) no increase in fares
- b) an average of \$0.10 increase per ride
- c) variations of the \$0.10 increase.

If it were determined that there be no fare increase, an increase in revenues over 1995 in the amount of \$430,300 is projected due to increased ridership levels. Therefore, projected amount totalling \$130,200 would have to be recovered from other sources. It is recognized that in order to balance the Transit Utility budget at \$6,997,100, there will already be a requirement for a reduction in service. (A report regarding service will be submitted to the Committees and Council at a later date). If there were no fare increase, the additional \$130,200 would have to be recovered from additional service reductions. Saskatoon Transit Services is already opposed to reductions in service because customer confidence, and, therefore, ridership, is returning to 1993 levels. Further service reductions are viewed by Saskatoon Transit Services and customers as potentially eroding the service at a point where recovery would be strained.

The average \$0.10 fare increase, with variations as outlined below, is estimated to provide the necessary increased revenue with minimal impact on customer ridership. It is normally estimated that an increase of 1.0% in fares will result in a ridership decrease of 0.3%. These factors have been incorporated in the revenue estimates for the fare increase.

As part of the fare strategy, the following was noted:

- (a) While it is recognized that tickets offer convenience to customers, which should, in itself, encourage sales, it is felt that a discount of \$0.10 rather than the current \$0.05 would further encourage the use of the ticket as a fare medium. With a further shift to tickets, customers will not be required to deposit a range of different coins in the farebox, Operators will be in a better position to ensure correct fares are being deposited, and less administrative time will be required to count the fares on a daily basis.
- (b) Adult passes are currently equivalent to approximately 30 rides per month, while student passes are equivalent to 33 rides per month. In light of the students' limited

ability to pay and the philosophy of encouraging pass usage, it is felt that no increase in the student pass will be proposed at this time. In the proposed fare strategy, the student pass will be equivalent to approximately the same number of rides as the adult pass.

(c) It is proposed to leave the senior citizen's annual pass unchanged for 1996. The senior citizen's pass has escalated dramatically for the past number of years, so a one year "no increase" is proposed.

There are numerous other combinations of fare increases which could be proposed, all of which would potentially recover approximately the required revenues. However, the strategy proposed for 1996 recognizes that occasional customers should pay a small premium and regular customers should experience added convenience in their fare medium choices. It is that philosophy upon which the 1996 proposal is based.

#### **POLICY IMPLICATIONS**

As a result of the 1994 Comprehensive Audit of the Transit Department, it became policy to inform City Council of the amount of concession fares offered by Council through its transit fare decisions. The use of adult tickets and passes, student cash fares, tickets and passes, children cash fares and tickets and senior passes theoretically result in less revenues received than if all customers paid the full adult cash rate. For the information of Council, the use of concession fares as proposed for 1996 results in the following differences in revenue generated:

In addition, it is estimated that the concession fare for the senior citizen pass is \$1,294,819 for 1996. The above concession fares amount to a total of \$4,743,065.

The projected revenues for the proposed 1996 fare strategy are as follows:

Your Committee has considered and supports the following report of the General Manager, Leisure Services Department, dated May 10, 1996, regarding the use of Ashworth Holmes Park by Mayfair Lawn Bowling Club Inc.:

#### "BACKGROUND

The Agreement between the City of Saskatoon and the Mayfair Lawn Bowling Club Inc., for the use of the lawn bowling facility in Ashworth-Holmes Park, expires on May 16, 1996. The Mayfair Lawn Bowling Club wishes to renew the Agreement for a five-year term from May 17, 1996 to May 16, 2000. The Mayfair Lawn Bowling Club is 75 years old, and operates the lawn bowling facility each year from May 1 to September 15.

#### REPORT

Under the terms of the current Agreement, the Lawn Bowling Club manages and maintains the building, and is responsible for all operating costs, utility charges, staffing, maintenance costs, and taxes. The City shares storage space in the club house during the winter months (November 1 to April 1), and has the option of using the facility for City programs or alternatively, making the building available to the Caswell Community Association during this time.

Once a year, your staff from the Asset Management Department along with a representative from the Lawn Bowling Club, conducts an inspection of the building and grounds. The Asset Management Department, Public Works Department, and Leisure Services Department have reviewed the terms of the lease and support the renewal of the Lease Agreement for a five-year period, with the same terms and conditions.

**RECOMMENDATION:** 1) that the requested tax exemption for use of 830/840

Idylwyld Drive North by Victory Church be denied; and

2) that any tax abatement be denied.

ADOPTED.

Attached is a copy of the above-noted communication which was forwarded to the Administration and Finance Committee for further handling.

Your Committee has met with George Turanich and determined that Victory Church is not the legal owner of the property at 830/840 Idylwyld Drive North, and therefore does not qualify for tax exemption. Should the Church become owner of the property, an application for tax exemption from the owner should include the Church's charter.

As City Council is aware, the Administration and Finance Committee is undertaking an in-depth review of the Tax Abatement Program, and will not be recommending any new tax abatements until a policy has been established.

Report of General Manager, Finance Department, May 9, 1996:

#### "BACKGROUND

According to Section 275 (1) (d) of *The Urban Municipality Act*, the following is exempt from taxation:

'every place of public worship and the land used in connection therewith to a maximum of:

- (i) 0.81 hectares; or
- (ii) 10 square metres of land for every one square metre of occupied building space used as a place of public worship; whichever is greater, that is owned by a religious organization, except any portion of that place or of that land that is used as a residence or for any purpose other than a place of public worship.'

It is our understanding, through discussions with Mr. George Turanich, that the portion of

the current buildings being considered for use consists of the gymnasium and the office areas of the school building. The current assessment for this portion of the building is 82,790. (Note: The letter dated April 4, 1996, to Mr. Turanich had a transposition of numbers contained in it and we would bring to your attention this change at this time.)

The apportioning of the land is based on the assumption that the commercially zoned (B1) portion is not affected, and would remain as a separately assessed area. Pro-rating the remaining (M3) land assessment by the respective building assessments results in a portion of land assessment being 20,430.

The resulting assessments/general taxes would be as follows:

Building 82790 Land 20430

103220 @ 133.55 mills = \$13,785.03

Note • these estimates are based on the current assessment system in place and are subject to change with the pending reassessment.

· changes to the building that would result in building assessment changes would also result in changes to the land apportionment.

The only other church in Saskatoon, which receives a yearly abatement of taxes from City Council, is located at 330 Avenue G South. This is a church operated by the Saskatoon Chinese Mennonite Church but the property is owned by the First Mennonite Church of Saskatoon. There is no rental fee charged to the Saskatoon Chinese Mennonite Church for the use of this property."

3. Identification for Potential Purchasers Properties on *The Holding Bylaw* (File No. CK. 680-11)

**RECOMMENDATION:** that the Administration be authorized to implement a system to

"flag" properties listed on The Holding Bylaw, so that it appears on

the tax certificate and on the yearly tax bill.

ADOPTED.

Your Committee has been investigating a way to ensure potential purchasers of properties in the City are aware, prior to purchase, that the property is listed on *The Holding Bylaw*, and what that means. Even though this information would be significant to approximately 15 properties on *The Holding Bylaw* (because there are schools, churches, and other buildings on Schedule "A" that would not be sold anytime soon), your Committee believes it is significant information for a potential purchaser to know. Your Committee, therefore, requested a report from the City Solicitor's Office identifying ways in which this could be done, and that report is quoted below.

It was determined that the Saskatoon Real Estate Board provides detailed listing information for properties for sale. The Committee thought that perhaps the Board could include an additional comment on any listing for a property that is on *The Holding Bylaw*, indicating the 60-day restriction for issuance of a Demolition Permit. The Committee is investigating whether this could be done. In the meantime, the Committee believes that the City's records could also contain this information, should a potential purchaser be provided with copies of a tax bill.

Report of Solicitor, May 9, 1996 (excerpt):

"The most reliable method of notifying a potential owner is by way of caveat. However, as the Committee is aware, *The Heritage Property Act* does not allow registration of a caveat. We note the Committee has petitioned the Province requesting the appropriate amendment.

We have discussed this matter with the Treasurer's Branch of the Finance Department. We are advised that the Treasurer's Branch computer system has been adapted to 'flag' properties on which local improvements are pending or on which there is an assessment appeal pending. When a tax certificate is requested, these 'flags' on the computer system result in a notation being placed on the tax certificate that there is a local improvement pending or that the property is the subject of a pending assessment appeal. The Treasurer's Branch has advised that with a small enhancement to their system, an additional 'flag' could be added with regard to properties listed in the Schedule to Bylaw No. 6770. This would result in a notation to such effect being placed on a tax certificate covering the subject property.

It is a normal part of a real estate transaction that a purchaser will obtain a tax certificate from the City to ascertain the state of the taxes on the property. Accordingly, the purchaser would be aware at that stage that the property was listed on the Schedule to Bylaw No. 6770. The difficulty is that the tax certificate usually is requested only after the purchaser is

already legally committed to the purchase transaction. However, a notation on the tax certificate would provide at least some advance notice of the fact that the property is contained on the Schedule to Bylaw No. 6770.

The Treasurer's Branch also reports that a further enhancement to the system could be undertaken to place this information on the yearly tax bill. A physical redesign of the bill would also be necessary. Once again, this is no guarantee that a purchaser will become aware of the information. However, it would serve as an ongoing reminder to the owner that the property is scheduled, and should increase the likelihood that an owner will reveal the information to a potential purchaser.

We are also advised by the Planning and Building Department that many developers and other persons involved in the real estate industry regularly check with that Department prior to a development or a purchase as to zoning or any other regulation which may affect the subject property. The Department keeps a register of properties on the Schedule to Bylaw No. 6770 for the purpose of responding to such inquiries."
