Excerpt from Report of City Solicitor, dated February 19, 1997:

"The Heritage Property Act provides that a Notice of Intention to pass a designation bylaw must be served on the Registrar of Heritage Property and the owner of the property. As well, Notice of Intention must be registered in the Land Titles Office and be published in a newspaper in circulation in the municipality. All notices must have been given at least 30 days prior to consideration of the bylaw. All prerequisites to the consideration of the bylaw have been completed.

The *Act* further provides that any applicant who wishes to object to the proposed designation must serve Council with an objection stating the reasons for the objection and all relevant facts. The objection must be served at least three days prior to the Council meeting at which the bylaw is to be considered.

Proposed Bylaw No. 7615 designates this property as municipal heritage property. The conditions of designation contained in section 5 of the proposed bylaw are those recommended by The Municipal Heritage Advisory Committee. Section 6 of the Bylaw removes the property from The Holding Bylaw."

A copy of the Notice which appeared in the local press under date of Saturday, January 25, 1997, is attached, as well as a copy of proposed Bylaw No. 7615.

The following enquiry was made by Councillor Postlethwaite at the meeting of City Council held on November 4, 1996:

"Would the Administration please report on the possibility of implementing a 'Reverse Mortgage' Scheme for property owners as is common in other jurisdictions and look into the necessary amendments to *The Urban Municipality Act* to allow the implementation."

Report of the City Solicitor, February 19, 1997:

"Reverse mortgage schemes do exist in British Columbia and Ontario. However, these mortgages are established by private companies similar to how mortgages are currently obtained in Saskatchewan. The municipalities themselves have nothing to do with the reverse mortgages.

British Columbia also has *The Land Tax Deferment Act*. Under this *Act*, owners of eligible property can apply to the Provincial Government to defer a portion of their property taxes. The Provincial Government would then place an encumbrance on the property. The amount of the deferred taxes would then be paid by the Province in each year to the municipality in question. The Province would receive payment of the deferred taxes upon the termination of the agreement which occurred when the eligible property was disposed of or notice of termination was given by the Minister under the *Act*.

The scheme enacted under *The Land Tax Deferment Act* is a Provincial tax deferment plan. If such a plan were to be implemented in Saskatchewan, such an initiative would have to come from the Province."

## **RECOMMENDATION**: that the direction of Council issue.

Your Committee, at its meeting held on February 25, 1997, considered the report of the General Manager, Transportation Department, dated February 18, 1997, and received further presentations from various residents in the area. After considerable discussion on the matter, a motion was put forward to accept the recommendations of the February 18, 1997 report. The motion was lost on a tie vote; however, your Committee wishes to submit the following recommendations to City Council for consideration at this meeting:

- that Coppermine Crescent be partially reopened to accommodate southbound traffic only near its intersection with Churchill Drive as shown in Attachment 1;
- 2) that all costs associated with the closure be funded from Capital Project No. 1512: Neighbourhood Traffic Management Program; and
- 3) that the City Solicitor bring forward the appropriate bylaw.

The following is the report of the General Manager, Transportation Department, dated February 18, 1997:

#### "BACKGROUND

The Planning and Operations Committee, at its meeting held on February 11, 1997, considered a report from the General Manager, Transportation Department, dealing with the closure of Coppermine Crescent. At that meeting, the Committee resolved:

'that the matter be referred back to the Administration to consider the options and bring forward a report to the next meeting of the Committee and that the Administration consider discussing the matter further with the community.'

This report is submitted as a supplement to the General Manager's report dated January 28, 1997, and documents what has been carried out since the last Committee meeting.

#### REPORT

Since the Planning and Operations Committee meeting, the Transportation Department has examined an additional option to the closure, and has discussed this option with community representatives. The option consists of a partial opening (or partial closure) of Coppermine Crescent at its intersection with Churchill Drive. Under this option, vehicles would not be allowed to turn onto Coppermine Crescent from Churchill Drive, as shown in Attachment 1.

A partial re-opening has the following advantages and disadvantages over the previous full closure:

#### Advantages

- 1. The partial opening of Coppermine Crescent will provide an alternate southbound route to access the neighbourhood from Primrose Drive, thereby reducing the need to make southbound, left-turn movements at the intersections of Warman Road and Churchill Drive and at Warman Road and Assiniboine Drive. A decrease in southbound left-turning vehicles at Warman Road and Churchill Drive will reduce the potential for rear end collisions and improve safety.
- 2. Prior to the closure, there were 2,000 vehicles using the closed portion of Coppermine Crescent. The partial opening will reduce the original (prior to closure) 2,000 vehicles per day to an estimated 1,200 vehicles per day.
- 3. The partial opening will provide additional access for southbound traffic. This will reduce the number of motorists who currently make left-turn movements from the two legs of Coppermine Crescent onto Primrose Drive heading west towards Warman Road.
- 4. During an emergency, the partial opening can be used by emergency vehicles to go in either direction. This will improve accessibility for emergency vehicles.
- 5. This would provide a compromise solution which partially satisfies the requests of both sides of the issue.

#### **Disadvantages**

- 1. Since a partial closure only blocks traffic flow in one direction, it is not as effective as a total closure in reducing through traffic. The only way this option would be totally effective is if the shortcutting traffic were predominantly from one direction. Southbound and northbound traffic is split equally on this street, at all times of the day.
- 2. Depending upon the roadway grades and location of storm sewers, this option may require changes to the surface. There will likely be a need to install a catch basin and lead to connect to a storm sewer on Churchill Drive.
- 3. Residents living south of the partial closure, particularly those who desire a quick access route to recreational facilities to the north, may not support this option.
- 4. Some motorists might ignore the signs and use the partial opening for northbound trips anyway. This location would be particularly prone to such a violation by motorists because the one-way section is short, and someone could very easily slip through without being noticed.

## **DISCUSSIONS WITH MEMBERS OF THE COMMUNITY**

A meeting with members of the community and the Ward Councillor was held on Monday, February 17, 1997. Both sides of the issue, i.e. those who are for and those who are against the permanent closure of Coppermine Crescent, were represented. The proposal to partially re-open Coppermine Crescent was presented and discussed during the meeting.

The partial opening was viewed as a compromise, and is generally supported by both sides. In addition to the partial opening, a proposal to prohibit left-turn movements from Primrose Drive onto the east leg of Coppermine Crescent was discussed. The idea was to prohibit left turns in conjunction with the partial opening. This would force motorists who wish to turn left to use either the west leg of Coppermine Crescent or the intersections of Warman Road and Primrose Drive, and Warman Road and Churchill Drive.

After a more detailed analysis of the proposal, the Department does not recommend such a measure for the following reasons:

One of the reasons for investigating partial reopening of Coppermine Crescent is to
provide alternate access in order to deal with safety concerns at the intersection of
Warman Road and Churchill Drive. Prohibiting left turns at the east leg of
Coppermine Crescent would transfer many of the left turns back to the Warman

Road and Churchill Drive intersection. This is contrary to the intent of the partial reopening which is to reduce southbound left-turn movements at Warman Road and Churchill Drive.

- 2. The west leg of Coppermine Crescent and the driveway to the Lawson Heights Mall are only 30 metres apart. To increase left-turning traffic at this intersection would potentially increase the length of vehicle queues and interfere with safe operation of traffic flow at the driveway. An increase in left-turning traffic would also be affected by eastbound traffic coming off Warman Road, possibly increasing conflicts at this intersection.
- 3. To prohibit left turns at the east leg of Coppermine Crescent and not at the west leg may further split the community on this issue. It would also appear as if one section of Coppermine Crescent were receiving preferential treatment.

#### **DISCUSSION**

The partial closure option discussed above is not new, and was investigated previously when temporary closure was being recommended. It was not considered the best option, however, because it is not totally effective in reducing shortcutting traffic. The one-way option works effectively when only one direction is being used as a shortcut. This is not the case with what was observed on Coppermine Crescent prior to the closure. The split between northbound and southbound traffic on the now closed portion of Coppermine Crescent was essentially 50/50, at all times of the day. Where such measures have been implemented, monitoring results have shown that 60% of the original traffic remains on the street. In this case, it would mean that an estimated 1,200 vehicles may continue to use the section of Coppermine Crescent which connects to Churchill Drive.

The Transportation Department is recommending approval of this option only as a compromise solution, and not on its merits as the most effective and comprehensive solution to the problem.

The Transportation Department will continue to monitor traffic flows and collision data in the neighbourhood. Upon completion of the Warman Road reconstruction, the appropriateness of this partial closure, or any other remedial actions, will be re-evaluated.

#### **OPTIONS**

- 1. Reopen Coppermine Crescent and revert back to the original arrangement.
- 2. Close Coppermine Crescent permanently.

## **POLICY IMPLICATION**

There are no policy implications.

## **FINANCIAL IMPACT**

The estimate for the permanent closure is \$15,000 which includes the cost of a catch basin and lead. It is proposed to fund this project from Capital Project No.1512: Neighbourhood Traffic Management Program.

Report of the General Manager, Finance Department, February 24, 1997:

#### "The Tax Enforcement Act

The basic philosophy of *The Tax Enforcement Act* is to secure payment of tax arrears under the threat of the loss of title to the property. The statute is not intended to provide a vehicle for the acquisition of property by the City. Each property owner (taxpayer) has certain fundamental rights concerning his/her land. The taxpayer must be kept fully aware of the proceedings being taken, and be given a reasonable time frame during which arrangements can be made for payment of the outstanding amount.

The steps under this Provincial statute are scheduled as follows:

- 1. The Tax Enforcement Act provides for the registration of a tax lien against a property where taxes have been due and unpaid for more than six months after the 31st day of December of the year in which the taxes were originally levied.
- 2. Where the taxes remain unpaid and the lien has not been withdrawn, first application for the transfer of title to the City may begin at any time after the expiration of one year following the registration of the tax lien in the Land Titles Office.
- 3. Final application for transfer of title to the City may commence six months after the first application. The City must, at this point in the proceedings, contact the Provincial Mediation Board and file an application for consent to obtain the title. The Mediation Board may, subject to certain conditions being met by the taxpayer, stay the proceedings by the City.

Within this schedule, the Administration now requests authorization to proceed, to secure further, the City's position with respect to those properties which became subject to tax lien action in 1994 and 1995.

#### 1995 Tax Liens (see Attachment 'A')

With respect to the properties listed in Attachment 'A', proceedings under *The Tax Enforcement Act* commenced on September 23, 1995. At that time, the City of Saskatoon, in accordance with the statute, published in <u>The StarPhoenix</u> the legal descriptions of all properties in arrears of property taxes which were subject to tax liens. The assessed owners were notified of the action being taken and were advised that if the taxes remained unpaid after 60 days following the date of the advertisement, a tax lien would be registered against the property on the official title held in the Land Titles Office.

Considerable effort has been made in contacting the assessed owners of the various properties identified in the Attachment 'A'. Attempts have been made to obtain payment or to negotiate reasonable payment schedules. However, as of the date of this report, payment has not been received from the respective owners and the property tax arrears are still outstanding.

The City has 1995 tax liens registered on 129 properties with tax arrears. These properties have been summarized by classification in Attachment 'A'.

These properties are now subject to first application for title under *The Tax Enforcement Act*. This action involves notification, to each registered owner by personal contact and each assessed owner by registered mail, that the City has followed the procedures under the Act to protect itself against outstanding arrears.

#### 1994 Tax Liens (see Attachment 'B')

On May 6, 1996, City Council approved proceedings with first application for title on 113 properties with 1994 tax liens. To date, 51 property owners have resolved their tax arrears. The remaining 62 properties, as listed in Attachment 'B', continue to have outstanding tax arrears and, therefore, the City is in a position to proceed to the third step of the tax enforcement process.

In proceeding to final application for title of these properties, the City must contact the Provincial Mediation Board and file an application for consent to obtain title. The Board will then contact each property owner and attempt to establish a payment schedule. If such a schedule is established, all resulting tax payments will be forwarded by the property owner to the Mediation Board which in turn, will forward the funds to the City. Only in limited circumstances will the City obtain title to property under *The Tax Enforcement Act*. Generally, the Act has been effective in securing tax arrear payments for the City.

#### ADOPTED.

Report of the General Manager, Finance Department, February 24, 1997:

"City Council has now received the 1997 Preliminary Operating Budget. The Letter of Transmittal is self-explanatory and provides an explanation of the key issues City Council must address.

The Budget, as tabled, proposes a zero percent mill rate increase, based on two assumptions. The first is that City Council, in reviewing the budgets for Boards, Commissions and related referrals, is able to make appropriate adjustments to ensure these organizations are able to meet the corporate budgetary guidelines. The second assumption, based on the Premier's announcement at the SUMA convention, is that there will be a reduced offset for the health levies when our exact revenue sharing grant is calculated. This latter figure will not be available until the Provincial budget is tabled on March 20, 1997.

The proposed schedule would have Boards, Commissions, and outside agencies starting their review at 5:00 p.m. on March 10, and if time permits, Civic departments in alphabetical order. March 12 would see the finalization of the remaining Civic departments, Utilities, and the General Government accounts."

#### **Section B - Planning and Operations**

B1) Proposed Street Closing Briarvale Road (File No. 6295-1)

"A request has been received from Preston Developments Inc. along with a deposit of \$100.00 for the closing part of Briarvale Road adjacent to Parcel S, Plan 96-S-13326. The purpose of the closing is to allow for consolidation of the closed street with the adjacent properties.

The various Civic Departments as well as SaskTel, SaskEnergy and SaskPower have approved of this closing proposal.

Attached to this report is a copy of Engineer's closing Plan No. P11-SL16 setting forth a detailed description of the closing described in general terms above. This description complies with the recommendations of the Chief Surveyor, Land Titles Office, Regina.

On February 3, 1997, City Council referred the proposed closing to the Administration for further information, the concern being the loss of parking on the street. The new subdivision proposed for the adjacent property creates cul-de-sacs with lots flanking on Briarvale Road thus eliminating the need for the original lay-by area which was provided to accommodate parking for frontage lots."

The following report of the General Manager, Transportation Department, dated January 21, 1997 is submitted for City Council's information:

#### "BACKGROUND

The Planning and Operations Committee, at its meeting held November 28, 1995, referred the above-noted communication from Shirl Jack to the Administration for a report. The letter from Mr. Chornomitz was received by City Council and referred directly to the Administration for a response to him.

Both enquiries concern two intersections on 33rd Street West. The first intersection is Northumberland Avenue/33rd Street which is a four-leg intersection with Northumberland extending south of 33rd Street and Catherwood Avenue extending to the north. The second intersection is Junor Avenue/33rd Street which is a T-intersection with Junor Avenue extending north of 33<sup>rd</sup> Street.

#### **REPORT**

The intersection of 33rd Street and Northumberland Avenue is presently controlled by stop signs in the north/south direction and a pedestrian-actuated traffic signal facing 33rd Street motorists. The intersection of Junor Avenue and 33rd Street is a T-intersection controlled by a stop sign on Junor Avenue. Both intersections were observed in 1996 with the following volume counts and collision statistics collected.

As the above traffic volumes indicate, the flow of vehicles entering these intersections is very unbalanced with the side streets having rather insignificant flow compared to 33rd Street. The traffic flows on 33rd Street are heavy and highly directional as is demonstrated by the eastbound movement on 33rd Street in the morning peak hour and the westbound movement in the afternoon peak hour. Traffic volumes on Junor Avenue, Northumberland Avenue and Catherwood Avenue have remained constant over the last five years. Over the last ten years, traffic volumes on 33rd Street, between Northumberland Avenue and Junor Avenue, have also remained constant at approximately 12,000 vehicles per day.

The number and type of collisions experienced at the two intersections does not indicate an abnormal trend, and are what can be expected to occur at intersections carrying these volumes of traffic and under the type of traffic control present. In addition, a field inspection indicated that there are no sight line visibility problems for motorists using these intersections.

The City of Saskatoon presently uses a warrant system for the installation of traffic signals. This system takes into account traffic volumes, collision data, intersection geometrics, number of pedestrians crossing, available gaps in traffic and proximity of other signalized intersections to evaluate intersections for warranted signalization.

The warrant for full signalization was performed for the intersection of Northumberland Avenue/33rd Street, and it was found that the warrant criteria for full signalization has not been met. The intersection has a priority point rating of 58, well below the 100 point level used as a guideline for further consideration. This intersection currently ranks 14th on the City's comprehensive priority point listing for installation of traffic signals. The intersection of 33rd Street and Northumberland Avenue will continue to be monitored in order to assess its need for additional traffic control devices on an ongoing basis.

The intersection of 33rd Street and Junor Avenue was also analysed for the possible installation of traffic signals. The warrant for full signalization was performed and the intersection has not met the warrant criteria for full signalization. The intersection has a priority point rating of 28, well below the 100 point level used as a guideline for further consideration. This intersection currently ranks 27th on the City's comprehensive priority point listing for installation of traffic signals. The intersection of 33rd Street and Junor Avenue will continue to be monitored in order to assess its need for additional traffic control devices on an ongoing basis.

The need elsewhere for the installation of traffic signals is significantly greater than at these two intersections. As such, it would not be appropriate to install traffic signals at these locations at this time. It should be recognized that installation of traffic signals at either location at this time would increase overall delay at both intersections and likely lead to an overall increase in collisions at both locations. Traffic signals tend to decrease right-angle collision incidents, but have a tendency to increase rear-end collisions on all approaches.

A concern was also raised regarding the safety of children crossing 33rd Street to attend Bishop Klein School (located on Northumberland Avenue, south of 33rd Street). Discussions with the Catholic School Board indicate that 62 children live north of 33rd Street and attend Bishop Klein School. Of these students, 36 are bused to school on a daily basis. The remaining 26 students are instructed to cross 33rd Street at Northumberland Avenue, under the protection of the pedestrian-actuated traffic signal at this location. Field studies have confirmed this, as the most recent count showed 24 elementary students crossing at Northumberland Avenue during the school day. The existing pedestrian-actuated traffic signal at this location affords pedestrians the same level of protection as a full set of traffic signals and, as such, the Department is satisfied with the level of service currently provided."

#### "EXECUTIVE SUMMARY

1996 was a successful year for the City of Saskatoon with respect to its neighbourhood-based summer recreation programs for children and youth.

The Leisure Services Department provides a variety of supervised recreational programs for children, youth, teens, and families throughout the summer months, at the neighbourhood and district level. These programs provide opportunities for these targeted populations to participate in a balance of recreational activities designed to provide quality leadership, encourage healthy leisure lifestyles, and enhance the social, physical, and cultural skills of children and youth.

All of these programs are designated as 'basic services', in accordance with the criteria in City of Saskatoon Policy C03-029 (Leisure Services and Fees and Charges). Therefore, they are available free of charge to all participants. Parents and other family members are welcome at all sites.

#### **BACKGROUND**

The Leisure Services Department reports the overall visitations and enrolments of neighbourhood and district-based summer recreation programs for children and youth on an annual basis to City Council. This report will reflect the response to the weekday

playground and paddling pool programs; the weekend paddling pool program; the summer youth centre programs; and the skateboard program.

The Leisure Services Department also tabled a report with the Planning and Operations and Administration and Finance Committees in December, 1996 that addressed the issue of year-round youth centres and the development of youth programs in general. That report outlined a process for determining where, when, and how the Leisure Services Department will involve itself in youth programming. The report indicated that the 1997 operating budget estimates would include an additional general provision of \$15,000 for new youth program initiatives. The Planning and Operations Committee approved the recommendations in that report and the Administration and Finance Committee referred the additional general provision to the Budget Committee. This report identifies priorities for expanded youth programming subject to budget approval and further consultations with the community.

#### **REPORT**

#### Playground and Water-Play Program (Weekdays)

A supervised playground program was operated in 43 neighbourhood locations for eight weeks or 38 full days in 1996 (from June 27 - August 21, inclusive), for children from 2 to 12 years of age.

Program leaders designed and delivered a variety of activities in accordance with the leisure needs identified through the Leisure Services Department's needs-assessment model. Daily activities at each site included sports, games, crafts, story-telling, music, creative drama, and special events. Water-play is a component of the playground program at 39 of the 43 sites where an outdoor water-feature is located (32 paddling pools and 7 spray pools).

Two locations are without an on-site recreation unit building and are served each week on a part-time basis through a travelling playground. These locations were McNab Park and Dr. J. Valens Park.

Overall attendance in 1996 at all playground sites was 153,226 visits, an 11.6 percent increase from 1995. The number of participants registered in the program was 22,982, a 6 percent increase over 1995. This level of participants represents 52.7 percent of the total eligible population of 2 to 12 year olds in Saskatoon.

Fifty-nine percent of the attendees were users of the water-play component of the playground program. This represented a two percent increase in usage over 1995.

It is the opinion of staff of the Leisure Services Department that the overall increase in attendance at the playground program in 1996 was due to exceptionally hot weather during the first two weeks of operation. Many of the playground locations experienced high usage of the water component as patrons utilized it for respite from the heat. A new spray feature in Erindale created a 105 percent increase in attendance there. Creative and dynamic playground leaders also attracted children to many of our playgrounds.

#### Weekend Paddling Pool and Spray Pool Operation

In addition to the regular weekday playground and water-play programs, the Leisure Services Department provides paddling pool attendants, through a contractual-service arrangement, to provide supervision at the 32 paddling pools on weekends. These individuals are required to attend to the water quality and participant safety as a requirement of the Provincial Health Regulations for operating these paddling pools.

The paddling pools were scheduled to operate a total of seven weekends (14 days), for five hours per day during July and August in 1996; however, they were closed for two of those days due to inclement weather.

The overall weekend attendance in 1996 at the paddling pools was 14,329 visits, a 17 percent increase from 1995. The number of participants enrolled in the program was 6,929, an 8 percent increase from 1995. The Leisure Services Department staff believe that this increase is due to the additional day the weekend paddling pools were operational as compared to that of 1995.

Seven spray pools located at Holliston, Pleasant Hill, Dundonald, Parkridge, Lakeridge, Forest Grove, and Erindale playground sites provide an opportunity for self-directed play, and do not require on-going supervision. Morning hours in the month of June are traditionally cooler than those of July and August, and the spray pool hours of operation are scheduled accordingly. Attendance and enrolment are not taken at these sites because an attendant is not present on the weekends.

## Summer Youth Drop-in Skateboard Program

A drop-in skateboard program operates as a specialized youth centre at the Archibald Arena during June, July, and August. Due to the specialized equipment required for this type of activity, it is operated at a single facility as a city-wide program.

The skateboard program began in 1989 as a result of a decision by City Council to amend the Traffic Bylaw to prohibit people from skateboarding on a street or sidewalk, or other public place within certain restricted areas (outlined in Schedule No. 5 of the Bylaw). The Skateboard Centre was developed to provide an alternative for the users of skateboards, and at the same time, provide opportunities for programming which emphasized skateboarding safety.

The skateboard program is supervised by staff experienced in skateboarding and provides instruction for skill development; special events and competitions; supervised, self-directed fun and enjoyment (while skateboarding); and training on the safety aspects of skateboarding.

The skateboard program operated six days a week at various times to meet the needs of the youth. Since the beginning of the skateboard program in 1989, the number of participants enroled has steadily increased from 150 to 952 in 1996, a 535 percent increase. Participants attended the skateboard program a total of 4,928 times in 1996, an increase of 41.6 percent from 1995.

The Leisure Services Department's staff believe that increases in attendance are a result of skateboarding becoming a growing recreation activity/sport in North America. Local skateboarding retailers indicate that increases in 1996 summer sales reached up to 60 skateboards per week.

The skateboard program attracts youth from across the City, as well as a number of out-of-town visitors to our city. The majority of users of the Skateboard Centre are male with an average age of 14 years. The largest number of registrants and highest attendance is among 13 - 14 year olds.

#### Summer District Youth Drop-in Centre Programs

The Leisure Services Department provided a supervised recreational program for youth 10 to 19 years of age at 11 elementary, high school, and mall locations throughout the City in 1996. The program was in operation for a total of 33 days.

Youth centre programs were located in the following locations in 1996:

Fairhaven School Bishop James Mahoney High School Evan Hardy Collegiate Princess Alexandra School St. Mary's School Confederation Park Mall Dundonald School Aden Bowman Collegiate Nutana Collegiate Westmount School King George School

The Princess Alexandra School location in the Riversdale neighbourhood was piloted as a late evening youth centre in 1995. This youth centre began the 1996 program with late night hours (6:30 p.m. to midnight) as well. However, due to a number of factors, the Princess Alexandra location reverted to the same hours of operation as all other City-operated summer youth centres midway through the program season. These factors included facility security issues (youth breaking into other parts of the schools during the later hours of the program); our inability to provide an alarm system inside the school to deal with the break-ins; and a significant drop in attendance at the youth centre after 10:00 p.m.

All of the youth centre programs were staffed with trained leaders who worked with the youth to design and deliver a variety of activities. The Bishop James Mahoney and Aden Bowman locations placed an emphasis on sports and games, in response to a high demand from older youth for these types of specialized activities. The programs at St. Mary, King George, Princess Alexandra, and Westmount Schools were designated as MeTaWeTan Centres, and placed an emphasis on experiences and an appreciation of the Aboriginal culture.

The overall attendance at youth centre programs in 1996 was 23,828 visits, a 6 percent decrease from 1995. The number of participants enrolled in the program was 2,697, a 16.6 percent decrease from 1995 which represents 10.6 percent of the total eligible population in this age group.

Staff believe that decreases in attendance and enrolment at the youth centre programs are due in part to the early closure of three youth centre locations whose schools were previously booked for Folkfest activities. Staff also noticed a decrease in attendance and enrolment at the MeTaWeTan sites. Participants informed staff that many were going out of town to their respective reserves for the summer and many were away participating at Pow Wows during the summer months. In addition, there was a decrease in the number of 0 - 9 year old participants attending the program as leaders encouraged this age group to attend the more age appropriate playground program.

The Leisure Services Department reviews its summer youth centre program locations on an annual basis in an effort to maximize the limited resources we have for such programs. Research shows that the greatest number of 10 to 19 year olds live in neighbourhoods in the far eastern, far western, and north end of the City. In addition, a cross-reference of the neighbourhoods that have a high number of 'youth', with neighbourhoods that have a large number of low-income households, and a review of those neighbourhoods where community associations have identified problems with 'youth' provides the Department with an indication of possible neighbourhoods where a youth centre program would be beneficial in 1997.

However, further discussions with community associations indicate a need to also review other factors that could affect the need for youth programs in neighbourhoods. Some of these factors include the number of youth and their demographics; prevention of at-risk behaviours; limitations of people to help themselves due to lack of family support and money; and the lack of mobility of Aboriginal youth in some neighbourhoods due to family obligations related to their culture.

Consequently, the Leisure Services Department will continue to provide four summer youth centre sites in the city-centre in 1997 and designate all of them MeTaWeTan (Let's Play) sites, with an emphasis on activities and sensitivity to the Aboriginal culture. In addition, the Department will continue to provide youth drop-in activities at the Westmount site throughout the fall, winter, and spring.

The Department will also continue to operate a youth centre in the Confederation Park Mall. Resources will be allocated to allow us to continue this program throughout the summer, as well as the fall, winter, and spring. We will also provide youth drop-in centres in the same six other 1996 locations.

#### New Youth Program Initiatives - 1997

In addition, the Leisure Services Department's program delivery strategy for youth programs identifies a need to increase participation by youth, particularly at the neighbourhood and district levels. In order to do this, we will need to increase the number of programs that we provide and, in some cases, change the way we deliver the program and the focus of the program. As a result we will be endeavouring to create some new initiatives in 1997 and will be addressing these initiatives through a proposed \$15,000 operating budget provision in the following manner:

• Directly delivering an <u>additional district summer youth drop-in centre in the Sutherland-Forest Grove area</u> to address the needs of youth in the Erindale, Silverspring, Sutherland, and Forest Grove neighbourhoods, allowing for twelve

summer sites, including the Confederation Mall project.

- Providing additional opportunities for Community Associations to partner with the City in identifying and delivering youth drop-in programs at the neighbourhood level throughout the fall, winter, and spring (as identified in our youth program development process).
- The Leisure Services Department will partner with sport-governing bodies to deliver sport skill development clinics during the summer months in districts throughout the City where a gap has been identified.
- The Leisure Services Department has once again recommended and gained approval from the Planning and Operations Committee to fund youth programs as one of the priorities under the Saskatchewan Lotteries Community Grant Program. There have been 34 youth projects applied for under this grant program for the 1997-98 grant year. Final adjudication will take place shortly for approval by the Saskatchewan Lotteries Trust Fund."

The Planning and Operations Committee, at its meeting held on January 14, 1997, considered the Transportation Department's report of December 27, 1996, regarding the above matter, as well as a letter dated January 14, 1997, from Mr. Arthur G. Baalim, submitting further suggestions, and resolved:

"1) that a report be submitted to City Council recommending that the report of the General Manager, Transportation Department, dated December 27, 1996, be received as information; and

#### **REPORT**

The Transportation Department has reviewed the suggestions contained in Mr. Baalim's letter dated January 14, 1997, and will be proceeding with action on both suggestions this coming summer.

The first suggestion was that consideration be given to installing pedestrian crosswalks across Spadina Crescent at Duke and Duchess Streets. During previous discussions with the North Park Community Association, the Transportation Department examined all of the intersections along Spadina Crescent between Queen Street and the Circle Drive Bridge. At that time, it was decided to install signed and marked intersections at all legal crossing locations. This will include the installation of pedestrian crossing signs and a painted crosswalk at Spadina Crescent and Duke Street, and at Spadina Crescent and Duchess Street. Sidewalk ramps and a hard surfaced pathway connection to the Meewasin Valley Trail will be included in this project. Signing and marking will be funded from the Signing and Pavement Marking operating budget, while the ramps and hard surfaced pathway will be funded by Capital Project No. 631 - Traffic Safety.

The second suggestion was to provide adequate crosswalk identification at the intersection of Queen Street and 7th Avenue. This intersection has recently been changed from a twoway stop to a four-way stop. While it was a two-way stop, a signed and painted zebra-style crosswalk extended across Queen Street on both sides of the intersection. Under four-way stop operation, the pedestrian crossing signing has been removed and the crosswalk will be painted as a standard single line crosswalk. This has been done because all vehicles must now stop at the intersection and it is redundant to have signs in place indicating the existence of a pedestrian crosswalk (which indicates that motorists must stop for pedestrians.) This summer, a corner bulb will be added to the southwest corner of the intersection to address an operational concern that has arisen following the installation of the four-way stop. The corner bulb will allow the stop sign to be located closer to the driving lane which will command more attention from the motorists and will be visible from a greater distance from the intersection. This bulb will also provide improved pedestrian protection by improving their visibility and reducing the crossing distance on Queen Street. The approximate cost is \$5,000 and will be funded by Capital Project No. 631 - Traffic Safety."

4. Operating Budget Impact
Park Enhancement Program
(File No. CK. 4205-14)

#### **RECOMMENDATION:**

- 1) that City Council recognize that neighbourhood park enhancement projects, funded wholly or in part by the community, have an operating budget impact and that these operating budget impacts require approval during the review of the annual Operating Budget estimates in order for these projects to proceed; and
- 2) that park enhancement projects estimated to cost over \$25,000 should appear for approval in the annual Capital Budget estimates as fully funded projects with operating budget impact estimates beginning in 1998.

Your Committee has considered and concurs with the following report of the General Manager, Leisure Services Department, dated January 29, 1997:

#### "BACKGROUND

The City of Saskatoon has had a Park Enhancement Program for neighbourhood parks in place since 1989 as a complimentary program to the neighbourhood park upgrading funding through the Capital Budget. Park enhancement projects are typically added program components to existing park amenities that cost under \$25,000 and, therefore, are not considered capital projects under the definition utilized for Capital Budget purposes. Projects vary in terms of type and scale but typically may include the installation of additional playground apparatus, players benches, lighting, or park furniture.

The Park Enhancement program is a jointly funded program between the City of Saskatoon Leisure Services Department and interested community associations. Community associations may fund a project in whole or in part. The City's contributions have been funded through a \$20,000 annual operating budget estimate in the Leisure Services Department's Community Development account.

Community associations apply to the Leisure Services Department on an annual basis for neighbourhood park improvements or redevelopment. All applications are reviewed and requests are verified in terms of need by the Leisure Services Department and the Public Works Department, Parks Branch. A number of factors are considered in the verification process including the existing programs and amenities available within the park; and a

technical evaluation of the current condition of the park and its amenities, including the identification of any maintenance and safety concerns. If the park improvements are substantial, the park will be put on the neighbourhood park upgrade list for partial or a complete redevelopment to be included in the Capital Budget process. Otherwise, the project will be placed on the current year request list for a park enhancement.

Projects that the community association has committed to funding fully are given first priority; however, all projects are considered, but all park enhancement project requests must have at least a 10% funding contribution from a community association.

#### **DISCUSSION**

The Park Enhancement Program has proven to be a very effective process for the public to make enhancements to their respective parks within the next year of application and without having to wait for a full upgrade under the Capital Budget process. The type and magnitude of park enhancement projects has grown since 1989 and the community has funded, in whole or in part, a total of 63 projects with a community contribution of \$201,400, and a City contribution of \$142,700.

The operating impact of park enhancement projects has, until now, been absorbed by the Asset Management and Public Works Departments in terms of design, construction, and maintenance. Over the past few months, there has been considerable discussion among staff of Leisure Services, Asset Management, Public Works, and the Electrical Branch of Public Works regarding the absorption of the operating costs associated with the construction of projects that will be developed under the park enhancement program. These costs have a direct impact to their operating budgets and sometimes are very significant (i.e. utility costs for lighting projects).

#### **JUSTIFICATION**

Seven projects have been approved for 1997. The community's contribution to these projects will be \$105,325 and the City's contribution will be \$15,275. (The remaining city operating allotment for 1997 will be placed in a reserve fund for future projects, as has been the practice since 1989). The operating impact for these projects will be \$5,400 and will be reflected in the 1997 Operating Budget estimates of the Asset Management and Public Works Departments. Since some Departments have identified that they will be unable to absorb these operating costs in their current budgets in the future, it is recommended that all park enhancement projects with operating budget impacts be required to gain approval through the Operating Budget process, beginning in 1998.

In addition, beginning in 1998, any projects that are estimated to be over \$25,000 will be placed in the Capital Budget as fully funded with operating budget impacts. A list of the 1997 park enhancement projects is attached in Appendix A.

#### **POLICY IMPLICATIONS**

Park enhancement projects that are estimated to exceed \$25,000 will be placed in the Capital Budget as fully funded projects with operating budget impacts.

#### **FINANCIAL IMPACT**

There will be a variable financial impact on the operating budget depending on the type and size of the park enhancement project.
