1. University of Saskatchewan Land Use Study -

Development Plan Amendment - Special Use to Direct Control District

Applicant: University of Saskatchewan

RECOMMENDATION:

that the application by the University of Saskatchewan to amend the City of Saskatoon Development Plan and Zoning Bylaw be approved, subject to:

- a) the proposed Direct Control District 3 being adopted as drafted; and
- b) Entertainment Complexes and Theatres <u>not</u> being included as a permitted or discretionary use within the Direct Control District 3

Your Commission has reviewed the attached report of the Community Services Department dated September 12, 2000, with the Administration and representatives of the University of Saskatchewan. Your Commission supports the recommendation outlined in the above-noted report."

Mr. Lorne Sully, City Planning Branch Manager, Community Services Department, reviewed the proposal and indicated that his Department supports the proposed amendment.

Mr. Gregory Kitz, Chair, Municipal Planning Commission, expressed the Municipal Planning Commission's support of the recommendation.

His Worship Mayor Dayday ascertained whether there was anyone present in the gallery who wished to address Council with respect to the matter.

Mr. Terry Boucher spoke in support of the proposed bylaw stating the rezoning would increase transit riders on the surrounding routes, it would mean more jobs for the east side of the city, and it would reduce peak hour traffic on the Circle Drive bridge.

Mr. Peter MacKinnon, President, University of Saskatchewan, stated that the Board of Governors takes the issue of the development of the University land seriously and has given this proposal much consideration. Mr. MacKinnon stated the Board of Governors regard the land as part of the

University endowment and he stated the importance of planning for that. The Board of Governors has approved the project and the land use study. Mr. MacKinnon stated that the vitality of the downtown is important to everyone and in essence the University is on the edge of the downtown. If they felt this proposal would undermine the values of the downtown they would be concerned, but they are satisfied their consultations have addressed the issues adequately. In closing, Mr. MacKinnon stated it is of interest to the University to proceed quickly in order to adhere to the engineering timetable, and he requested favorable consideration of the proposal.

Ms. A. Margaret "Peggy" Sarjeant addressed concerns with respect to the damage that could be done by allowing development of this nature in the area and the impact it would have on traffic flows. Ms. Sarjeant expressed her concern that this development will have a detrimental effect on the downtown core. Ms. Sarjeant provided City Council with a copy of her presentation.

Mr. Marcel Brossart spoke with respect to the employment opportunities provided through big box retail stores and that stores of this nature help out the economy with respect to taxes.

Mr. Don Irvine spoke against the development and stated the study that the University conducted was flawed and he did not agree that big box stores reflect the vision of the University. He stated that the development would not allow the University campus to remain as a place of inspiration and beauty. Mr. Irvine spoke with respect to the disappearing stores downtown and urged Council to defeat the proposal.

Ms. Diane Sawatzky, Civic Coordinator, Caswell Hill Community Association, spoke in opposition to the amendment. Ms. Sawatzky stated that the community has not been given adequate input and information and a format is needed that allows for communication to the community. Ms. Sawatzky spoke with respect to the downtown and stated educators should look at education not commercial business.

Mr. Aaron Wright spoke against the proposal on behalf of Silverspring residents.

Mr. Cliff Wright spoke in favor of the proposal and stated that what is important is that the City undertake what is necessary to maintain its vibrancy and economic wellbeing and this is fundamentally important to the Province as well. Mr. Wright stated the City has to ensure that financial resources are always available to support the University and that there are young people to use the University.

B3) Proposed Snowmobile Access Bylaw (File No. CK. 186-1)

RECOMMENDATION: that City Council consider Bylaw No. 7983.

We are pleased to enclose a copy of The Snowmobile Bylaw, 2000 for Council's consideration. The Infrastructure Services Department is presenting a report concurrent with this Report outlining the background and reasons for this Bylaw. The purpose of the Bylaw is to authorize the operation of snowmobiles in certain parts of the City. As Council can see, the proposed area is in the north area of the City along Highway 11/12. Access to the proposed area will allow the snowmobilers to utilize service station facilities and restaurants in the area.

Also, the Bylaw limits the hours during which snowmobiles may be operated in the City and limits the speed at which they may be operated. Finally, the Bylaw states that operators must comply with all other laws relating to snowmobiles.

The General Manager of the Infrastructure Services Department has reviewed this Bylaw.

ADMINISTRATIVE REPORT NO. 19-2000

D2) Proposed Snowmobile Access Bylaw (File No. 186-1)

RECOMMENDATION:

that the City Solicitor prepare a bylaw allowing for the operation of snowmobiles, between the hours of 0700 and 2300, within the corporate boundaries of the City of Saskatoon and along the route specified within the bylaw.

The Saskatoon Snowmobile Club has approached the City with respect to creating a bylaw that will allow the operators of snowmobiles access to food and fuel services found on Marquis Drive. Marquis Drive is a four-lane, divided arterial roadway located in Agriplace. The route along which access would be allowed is indicated on Schedule A (Attachment 1).

The Saskatoon Snowmobile Club has indicated that they will erect and maintain all markers, signing and barricades necessary to safely identify the proposed snowmobile route. The signing will be in accordance with the "Guidelines for Snowmobile Trail Signing 1988" of the International Association of Snowmobile Administrators or as otherwise required by the General Manager of Infrastructure Services. Infrastructure Services will post 40 kph speed signs to indicate the maximum speed limit on the snowmobile route.

There are approximately 65,000 snowmobiles in the province of Saskatchewan. With the advent of organized snowmobile clubs within this province, more municipalities are allowing snowmobiles access to services such as food, fuel and lodging. The City of Prince Albert has enacted a bylaw, which allows snowmobiles access into and around their City limits. These municipalities are entering into partnership agreements with the local snowmobile clubs for the snowmobile club to establish, maintain and sign those routes upon which access has been agreed.

Under "The Snowmobile Act" and subject to the approval of the Highway Traffic Board, the council of a municipal corporation may, by bylaw, authorize the operation of snowmobiles on any highway or portion of a highway, designated in the bylaw, within the area of the corporation.

The annual cost to establish, sign and maintain the proposed snowmobile access route would be the responsibility of the Saskatoon Snowmobile Club including the maintenance of a policy or policies of insurance in a form acceptable to the City.

The City Solicitor has reviewed this request and is in agreement with the creation of the proposed bylaw.

Councillor Maddin made the following enquiry at the meeting of City Council held on October 2, 2000:

"Would the Administration please review and report on the feasibility of placing a parking prohibition into effect for the north side of the 100 block of 35th Street West.

Parking at this location has created a safety concern since the opening of the Mano's Restaurant at that location."

Infrastructure Services has reviewed the roadway operation at this location and has noted an increase in traffic. A strip mall has been developed on the west side of Idylwyld Drive between 35th Street and 36th Street. This development has resulted in increased traffic volumes on 35th Street. Classified as a local roadway, 35th Street can accommodate only two parking lanes and a through lane. On-street parking is allowed on both sides of the street. Visibility is restricted when traffic

enters from or exits onto 35th Street from the commercial driveway or back lane due to parked vehicles on the street. There is also significant pedestrian activity at this intersection.

The removal of curb parking on the north side of 35th Street would allow for better visibility. It would also reduce traffic congestion. Given the traffic volumes, it is proposed that a No Parking restriction be placed on the north side of 35th Street between Idylwyld Drive and the north/south lane.

The costs associated with the proposed signing will be funded through the Roadways Signing and Markings Operating Budget.

Following a systematic evaluation of the proposals, it is recommended that the proposal from Reid Crowther & Partners Ltd. be accepted.

The net cost to the City for the proposal submitted by Reid Crowther & Partners Ltd. would be as follows.

A requirement of the Pre-design Report was to complete a structural evaluation of the existing overpass. From this evaluation, the City will decide if upgrading is necessary to meet current loading standards. If it is deemed necessary to upgrade the existing structure at this time, additional design fees, likely in the order of \$5,000 to \$15,000, will be required depending upon the extent of the upgrade.

Capital Project No. 950 - Idylwyld Drive / Circle Drive Structure Widening has \$120,000 of approved funding allocated in 2000. Of this approved funding, \$75,000 was budgeted for this design commission. Other tasks to complete in this phase of the project are to conduct a geotechnical investigation of the sub-soils (\$3,000), and to modify the roadway geometric design (\$10,000 - to be completed in-house).

Based upon the identified costs, there are sufficient funds to proceed with the design for the structural widening.

Section E - UTILITY SERVICES

E1) Call for Resolutions - SUMA For January 2001 (96th Annual) Convention (File No. CK. 155-3-2)

RECOMMENDATION: that City Council approve the following Saskatchewan Urban

ADOPTED.

The Call for Resolutions from SUMA was considered by the Administration and Finance Committee at its meeting of September 25, 2000, and was referred to the Administration for a report.

Special Needs Transportation

Special needs transportation services are jointly funded by the Provincial Government, through Saskatchewan Municipal Affairs, Culture and Housing, and the nearly 80 municipalities involved in the program.

The Province established the Transportation for the Disabled (TFD) Program in 1975 and was to cover the following:

- 50 percent of the operating deficit;
- 75 percent of the costs to acquire specialized vehicles for special needs transportation; and,
- 75 percent of the costs of studies percent, demonstration projects and construction projects.

In 1992/93 \$2.15 million was made available to municipalities through this program. In spite of increased demands and costs since this time, the funding available has not changed. In Saskatoon for instance, 1999 funding from the province represented less than 40% of total costs.

Environmental Product Stewardship

Municipalities are required by law to manage their citizens' waste. They have little ability to influence the quantity and quality of the materials which they are asked to handle. Stewardship, or producer responsibility, programs recognize that municipalities end up dealing with the results of producer decisions about products and packaging. These programs shift responsibility for paying for after-use onto producers and consumers of the product.

Stewardship programs recognize that we all have a role to play in choosing how resources will be managed. Saskatchewan has producer responsibility programs for tires, used oil, and pesticide containers which are working fairly well. Backed by government regulations, but operated by independent agencies, these programs handle specific parts of the waste stream by having product producers and consumers pay for responsible waste management.

Two classes of waste products require costly handling and disposal practices, for which there is presently no source of funding in place except by taxation.

One class of products include hazardous materials often used in the home, such as cleaning products, solvents, paint, pesticides, herbicides, and their containers which require special handling, and which cannot be accepted at municipal landfills. In practice, although most of these materials are liquids, the majority of them are disposed of through the solid waste system; the remainder are disposed of through the sewer system, poured on the ground, burned, stored by the consumer, or left as litter.

A second class of products is recyclable materials which can be collected and returned to be reprocessed for a beneficial use. Such products include numerous grades of plastics and glass. The costs of collection and transport are generally higher than the revenues generated by their return.

Beverage containers should not be included in the program since the SARCAN program is dealing effectively with after-use beverage containers. SARCAN has the best return rate on beverage containers in North America and fulfills a valuable social function in providing meaningful employment for disabled people.

Similarly, such organizations as Cosmopolitan Industries in Saskatoon are handling after-use paper and providing meaningful employment for disabled people. This product also is not necessary to include in the stewardship program.

B1)	Revised Swimming Pool Bylaw
	(File No. CK. 185-1 and 613-1)

RECOMMENDATION: that City Council consider Bylaw No. 7981.

ADOPTED.

We are pleased to enclose a new Bylaw entitled The Private Swimming Pools Bylaw, 2000. The Bylaw is a complete re-write of The Swimming Pool Bylaw.

The reason for the new Bylaw is twofold. First, the language of the old Bylaw was in need of modernization and the passage of the new Bylaw will accomplish this. Second, the new Bylaw addresses a number of smaller issues raised by the Fire & Protective Services Department and the Building Standards Branch. There are no significant changes in the Bylaw for property owners. The changes to the Bylaw include the following:

- (a) the requirement regarding the distance between horizontal structural members of enclosures has been clarified:
- (b) a section has been added requiring gates of enclosures to swing outward, in the direction away from the swimming pool;
- (c) the requirement for a locking device no longer specifies the lock must be a padlock;
- (d) the requirement for locking an enclosure has been clarified;
- (e) the standards for hot tubs which the Building Standards Branch currently require have been included; and
- (f) there is no longer a provision dealing with temporary enclosures, rather, the Bylaw simply requires the permanent enclosure be complete prior to the swimming pool being filled with water.

The Bylaw was reviewed and approved by the Fire & Protective Services Department and the Building Standards Branch.

6a) Proposed Walkway Closure
Parr Place and Borland Place
Proposed Bylaw No. 7968
(File No. CK. 6295-1)

REPORT OF THE A/CITY CLERK:

"Attached is an excerpt from the minutes of meeting of City Council held on September 18, 2000. Also attached is a copy of Bylaw 7968. Council closed its hearing into the proposed walkway closure but did not consider Bylaw 7968. Instead, the matter was deferred to the October 16, 2000 Council meeting in order for the Administration to report on the elevation problems.

The following is a report of the General Manager, Infrastructure Services Department with respect to the matter.

'At its meeting held September 18, 2000, City Council resolved:

"that the matter be deferred until the October 16, 2000 meeting in order for the Administration to report on the elevation problems."

This report deals with two issues relating to the information presented to council; drainage problems at 31 Blackley Place related to the new development in the area, and the impact closure of the walkways will have on drainage.

In early June, Mr. Krieger (31 Blackley Place) contacted Infrastructure Services and informed us that he was experiencing drainage problems on his property. He has been experiencing these problems for some time, even prior to the recent development behind his property. The recent increase in elevation of the lots backing his property has prompted him to contact the City and request preemptive

action to prevent the drainage problem, which he proposes will worsen, due to the new development.

The City immediately contacted UMA Engineering (Developer) and requested a survey along the rear property of 31 Blackley Place, to compare the elevations of the property line to the design elevations for Borland Place. It was determined that the elevation along the rear property line was lower than designed for Borland Place. At our request, UMA lowered the design grades of the rear property line of Borland Place.

In a letter received from Mr. Krieger on June 25, 2000 (Attachment 1), he states that his house appears to be constructed at least 0.5 metres below the design elevation. A site visit to 31 Blackley Place revealed that the elevation at the house did appear lower than the rear property line, which would be the major reason for the drainage problems on this lot. In order to obtain factual information on the elevations of Mr. Krieger's property, the City conducted a survey of the property, and the neighboring properties.

The City surveyed many points in the rear yard and along the house, and the information revealed that the elevation of the house was lower than the rear property line elevation. The depressed elevation of the lot and house are likely the reason for the existing drainage problem in this lot. However, the elevation along the rear property line of 31 Blackley Place is now higher than the design elevation for the rear lot line of Borland Place, acting as a barrier to water flowing along the rear property line.

Mr. Krieger has been forwarded this information along with suggestions for eliminating the drainage problem within his property (Attachment 2).

With respect to the issue of the walkway closure, if the existing properties, as well as those within the new development, grade their lots as per the design, run-off will be carried to the City right-of-way along the designed drainage path. Should the walkways be retained, the amount of water flowing along them will have a higher velocity and thus be dissipated faster, but will tend to travel in a straight line when encountering sharp bends in the walkway. However, a soil surface will allow for the infiltration of water into the ground, thus decreasing the amount of runoff, as well as slowing the velocity of flow, allowing the water to better navigate bends. There is no evidence to suggest that closing the walkways in question will detrimentally affect easement drainage in this area.
