City Council, during consideration of two Discretionary Use Applications for the intended use of taverns (brew pubs), at its meeting held on November 6, 2000 denied the applications and Council subsequently resolved:

that the issue of discretionary use for brew pubs be referred to the Planning and Operations Committee for a report.

Your Committee referred this matter to the Administration for a full report that would include historical background respecting past and current issues involving brew pubs, as well as information respecting alcohol consumption rates.

As well, the following enquiry was made by Councillor Steernberg at the meeting of City Council held on March 20, 2000:

"Several times over the last few years it has become evident that a category of liquor license which fits somewhere between Tavern and Night Club is needed.

Would the Administration please report on the procedure for requesting the action required by the Provincial Government, also any recommendations or restrictions considered important to the City of Saskatoon within that license request."

With respect to the question of alcohol consumption rates, it has been determined that according to the Saskatchewan Liquor and Gaming Authority, if more tavern operations are approved, complete with off-sale privileges, the total alcohol consumption volumes will not go up accordingly, as demographic factors such as actual population growth and the age of consumers form a more direct link with changes in consumption patterns and trends in the market place for liquor, not the number of licensed establishments.

With respect to the question of requiring Discretionary Use Applications for brew pubs, which was passed by City Council at its meeting held on August 14, 2000, your Committee endorses this decision. Attached is a copy of the report of the General Manager, Community Services Department dated March 15, 2001 on this matter, which your Committee has reviewed with the Administration and with concerned members of the community. Your Committee agrees that the discretionary use approval process is an effective means to facilitate appropriate technical review and meaningful public consultation, and that the Administration should evaluate the applications primarily on technical issues (traffic flow, parking, utilities, land use conflicts, site planning, etc.) rather than on marketplace issues. The Committee is also sensitive to the concerns of residents who may live in close proximity to a planned neighbourhood pub, and the discretionary use application will ensure residents are aware of an upcoming development proposal in their neighbourhood. Your Committee believes that encouraging business owners to become good community members is also important to the success of the neighbourhood pub concept.

A3) Feasibility of Constructing a Model of the Future Growth Study File No.: CK 4000-1)

RECOMMENDATION: 1) that the information be received; and

REPORT

During its January 8, 2001 meeting, City Council adopted the following recommendation:

- "1. that the information be received; and
- 2. that the Administration be requested to report on the cost and feasibility of a model based on the future growth study."

The Administration is concerned with cost, and will examine the most cost effective method available to produce a model of the Future Growth Study. The City Planning Branch has recently been contacted by a company which produces computerized 3D models of Canadian cities from aerial photographs (samples from Vancouver and Quebec City area are attached - please refer to Attachments 1 and 2). The company is currently working on such a model of Saskatoon. Cost is not known at this time.

Another option which will be considered would be to produce a detailed CAD drawing with an air photo underlay.

However, the request for a model of the Future Growth Study may be premature. The Municipal Engineering Branch and City Planning Branch are commencing with the second phase of the Future Growth Study in 2001. The second phase is intended to look at the three preferred growth sectors (west, northeast, east) in greater detail. The study will examine the infrastructure requirements and conduct a feasibility analysis for each growth sector. A major component of the study will include a concept plan for each growth sector. This is important information which should be included in any model that is constructed. At this point, it is premature to model the Future Growth Study without the results of the feasibility analysis and concept plans in place.

The City Planning Branch will gather more details concerning cost and practical applications for a model of the Future Growth Study. The West Growth Sector Study will be completed in early 2002 followed by studies of the Northeast and East Growth Sectors. A complete report will be submitted to Council providing cost and timing details of a Future Growth Model prior to work commencing.

Section F - CITY MANAGER

F1) Saskatoon Marketing Strategy (File No. CK 365-1)

RECOMMENDATION: that the information be received.

ADOPTED.

For many years, Saskatoon has been promoted through various agencies and institutions charged with the task of marketing the community to different target audiences. While each has met with success, the "shot-gun" approach has led to a segmented, inconsistent message. Many have made light of Saskatoon's numerous slogans over the years; Hub City, POW City, City of Bridges, Diamond in Denim Country, etc.

Within this context, a wide range of community organizations participated in the *Civic Forum on Business and Quality of Life* in January of 1999. Community leaders examined the issue of "Image and the Media" and agreed that a unified and consistent message would support agencies in their efforts to generate economic development, tourism activity, and assist in the recruitment of key positions - from medical specialists to welders.

One of the recommendations generated by the Forum called for the establishment of an umbrella group of organizations to review Saskatoon's image and to develop a common marketing strategy. To this end, the City of Saskatoon included this directive in its 2000 - 2002 Corporate Business Plan.

Over the past six months, a number of private and public sector companies met to discuss ways to increase the coordination of marketing efforts for Saskatoon and region. In addition to the City of Saskatoon, the participating organizations included: Tourism Saskatoon, the Chamber of Commerce, the Saskatoon Tribal Council, the Saskatoon Hotel Association, the Canadian Light Source, Innovation Place, AgWest Biotech, the Prairieland Exhibition, the NSBA, Saskatchewan Economic and Cooperative Development, the Saskatchewan Exporters Association, the University of Saskatchewan, SREDA, Wanuskewin, the Western Development Museum, the Metis Nation of Saskatchewan, the Downtown Partnership, the Centennial Auditorium, SaskPlace, and Saskatoon Sports Tourism.

"Team Saskatoon" further refined the problem and identified the need to reduce fragmentation and increase the impact of individual promotional efforts. It was agreed that a long-term, strategic marketing plan, including the development of a common "slogo", should be developed for Saskatoon. A working group consisting of the City of Saskatoon, Saskatoon Tourism, SREDA, and Saskatchewan Economic and Co-operative Development was struck, and in November of 2000, an Expression of Interest from local companies for the development of this plan was requested. A joint submission by Doug Fast & Associates and the Marketing Den was chosen.

The general direction of the process will be a focus on the future, as opposed to expending large portions of time revisiting the past. The elements of the initiative include the following phases:

- External Market Research Initial information gathering will focus on compiling existing market research data. The committee concedes that the awareness of Saskatoon in many markets is either negligible, or often negative, and that minimal resources should be expended to confirm this. The committee will provide known sources of information relevant to awareness or perception of Saskatoon, and Saskatchewan, in markets of interest.
- **Internal Research and Input** This will become a primary activity area for the consultant. Broad-based input at this stage will be crucial to encourage endorsement of the plan by the whole community. The consultants will conduct extensive consultation in the form of focus groups and personal interviews with key community representatives and leaders.
- **Branding/Image Development** Developing an effective, believable brand is an important part of the strategy. It will provide a central theme for the strategy and its tactical elements. The consultants will develop and test potential brands internally to determine their potential for community acceptance. The consultants will then test potential brands in external markets. The final brand and itinerant slogans, wordmark, etc. will be imbedded within the strategic plan.
- Strategic Plan Development More than simply the development of a slogo, key to the success of this initiative is the development of a long-term marketing strategy. Tactical elements to fit strategic initiatives will be organized into short, medium, and long-term actions, with cost ranges identified for each item. Measurement processes and indictors will be developed to accompany each strategic initiative or tactical element. The committee will select a final set of key indicators for monitoring and reporting to the community and investors.
- **Communication Strategy** The consultant will develop an appropriate communication strategy for the plan that will include a launch, and regular reporting to the public.

Exemplifying the cooperative spirit of the initiative, the City of Saskatoon, Tourism Saskatoon, SREDA, and Saskatchewan Economic and Co-operative Development have agreed to split the costs of the \$45,000 budget. Funds for the City of Saskatoon's portion will be allocated from the Communications Branch. Other members of the larger committee will be approached to become financial partners in the process.

It is anticipated that the consultant's report will be completed by this fall.

A1) Enquiry - Councillor O. Fortosky (March 19, 2001) Audit of Leisure Services Advisory Board (File No. CK. 175-4)

- Minutes of meeting of the Leisure Services Advisory Board of June 18, 1998 (Attachment B); and
- Report of the Leisure Services Advisory Board dated September 24, 1998, responding to the letter (Attachment C).

As a result of the review, City Council at its meeting held on November 16, 1998 adopted the recommendations set out in Clause 2, Report No. 14-1998 of the Executive Committee, a copy of which is attached (Attachment D). This information was forwarded to all advisory committees on November 20, 1998.

One of the recommendations adopted by City Council was that the mandates of advisory committees be reviewed every two years by the appropriate Standing Committee. There has been no change to the mandate of the Leisure Services Advisory Board since adoption of the report. This is because the review of the mandate by the Board was put on hold pending the results of City Council's review of the proposed "Social Policy Development Model" which is still before the Executive Committee. If Council does make the changes outlined in the model, there will be implications on several advisory committees, including the Leisure Services Advisory Board.
