# 1. City of Saskatoon - 2002 Operating Budget (File No. CK. 1905-5)

The City Clerk circulated copies of the following report of the General Manager, Corporate Services Department, dated April 30, 2002:

"On April 22, 2002, City Council adopted the recommendations of its Budget Committee with respect to the 2002 tax levy. In response to the budget resolutions for each taxing authority (including the attached letters from the School Boards), and the 2002 impact of the tax policy decisions previously approved by City Council, the Administration has determined the 2002 uniform mill rate for each taxing authority and the mill rate factors for each property class. A summary of the information is provided in the table below:

#### 2002 Phase-in Plan

At its special meetings held on February 12 and March 5, 2001, City Council resolved that the tax shift as a result of reassessment be phased in within property classes over four years. 2002 Tax Notices will reflect year 2 of this four-year phase-in.

#### 2002 BID Levies

City Council has received and referred the budgets submitted by all four Business Improvement Districts (BIDs) to the Administration to calculate the 2002 BID levies for inclusion with 2002 tax billing. The bylaws to establish the levies for each BID are attached for consideration. These bylaws will raise the necessary funds each BID has requested for 2002.
