Section E – UTILITY SERVICES

E1) Proposed Bylaw Amendment to the Electrical Rates Bylaw No. 2685 Effective January 1, 2006 (File No. 1905-6)

<u>RECOMMENDATION:</u> 1)

that the electrical rates charged in the City of Saskatoon distribution area be revised so that customers will pay the same as SaskPower customers;

	2)	that the revised rates be effective January 1, 2006; and
	3)	that City Council consider Bylaw No. 8474.

SaskPower will increase its retail rates effective January 1, 2006, based on the Provincial Government's decision to support the Saskatchewan Rate Review Panel recommendations.

The average impact of this year's increase on a residential customer will be 6.0% or approximately \$4.00 per month. The various commercial customers will see impacts ranging from 2.0% to 10.1%, with a 14.1% decrease for streetlights. The overall average increase for all customer classes is 4.7%. The bulk power rate charged to the City of Saskatoon will increase by 7.5%.

Historically, the City has set its rates for electricity sold within its franchise area so that customer bills would be the same as those paid by SaskPower customers. Failure to do this would result in inequities between similar customers served by the two utilities in Saskatoon.

The financial impact of these rate changes is being analyzed and will be included in the 2006 Operating Budget.

The Land Bank's current lot draw process does not allow some of our larger builders the opportunity to keep their trades people fully occupied on Saskatoon construction projects.

In order to allow Saskatoon to grow, we must address these impediments.

Would the Administration please report on the possibility and process required to sell by public tender, as a single purchase, a parcel of residential land, either serviced or unserviced, equivalent to approximately 100 single family lots.

Councillor T. Alm Property Tax Exemptions (File No. CK. 3500-13)

The City of Saskatoon is in the practice of providing property tax exemptions where they relate to Economic Development reasons.

These exemptions provide an incentive for a business or developer to invest in capital and create employment opportunities.

It is my understanding that these write-offs or rebates include the education portion of property tax.

Would the Administration please report on the possibility of providing a developer with a property tax exemption for up to a five-year period in exchange for a contribution to the City's infrastructure.

Councillor D. L. Birkmaier Impact of Increased Costs To Purchase Power from SaskPower (File No. CK. 1905-3)

Would the Administration please report the impact of the increased costs to the City of Saskatoon for the purchase of power from SaskPower.

What impact will this have on the mill rate?

Councillor D. L. Birkmaier Leisure Guide for Winter 2006 Use of Helmets (File No. CK. 366-1)

The recent Leisure Guide for Winter 2006 shows children on ice without helmets but identifies on the bottom of the brochure 'The City of Saskatoon recommends the use of helmets while skating.' Council recently supported a motion for the use of helmets. Who authorized this publication?
