- that the proposed plan for Phase III of the University Regional Retail Complex, as outlined on Attachment 3 of the report of the General Manager, Community Services Department dated November 5, 2007, be approved subject to the following conditions:
- a) the development conforming to all requirements of the Direct Control District 3 regulations;
- b) the review and approval by the Infrastructure Services Department of detailed site plans showing all necessary dimensions indicating the location and grades of access and egress points, intersections, turn bays, and driveways, with the overall site design grades matching the existing grades of Preston Avenue:
- c) the review and approval by the Infrastructure Services Department of design plans (stamped by a licensed engineering consultant) for all necessary water mains, sanitary and storm sewer mains, and lift stations, both on and off-site;

- j) all remaining commitments and conditions from the Phase I and II approvals that are outstanding be fulfilled to the satisfaction of the Infrastructure Services Department and Community Services Department; and
- that the General Manager, Community Services Department, be authorized to issue development permits which are in substantial conformance with the approved Phase III plan, subject to the conditions outlined in Recommendation 1) above.

REPORT

According to City of Saskatoon Policy No. C09-008 (Naming of Civic Property and Development Areas), all requests for adding names to the Names Master List must be screened by the Naming Advisory Committee and approved by City Council.

The Naming Advisory Committee has reviewed and screened the following names in accordance with City Council's naming guidelines and recommends to City Council that they be added to the Names Master List.

1. 'Funk' – Don and Doug Funk were actively involved with Softball from 1958-1992. It was their vision to develop Gordon Howe Park into the major softball complex that it is today. This paved the way for Saskatoon to host many provincial, national, world, and international championships, which resulted in millions of dollars brought into Saskatoon through sports tourism. Don and Doug Funk both received many appointments to various softball posts both Canadian and international. They received the Certificate of Merit in 1988 for their contribution to their community on the international stage. Don Funk was inducted into the Saskatoon and Saskatchewan Sports Hall of Fame as a Builder in 2004. Their business (The All-O-Matic Transmission) sponsored, organized, managed, and coached the Saskatoon All-O-Matic Softball Club. They were also involved with hockey, referees; curling,

sponsors/volunteers; Lacrosse, referees; Jeux Canada Games, 1989 volunteers; radio and television sports commentators.

- 2. 'Baltzan' Dr. David M. Baltzan, Dr. Marcel (Marc) Baltzan, Dr. Donald M. Baltzan, and Dr. Richard B. Baltzan. The Baltzan doctors have practiced medicine in Saskatoon continuously since the 1920's, the only medical family to make this claim. Dr. David M. Baltzan was the first internal medicine specialist in Saskatchewan and introduced electrocardiography to Saskatchewan and the first artificial kidney unit in Saskatoon. His sons, Dr. Marcel Baltzan, Dr. Donald Baltzan, and Dr. Richard Baltzan collaborated to introduce dialysis and begin a kidney transplant program in Saskatoon. The family is also active in the business community, Bessborough Hotel, and other real estate ventures. Two family members have received honourary doctorates from the University of Saskatchewan. Dr. David Baltzan was the recipient of an honorary Doctorate of Laws, May 12, 1969, and Dr. Marcel Baltzan was the recipient of an honorary Doctorate of Science, May 27, 2004.
- **'Mahabir'** Ramesh Mahabir was instrumental in securing a permanent location for the Saskatoon Farmers' Market. He owns and operates a market garden business, 'Better Herbs and Gardens', and has been a member of the Saskatoon Farmers' Market since 1990, president from 1999 to 2004. He has lectured at the University of Saskatchewan, in high school classes, and cooking classes on how to grow and use the food products that he grows and sells. He helped develop the City of Saskatoon's Food Charter and was awarded the Slow Food Award by the Slow Food Movement.
- 'Mackay' Craig Innis Mackay has been involved with speed skating for 62 years. 4. His awards comprise honorary lifetime membership in the Saskatoon Lions Speed Skating Club; Kinsmen Sportsman of the Year nomination, 1973; Saskatchewan Sports Hall of Fame inductee, 1973; Canadian Amateur Hall of Fame inductee, 1976; and Saskatoon Sports Hall of Fame inductee, 1987. His athletic accomplishments include the 1948 and 1952 Winter Olympics; 1950 World Championships; 1967 Canadian Winter Games; and 2004 Western Regional Championships in Moose Jaw establishing a provincial record. In addition to his athletic contributions, he worked for many years building and maintaining Saskatoon's Speed Skating Oval and donating time, money, and equipment to promote his sport and encourage young skaters. He worked with others to have Saskatoon host the Olympic Trials for Speed Skating in 1951 and 1955. He has also acted as President of the Saskatchewan Speed Skating Association, 1966-1968; official coach and Vice-President and Director of the Saskatoon Lions Speed Skating Club; Vice-President of the Canadian Speed Skating Association; and as a speed skating referee. In addition to his contributions through speed skating, his construction company, MacKay Construction, was involved in many projects in and around Saskatoon including several major overpasses and earth work for the Silverwood Golf Course and the Lakeview neighbourhood.

5. 'Romanow' - Roy John Romanow, Premier of Saskatchewan, 1991–2001; first elected to the Legislative Assembly of Saskatchewan, 1967; Deputy Premier of Saskatchewan, 1971-1982; leader of the Saskatchewan New Democratic Party, 1987-2001; worked with Prime Minister Chrétien on the 1981 discussions over patriation of the Canadian constitution resulting in the famous late-night Kitchen Accord; appointed to head the Royal Commission on the Future of Health Care in Canada, April 4, 2001; released the Romanow Report, which outlined suggestions to improve the health care system, 2002; sworn in as a member of the Queen's Privy Council for Canada, November 13, 2003; made an Officer of the Order of Canada, 2003; and awarded the Saskatchewan Order of Merit, 2003. Mr. Romanow's official portrait was unveiled at Saskatchewan's Legislative Assembly when he received the Commemorative Medal for the Centennial of Saskatchewan from Lieutenant Governor, Dr. Lynda Haverstock, 2005.

The Names Master List is kept in the Mayor's Office and contains all screened and approved name suggestions for naming municipally owned or controlled facilities, streets, suburban development areas, neighbourhoods, and parks. There are currently 195 entries on the Names Master List. The City Planning Branch will notify the applicants of the outcome of City Council's decision.

A3) Downtown Housing Incentives
The Rumley Distinctive Lofts Inc.
224 Pacific Avenue
File No.: PL. 4130-16; CK. 1965-1

RECOMMENDATION: that the information be received.

ADOPTED.

BACKGROUND

On May 18, 2007, The Rumley Distinctive Lofts Ltd. acquired the property at 224 Pacific Avenue known as "The Rumley Building". (See Attachment 1.) The building was constructed in 1912 for the M. Rumley Tractor Company which assembled and sold steam engines and other farm equipment from that location until the late 1950's. Since then, the building has had various uses and has recently been leased out as commercial and studio space to clubs, businesses, and individuals.

On August 2, 2006, The Rumley Distinctive Lofts Inc. applied for incentives under the City of Saskatoon Policy C09-032 (Downtown Housing Incentives). The proponent intends to convert the building into a residential loft condominium use.

During its October 9, 2007 meeting, City Council approved the recommendations of the Administration and Finance Committee to provide incentives to The Rumley Distinctive Lofts Inc. under the City of Saskatoon Policy C09-032 (Downtown Housing Incentive Policy). Approved incentives include: a tax rebate during construction, a five-year incremental tax abatement, and a rebate of 75 percent of applicable offsite levies and direct service charges.

REPORT

On November 1, 2007, The Rumley Distinctive Lofts Inc. advised the Administration that the nature of the project has changed slightly since the October 9, 2007 City Council meeting. Initially, the project was intended to include residential units on all five floors plus two additional penthouses for a total of 32 residential units. The project has since been revised to incorporate commercial space on the main floor, reducing the number of residential units by six for a total of 26 units.

The total investment for this project is estimated at \$8.7 million with \$1.5 million in building acquisition costs and \$7.2 million in construction costs. The changes have not significantly altered the expected total investment.

Based on the City of Saskatoon Policy C09-032 (Downtown Housing Incentive) and precedent cases, the tax rebate during construction, and the rebate of 75 percent of offsite and direct development charges are not affected by the revisions to this project. The presence of commercial space in the building does affect the five-year incremental tax abatement, however, since the abatement can only apply to the residential portion of an eligible project.

The incremental tax abatement for this project, approved prior to the revisions, was estimated to be \$117,600 per year for a five-year abatement value of \$588,000. The revisions require that space dedicated to commercial uses be factored out. This was done by applying a ratio of residential floor area over total floor area to the incentive amount. Based on this ratio, the estimated annual incremental tax abatement for the residential portion will be \$103,715.50, which is \$518,577.50 over the duration of the five-year abatement. Property taxes for the main floor commercial area will continue to be assessed and paid during the abatement period.

The Administration has reviewed the revisions proposed by The Rumley Distinctive Lofts Inc. and has determined that it remains eligible for the requested incentives under City of Saskatoon Policy C09-032 (Downtown Housing Incentives) as a residential conversion. The project still meets the intent of the policy, and as a mixed-use development, it will create a wider range of activity in the area.

FINANCIAL IMPACT

The revisions to this project have no impact on the Downtown Housing Reserve, the funding source for the Downtown Housing Incentives Program, because tax abatements represent foregone revenue. Based on the changes to The Rumley Distinctive Lofts, the City of Saskatoon will capture more tax revenue from the property during the abatement than it would have otherwise.

- 2) that the five-year tax abatement be effective in the next taxation year following completion of the project; and
- 3) that the City Solicitor be requested to prepare the necessary bylaw and agreement.

ADOPTED.

BACKGROUND

Station 20 West Development Corporation is in the process of purchasing the property at 230 Avenue L South (see Attachment 1) in the Pleasant Hill neighbourhood. The proponent intends to develop a Community Enterprise Centre on the site.

Station 20 West Development Corporation is a partnership between Quint Development Corporation and CHEP Good Food Inc. It is a social enterprise organization which was incorporated in 2005 to develop and operate the Community Enterprise Centre as a component of the larger Station 20 West development.

The City of Saskatoon has been involved in site preparation and cleanup to create the Station 20 West site. The City was aided in this process by the Urban Development Agreement (UDA) framework which involved the participation of three levels of government to share site cleanup costs. In addition to the Community Enterprise Centre, the Station 20 West Urban Renewal Project involves the creation of 55 housing units, office space, and a new branch library at 219 Avenue K South. The housing components have already received assistance from the Municipal Enterprise Zone.

On November 1, 2007, the Municipal Enterprise Zone Adjudication Committee considered an application from Station 20 West Development Corporation for assistance with construction of a Community Enterprise Centre and with costs tied to the closure of a portion of Avenue L. This closure is supported by the Infrastructure Services Department and will facilitate the development of additional parking adjacent to the site.

Upon completion of the project, the Community Enterprise Centre will accommodate a range of organizations and uses including medical and dental clinics, office space for several community organizations, and a grocery store. The total capital investment for this project is estimated at \$15,000,000.

REPORT

Station 20 West Development Corporation submitted its application for Municipal Enterprise Zone incentives through the City Planning Branch. A thorough review of the application was conducted and it has been determined that the project warrants consideration for incentives under the Municipal Enterprise Zone Program.

All required building and plumbing permit fees will be automatically rebated to the owner of the property upon completion of the project (estimated to be \$50,000). Based on the scale of this project, the significant costs involved, and the potentially large draw on the Enterprise Zone funds, the Adjudication Committee decided to approve cash incentives for an amount less than the full eligible amount. The Committee approved a rebate of the full amount of charges associated with the closure of Avenue L, as well as ten percent of the land cost. This amounts to a Committee-approved incentive of \$14,402.24 for land assembly. The total value of automatic and Committee-approved incentives is estimated at \$64,402.24.

A five-year property tax abatement is also being requested. The total value of the tax abatement is estimated to be \$456,255 over five years. The abatement is applied to the incremental tax increase only and is foregone revenue. City Council approval is required for all tax abatements. The Adjudication Committee is recommending that City Council grant the five-year property tax abatement commencing in the next taxation year after completion of the project.

The Adjudication Committee considered the merits and value of the development to the Municipal Enterprise Zone. The Adjudication Committee agrees with the City Planning Branch report and recommendation that the project is a valuable development for Pleasant Hill and the core neighbourhoods in general. It will bring many needed community services into the area and constitutes an important component of the larger Station 20 West development. This project meets the purpose of the Enterprise Zone, and is expected to have a significant impact on the core and the City of a Saskatoon as a whole.

FINANCIAL IMPACT

The above application was considered by the Enterprise Zone Committee on November 1, 2007. As of November 14, 2007, there is approximately \$312,000 remaining in the Municipal Enterprise Zone account. The above application totals \$64.402.24 in cash incentives and is within the means of the Municipal Enterprise Zone Program.

REPORT

As reported in the previous update to Council, there remain a number of issues that challenge the timely and efficient construction and opening of various projects in River Landing. The original budgets for River Landing were established in 2004 and, as with all capital projects in western Canada, the hot economy continues to raise construction costs to the point where accurate estimates are extremely difficult. Likewise, the shortage of contractors and sub-trades remains a challenge. Finally, environmental and regulatory approvals have proven to be slower and more difficult than anticipated. Much effort to mitigate these concerns have been undertaken including contractor open houses and value engineering exercises, and the overall project continues to progress.

The same hot economy also bodes well as a source for additional revenue to fund the increase in capital costs. The following report provides an update on design, construction, and budget estimates.

Phase I

Riverfront

The riverfront on Phase I is being managed by the Meewasin Valley Authority. The \$13.5M project is being funded by the provincial and federal governments, the City of Saskatoon, the Meewasin Valley Authority, and through various sponsors. In 2007, another portion of the riverfront was opened and turned over to the city for maintenance and operations. This new area is bounded by the riverwalk, the 3rd Avenue entry, the Spadina promenade and the east stairway at 2nd Avenue. Amenities within the area include the amphitheater, the barrier-free pathway, and site furnishings. Current construction work is focused on the river basin feature and the pavilion building. Both areas are scheduled to be completed before year-end.

The pavilion contains tenant space for concessions plus storage and washrooms that will be operated by the City. The City has prepared a draft Request for Proposals for the lease of the pavilion, and intends to issue it this winter.

The boat dock will be re-evaluated this fall. The review will critically evaluate the design requirements and construction options for cost effectiveness. The goal is to have a functioning dock in place in 2008.

Following the completion of Phase I, the following projects from the original riverfront design will remain outstanding and unfunded:

- river fountains;
- river garden and river garden access;
- river tributary and backshore linkage; and,
- natural gas fire pit and seating.

Urban Village - Parcel "Y"

At its September 17, 2007 meeting, City Council directed Administration to negotiate an agreement with Lake Placid Developments Inc. for the sale of Parcel "Y" River Landing Phase I and the development of an "Urban Village". The development includes new residential housing, a restaurant, retail, a boutique hotel, office space, and a plaza.

Administration has met with officials from Lake Placid on several occasions and discussions are progressing. The sale agreement will include the \$4.765M sale price and provisions to ensure timely construction of the development in accordance with the proposal. The final proposal and design will be subject to a separate regulatory approval process by both the City of Saskatoon and the Meewasin Valley Authority.

Ambient Lighting, Architectural Features, Public Art

The approved capital budget from River Landing Phase I included \$1.8M for the development of ambient lighting, architectural features, and outdoor public art that were partially identified in the South Downtown Concept Plan.

To date, projects completed, underway, or in the design stages include Prairie Wind, the former Gathercole Arches, the Traffic Bridge lighting and special events project, the Chief Whitecap/John Lake sculpture, and the installation of public art pieces such as "Launch Time" and "Cut Out of Time" on the riverfront walkway.

One project that the City is currently investigating, for inclusion within this budget, is the preservation and display of the anchor recently discovered in the South Saskatchewan River. An archaeologist engaged to study the find has indicated that the anchor is likely from the ill-fated S.S. Medicine Hat paddle wheeler. A further study on possible options to display and interpret the anchor is underway and may lead to its inclusion within the riverfront on Phase I.

Destination Site

Persephone Theatre is well under construction and is planning to hold their opening show this December. Administration is currently working on a process, for City Council's review and approval, to determine the best course of action with respect to the future destination complex on the remaining site to the south and north of the Persephone Theatre building. Meanwhile, the site is being graded and prepared for temporary surface parking for the public and theatre patrons.

Streets and Streetscape

With the exception of the north sidewalk and amenities, the extension of Spadina Crescent from 3rd Avenue to the Century Plaza roundabout was completed in 2006. Sidewalks, roll curbs, street pavers, trees and tree grates, streetscape furniture, and lighting has also been completed on the south side in this area. The extension of 2nd Avenue south to the Prairie Wind roundabout is currently under construction and will be completed in time for Persephone Theatre's opening. The reconstruction of Saunders Place will begin in spring of 2008. A temporary roadway surface will be applied to allow for access to Clinkskill Manor, the Persephone loading docks, and the temporary surface parking lot.

Commercial Development (Future Feature Building)

This winter, the City will begin developing the Request for Proposals for the "Feature Building" site which was an important element of the Master Plan developed for the River Landing Phase I Riverfront.

The building component was included "to provide the major site identity structure as well as commercial opportunity (proposed restaurant) with extended hours of operation to provide a focus for activities, and to provide income for riverfront development and management." The report identified the feature building as a high development priority.

The site was designed to support a three-storey building including two stories of restaurant. The bottom floor (level with the riverwalk) is located within the 500-year flood zone; therefore, no permanent fixtures are allowed. However, the lower floor could accommodate space for programming, storage, or a "tourism" oriented operator which could include river tours and rentals.

It is proposed that the City issue a Request for Proposals from qualified developers for the long-term lease of the site and subsequent development.

Phase II

19th Street Reconfiguration, Pathways, and Parking

At the meeting of August 13, 2007, City Council approved a recommendation to re-tender the 19th Street reconfiguration, pathways, and parking project after the City received only one bid 60% higher than the estimate. Administration, officials from Stantec Consulting Ltd., and KDL Consulting (an independent construction cost estimator) reviewed the design for any potential savings.

One of the designs reviewed related to the retaining wall required to construct the roadway and pedestrian walkway from 20th Street to 19th Street, immediately adjacent to the Toys R Us parking lot. Consultants have determined that, with the purchase of a small amount of land from the Toys R Us parking lot, the height of the retaining wall can be significantly reduced providing for a safer and more aesthetic walkway while reducing costs.

Work currently underway on 19th Street and area involves replacing and relocating underground utilities including water, sewer, power, and gas. This work should be complete by the end of November, with 19th Street temporarily re-opening to limited traffic. There will be a height restriction under the 1st Avenue bridge until the ramp is removed. This would allow for most vehicle traffic except for large trucks and city buses.

Pending a successful bid, construction is scheduled to begin in spring 2008. Residents, businesses, and motorists in the area should be well aware that this will cause a number of significant and prolonged traffic and pedestrian detours over the next year. 19th Street will again be closed for most of the year, and access on and off the Senator Sid Buckwold Bridge will be interrupted.

Riverfront

Construction of riverfront Phase II is well underway. This \$8.3M contract will continue into 2008 and includes establishing and armoring the shoreline and the construction of shorewalls, the pedestrian bridge, retaining walls, earthworks, site services, pathways, lighting, and site furnishings. The goal is to have a safe and functional riverwalk from Phase I through Phase II, and into Victoria Park by the end of 2008 or spring 2009.

The original design of the pedestrian bridge incorporated the remnant intake structures from the former A.L. Cole Power Plant as part of the interpretive plan and history of the area. The Navigable Waters Protection permit to build the pedestrian bridge included an unexpected requirement to remove these structures. The intake structure that is furthest into the river channel is immediately adjacent to the ageing sanitary sewer that crosses under the river. Administration continues to explore options and costs in consultation with Navigable Waters for those structures.

The balance of work on the River Landing Phase II riverfront following Contract 1 includes:

- play and activity areas;
- backshore links to River Landing Phase II;
- pumphouse adaptive re-use;
- small dock; and,
- a portion of soft landscaping, site furnishings, and lighting.

As previously reported, it is anticipated that the cost of this portion of the work will bring the total cost of the riverfront Phase II to the same level as Phase I at \$13.5M.

Isinger Park

Led by the Parks Branch, the tender for the construction of Isinger Park and electrical substation mitigation was issued and awarded in 2007. The lowest tender came in higher than the estimate. Following a design review, a number of elements were redesigned or eliminated to bring the project within the \$2.5M budget. Due to scheduling conflicts, a small amount of construction has started this year (piling for new substation fencing) with the remainder of work scheduled for 2008.

Streetscape – Avenues A, B, and C between 19th and 20th Streets

To revitalize the streetscape and serve as a transition between the Riversdale business district and the new River Landing development, the construction of new streetscape on Avenues A, B, and C between 19th and 20th Streets began in 2007. The project included irrigated planting and trees, sidewalk repair, street furniture, enhanced crosswalks across 19th Street, and improved pedestrian and street lighting.

The lowest tender received was above the estimate. Following a design review, a number of elements were redesigned or eliminated to bring the project to within the \$3.8M budget. Construction began in late spring. Avenues A, B, C and the north and south side of 19th Street between Avenues A and C are now complete. Due to the current construction of the underground infrastructure along 19th Street, the intersections of 19th Street and Avenues A and B will be completed next year.

Infrastructure (Underground Utilities)

Installation of electrical, water and sewer, telephone, fibre optics, and cable will be mostly completed in 2007. SaskEnergy will begin work in 2008.

Farmers' Market/Ideas Inc./Market Square

The adaptive reuse of the former electrical garage and offices into the new home for the Saskatoon Farmers' Market and Ideas Inc. business incubator is now complete. The Market Square was also completed with the official opening held in September.

The Saturday market has been very successful to-date. Because of the extensive construction activity around the block, access and parking remain a challenge. Administration continues to work with officials to accommodate parking on a temporary basis.

Soil Mitigation

Led by the Environmental Services Branch, the City engaged the services of Pinter and Associates to develop a remediation plan, generate tender documents, and supervise the contractor to bring soil standards from commercial/industrial to residential/parkland in certain parcels of land designated for development as residential or parks. This was largely completed in 2006 within the original \$1.2M budget.

Contrary to the assumption that the site was cleaned to commercial standards upon the decommissioning of the former A.L. Cole power plant, subsequent construction work around the new streets in Phase II have found certain pockets of soil above commercial criteria. This soil requires additional testing and remediation which has, so far, increased the cost of remediation to \$1.4M.

The funding includes a proposed contribution of \$3.206M to the Reserve for Capital Expenditures as a result of an anticipated surplus on Phase I due to increased revenues from the future sale of land on River Landing Phase I. This contribution would then be transferred to Phase II. As well, the funding includes an increase in the value of land sales in Phase II, a \$269,000 increase in cash contributions, and funding from the Urban Development Agreement for portions of the Ideas Inc. facility. Attached are the River Landing Phase I and II budgets (Attachments 1 and 2).

Your Committee is pleased with the outcome for this Program, and certainly appreciates the input received from the veterans themselves and the Downtown Business Improvement District.

Your Committee has reviewed this proposal with the Administration, and wishes to note that the proposal involves the installation of an 80-metre tower at the proposed site for a one-year assessment of actual wind conditions, at which time a comprehensive environmental assessment will be completed. A further report will be provided to City Council after that time. Your Committee is pleased that alternative energy sources are being explored, and fully supports this project.

5a) Proposed Revisions to University Heights Sector Plan (File No. CK. 4131-5)

REPORT OF THE CITY CLERK:

"The following is a report of the General Manager, Community Services Department dated October 26, 2007:

'RECOMMENDATION: that City Council approve the revised University Heights Sector Plan dated October 9, 2007.

PROPOSAL

The City Planning Branch of the Community Services Department has completed a revised Sector Plan for the University Heights Suburban Development Area. The University Heights Sector Plan will guide long-term development in the northeast of Saskatoon out to the proposed perimeter highway alignment.

REASON FOR PROPOSAL

The City's Development Plan requires sector plans to be approved by City Council prior to putting the sector plan into effect. The revised Sector Plan has been drafted in response to the following issues:

- new proposed perimeter highway alignment;
- new development guidelines for the Northeast Swale;
- buffers and constraints Wanuskewin Heritage Park, Wastewater Treatment Plant and existing chemical plants;
- servicing limitations for Neighbourhood 4;
- recognition of Historic Moose Woods/Batoche Trail;
- Agriculture Canada lands;
- District Village Commercial Areas;
- separation from SuperDARN Radar Station; and
- Meewasin Valley Authority jurisdiction.

BACKGROUND INFORMATION

The current University Heights Sector Plan was adopted on May 10, 1993.

The University Heights Sector Plan is intended to provide a blueprint for future subdivision and phasing of urban growth and guide the extension of trunk systems. Sector plans serve as a development framework based on the City's Development Plan. City of Saskatoon services are planned, new neighbourhood concept plans are developed, and land use designations and rezoning applications are evaluated based on the framework provided by sector plans.

REPORT

The boundaries of the University Heights Sector Plan are the proposed perimeter highway to the north, University lands to the east, existing neighbourhoods of Silverspring and Willowgrove to the south, and the South Saskatchewan River to the west.

The proposed University Heights Sector Plan will add four additional residential neighbourhoods to the existing University Heights Sector. Also added will be significant natural areas, an employment area, parks/recreational areas, and major transportation corridors serving the sector.

POLICY IMPLICATIONS

The preparation of the University Heights Sector Plan has been undertaken in accordance with the land development policies outlined in the City's Development Plan. City Council approval of the Sector Plan is required prior to drafting neighbourhood concept plans and undertaking design work for roadway and infrastructure provision.

FINANCIAL IMPACT

The proposed University Heights Sector Plan is expected to have a neutral effect on off-site servicing rates. The total amount of off-site services required to complete the area is estimated at \$96 million.

COMMUNICATION PLAN

Sector plans are widely circulated and reviewed. The revised University Sector Plan has been presented to the following groups:

- property owners;
- Technical Planning Commission;

- Public Open House;
- Municipal Planning Commission;
- Meewasin Valley Authority Development Review Committee and Board of Directors; and
- Rural Municipality of Corman Park

The Sector Plan will also be presented to the Administration and Finance Committee prior to being presented to Council.

An Open House to present the Sector Plan took place September 11, 2007 at the Alice Turner Library in the University Heights Suburban Centre. In general, citizens were receptive to the proposed plan. Comments received in writing by those attending the open house expressed concerns related to the following:

- the location of Fedoruk Drive adjacent to Silverspring, rather than north of the Northeast Swale;
- development affecting wildlife (deer in particular) which move between the Saskatoon Natural Grasslands in Silverspring, and the riverbank;
- the proposal to designate the area surrounding the University of Saskatchewan Chemical Landfill as park space, rather than leaving it in its current state; and
- increased traffic, road noise, and increased congestion, particularly with respect to the intersection at Central Avenue and Attridge Drive.

The paragraphs below outline the City Planning Branch's response to the concerns noted above in the order they are listed.

The alignment of Fedoruk Drive was reviewed again in consultation with the Infrastructure Services Branch. Fedoruk Drive has been aligned along the south side of the Northeast Swale to serve Neighbourhood 1 and intersect McOrmond Road. Moving the alignment of Fedoruk Drive to Agra Road and having it cross the Northeast Swale to serve Neighbourhood 1 is not desirable. There are no approved swale crossing locations in the vicinity, and the impact of an arterial road crossing in this location would be detrimental to the preservation and function of the Northeast Swale.

Development in the University Heights Sector will likely have some impact on the current movement of wildlife in the area. It is expected that as development within the sector takes place, primary wildlife movement will occur within the boundaries of the Northeast Swale between the riverbank and the uplands. In order to accommodate the movement of wildlife, a grade separated crossing will likely be needed at Central Avenue where it crosses the Northeast Swale.

The area surrounding the University of Saskatchewan Chemical Landfill has been labelled as District Park on the Sector Plan. This area has been labelled non-dedicated buffer in the past. It is the City Planning Branch's view that this area is suitable for recreational use, whether in passive or active form. Further discussion regarding the use of this land will be undertaken with the Leisure Services Branch and the public to determine an appropriate use for these lands.

The Infrastructure Services Department will address general traffic congestion and noise issues as the sector develops.

OPTIONS

- 1. City Council may approve the proposed University Heights Sector Plan. (Recommended.)
- 2. City Council may decline approval of the proposed University Heights Sector Plan. Development in the sector must then conform to the current 1993 Sector Plan. The current sector plan does not reflect the perimeter highway alignment or the environmental work that has defined the core area of the Northeast Swale. If a sector Plan that reflects these facilities and resources is delayed, it may delay the development of Neighbourhood 1. The timely development of Neighbourhood 1 is important because the Willowgrove neighbourhood is now expected to be built out by the end of 2008.

REPORT

The Purchase of Goods, Services and Work Policy currently contains a brief definition on sole source procurement. As a result of a recent policy review, it was determined that the definition of sole source procurement requires clarification that will more clearly define the circumstances where sole source procurement is permitted. It is recommended that the following be added to the policy to serve as a guide when considering sole source situations:

- When the selection of a single vendor is necessary due to the vendor's proprietary rights;
- When supply is available from only one vendor due to the compatibility with existing equipment or services that have been established as a standard with the City;

- For the extension of work with the contractors/supplies on an existing project site where it is considered to be more economical, efficient and expedient than soliciting competitive tenders;
- In an emergency that has created an immediate and serious need which could risk the health or safety of any person or threaten public or private property and environment or adversely affect the operation of the City;
- For the supply of goods or equipment for trial use and for used or demonstration goods or equipment;
- Subject to the approval of the City Manager, for supply of goods, equipment or services where there is a fluctuating price or shortage of availability and a delay in securing pricing or supply could adversely affect the interest of the City;
- Any other circumstance where, in the opinion of the City Council, it is appropriate for the City to sole source the purchase.

The second revision that is proposed would include a new section regarding Disclosure of Information in City of Saskatoon contracts. This disclosure includes providing pricing information relating to the successful bidder, however, does not include the divulging of names or numbers of bidders prior to the closing of tenders or bids, except when it is deemed to be in the best interest of the City. In addition, requests for proposals will not be opened publicly, however, at the time of the contract award, the evaluation results of the successful proposal will be disclosed. Details will only be released if permission of the bidder is obtained in accordance with *The Local Authority Freedom of Information and Protection of Privacy Act*. This information currently exists in the administrative policy on Corporate Purchasing Procedure A02-027 and it is recommended that the information be inserted in the Council policy.

4. Financial Surplus – Saskatoon Citizens' Centennial Committee (File No. CK. 225-68)

RECOMMENDATION:

- that the "Saskatoon Citizens' Centennial Endowment Fund" be created with the Saskatoon Community Foundation, incorporating the criteria contained in the report of the General Manager, Corporate Services Department dated November 16, 2007; and
- 2) that the financial surplus of \$64,684 be donated to this fund.

Your Committee has considered and supports the following report of the General Manager, Corporate Services Department dated November 16, 2007:

"BACKGROUND

The Saskatoon Citizens' Centennial Committee was formed to organize and deliver events to celebrate the Saskatoon's Centennial year in 2006.

At its meeting on April 16, 2007, City Council received the final report of the Committee, at which time a surplus was forecast but not finalized. The Committee recommended to Council that the surplus be set up as an endowment fund with the Saskatoon Community Foundation or another agency, and the proceeds used to support organizations and events to ensure their events are accessible and inclusive, and that City Council develop a list of criteria for accessing these funds. Council resolved that the matter of disposition of the financial surplus be referred to the Administration for a report to the Executive Committee.

REPORT

At the time the final report of the Committee was tabled, the surplus figure was not finalized. Since that time, a surplus of \$64,684 has been confirmed.

The Administration has reviewed the Committee's request and has confirmed with the Saskatoon Community Foundation that an endowment fund will leave a lasting legacy of the Saskatoon Centennial. Your Administration recommends that the Foundation administer the fund and the disbursement of grants based on criteria established to meet the objectives of the Committee. In working with the Committee Chair, Darlene Bessey, criteria have been established for organizations to access grants that would be created from the income of the fund.

The purpose of the fund is to create a legacy from the Saskatoon Centennial year ensuring that community based organizations are able to offer special events that are accessible and inclusive in keeping with the values of the Saskatoon Centennial Committee and the events held throughout the Centennial year. Criteria for accessing the fund include the following:

- Eligible organizations must be community based with a volunteer board of directors;
- Eligible organizations do not need to have charitable or non-profit status (making this a requirement will restrict access by a number of grass roots organizations) however, the event must be community focused;
- Access to the funds will be by application with two granting periods each year and with the total earnings from the fund allocated each year;
- Applications to be adjudicated by the Saskatoon Community Foundation;
- The applicant organization must demonstrate how use of the funds would enable it to increase accessibility to a special event:

Examples: Provide transit services at no or minimal cost;

Food items available at no or minimal cost;

Build a wheelchair ramp or boardwalk at an event with difficult

physical access;

Provide subsidized registration for a conference or training event."

The Committee believes that another year of working through the concerns identified will be well worth the effort, and therefore supports the extension of the contract for one year after which time the Administration will report back on the outcome.
