# **BACKGROUND**

During the April 16, 2007 meeting of City Council, Councillor Lorje made the following enquiry:

"Will the Administration please report on the matter of signs for community associations? Currently, they are allowed, on an ad hoc basis, to place signs on city property such as parks and boulevards for a short duration in order to advertise community events. However, some community associations want to be able to advertise things such as church services, child care spaces, etc. They are also concerned that they do not in fact have permanent signage locations.

Could the Community Services Department please report on the possibility of a policy and a program to develop up to two permanent sign locations in neighbourhoods to be used by the local community associations?"

#### **REPORT**

Of the 43 community associations in Saskatoon, 19 have access to at least one permanent sign in their neighbourhood for the purpose of promoting community events. Several other associations are currently considering some form of permanent signage. Of the existing 19 signs, 16 are located on either Catholic or Public School Board property. These signs were initiated and subsequently funded by the community associations in partnership with a local school. In most cases ownership resides with either of the School Boards, an arrangement that benefits the community associations in that it relieves them from having to administer and maintain the signs. While the size and style of these signs vary, installed costs range from \$5,000 to \$11,000.

For those associations without access to permanent signs, the Zoning Bylaw No. 7800 does provide for portable signs, subject to guidelines set out in the Sign Regulations, most notably that portable signs cannot be located on residential sites, cannot remain on one site for longer than 90 days, must not advertise a commercial product, and permission of the property owner is required. Community associations that use portable signs typically do so one to four times each year. These signs are almost always located on school property, although from time to time they do appear on church property.

In neighbourhoods without a school or a church willing to permit a sign, either temporary or permanent, on their property an application can be made to Infrastructure Services Department, Parks Branch, for consideration for placement in a park. Permission would, in part, be contingent on the signage adhering to the Zoning Bylaw No. 7800 and the Recreation Facilities and Parks Usage Bylaw No. 7767 that regulate sign size and advertising on public property. For permanent signs, Infrastructure Services Department, Parks Branch and Facilities Branch would also need to approve location, design and construction. In the case of a permanent sign, should permission be granted a community association could then apply to Community Development's Park Enhancement Program for funding for a portion of the capital cost of the sign. Lastly, an operating

agreement between the community association and the City of Saskatoon would then be developed to cover issues such as ownership, ongoing maintenance, and messaging.

In summary, almost half of Saskatoon's community associations already have access to permanent community information signs. For most of those who do not have information signs, the ability to do so does exist or at least the ability to rent and place temporary signs exists. Partnerships, in particular with the two School Boards, are seen as ideal in that capital and operating costs can be shared while at the same time ensuring better use of the signs. Finally, for the few associations who do not have access to a partner, such as a school, an application can be made to the City of Saskatoon to place such a sign on City park property.

#### **OPTIONS**

The Community Development Branch is recommending that community associations continue to partner with school boards and/or churches to arrange for permanent community signs. In the case of neighbourhoods where this is not possible, the City is willing to consider requests for permanent signs to be placed in City parks.

# **POLICY IMPLICATIONS**

The City of Saskatoon places restrictions on types of advertising in City parks through both the Zoning Bylaw No. 7800 and the Recreation Facilities and Parks Usage Bylaw No. 7767. Any community association granted permission to place a sign on City property would have to adhere to these conditions.

#### **FINANCIAL IMPACT**

Capital funding could be made available on a cost share basis to community associations, through Park Enhancement Reserve fund, for permanent signs on City of Saskatoon park property. Any associated operating impact would be the responsibility of the community association.

#### **REPORT**

On March 8, 2007, the street name plan for Stonebridge Neighbourhood was provided to the Naming Advisory Committee Administrator from the developer, Dundee Developments. (See Attachment 1.) The developer has selected six names from the Names Master List, which are indicated on the attached plan. The names selected comprise:

- 1) 'Stonebridge Common' and 'Stonebridge Green' Key neighbourhood streets that encircle Preston Avenue at the centre of the neighbourhood
- 2) 'Chubb Cove' B. Chubb City Councillor 1905;
- 3) 'Milne Crescent' W. A. Milne City Councillor 1966-1969;
- 4) 'Robertson Cove' Patrick Robertson City Councillor 1985-1991;
- 5) 'Cope Way', 'Cope Lane' and 'Cope Crescent' Ron Cope Served as a City Planner for 24 years; and
- 6) 'Wellman Crescent' and Wellman Lane' Herbert (Bert) Wellman Served as a City Planner and as Director of Planning and Development, 1970-1987.

According to City of Saskatoon Policy No. C09-008, (Naming of Civic Property and Development Areas), all requests for street names from the Names Master List will be selected by the Mayor. All of the names on the Names Master List have been previously screened by the Naming Advisory Committee and meet City Council's guidelines for name selection.

On March 9, 2007, His Worship, Mayor Don Atchison notified the Naming Advisory Committee Administrator that the street names had received approval. The decision of His Worship, Mayor Don Atchison was forwarded to Dundee Developments and the families have been notified.

According to City of Saskatoon Policy No. C09-008, (Naming of Civic Property and Development Areas), all requests for adding names to the Names Master List must be screened by the Naming Advisory Committee and approved by City Council.

The Naming Advisory Committee has reviewed and screened the following names in accordance with City Council's naming guidelines, and recommends to City Council that they be added to the Names Master List.

- 1) 'Terry Alm' Requested in honour of Terry Alm who was a member of City Council from 2003 to 2006.
- 2) 'Elaine Hnatyshyn' Requested in honour of Elaine Hnatyshyn who was a member of City Council from 2003 to 2006.
- 3) 'Donna L. Birkmaier' Requested in honour of Donna L. Birkmaier who was a member of City Council from 1976-79, 1982-88, 1991-2000, and 2003 2006.
- 4) 'Owen Fortosky' Requested in honour of Owen Fortosky who was a member of City Council from 2000 2006.
- 'Hartley' Requested in honour of Hartley Sommerfeld who is one of the Sommerfelds from whom Dundee Realty acquired land in Stonebridge. The Sommerfeld family has farmed lands in this general region for a few generations. There is currently a Sommerfeld Avenue, which is named after Paul Sommerfeld (grandfather), and Louise Street is named after Louise Sommerfeld (grandmother). Because the Sommerfeld name has already been used, Dundee Realty is requesting the use of the first name for use on collector streets in Stonebridge.
- 6) 'Victor' Requested in honour of Victor Sommerfeld who is the other Sommerfeld from whom Dundee Realty acquired land in Stonebridge. The Sommerfeld family has farmed lands in this general region for a few generations. There is currently a Sommerfeld Avenue, which is named after Paul Sommerfeld (grandfather), and Louise Street is named after Louise Sommerfeld (grandmother). Because the Sommerfeld name has already been used, Dundee Realty is requesting the use of the first name for use on collector streets in

Stonebridge. The street Dundee Realty would like to name Victor runs adjacent to the Victor Sommerfeld farmyard.

- 'Assaly' Requested in honour of Fred Assaly recognizing a Saskatoon family with a long history of involvement in the business community in Saskatoon. Mr. Assaly was a charter member of the Nutana Kiwanis Club and former President of the Saskatoon Club, as well as having served on several Boards.
- 8) 'Prairie Lily' Requested in honour of Saskatchewan's Provincial Flower.
- Canadian Navy from 1941 to 1963 where he attained the rank of Sub-Lieutenant. After World War Two, he enrolled in the University of Saskatchewan to become a teacher. Upon graduating in 1949, he began what was to be a distinguished career as an educator. By the time Mr. Keith had retired in 1982, he had gone from a teacher to Assistant Principal to Principal, as well as serving as President of the Saskatchewan Teachers' Federation and being appointed Assistant Superintendent of Personnel for the Saskatoon Public School Division. Mr. Keith also authored a Mathematics text book and sat on the Board of Directors for the Saskatchewan Council for Crippled Children and Adults, as well as the Canadian Rehabilitation Council for the Disabled. Mr. Keith also had a keen interest in preserving and protecting the South Saskatchewan River Valley.

Through this, he became instrumental in setting up the Meewasin Valley Authority for which he was appointed to the first Board of Directors. He later also served on the Board of Directors and was eventually President of the Saskatoon Prairieland Exhibition.

The Names Master List is kept in His Worship the Mayor's Office, and contains all screened and approved name suggestions for naming municipally owned or controlled facilities, streets, suburban development areas, neighbourhoods, and parks. There are currently 240 entries on the Names Master List.

The City Planning Branch will notify the applicants of the outcome of City Council's decision.

# **BACKGROUND**

In January of 2007, the City of Saskatoon entered into an agreement with Patrick Wolfe to purchase 29 individual properties in two phases. These properties are concentrated together between Avenues O and N South.

In May of 2007, the City of Saskatoon purchased the first phase of the Wolfe properties, however, the second phase of the purchase, which contains the properties fronting onto 20<sup>th</sup> Street West, are dependent on a successful purchase of three properties which Patrick Wolfe does not own. These properties are 1405, 1407 and 1415 20<sup>th</sup> Street West. The City of Saskatoon has until October of 2007 to enter into agreements to purchase these properties, under the sales agreement with Patrick Wolfe.

#### **REPORT**

The Community Services Department, Land Branch, has entered into negotiations with the owners of the three properties at 1405, 1407 and 1415 20<sup>th</sup> Street West.

The Land Branch has come to an agreement on a sale price for the properties at 1405 and 1415 20<sup>th</sup> Street West. (See Attachment 1.)

# 1405 20<sup>th</sup> Street West

An Offer to Purchase 1405 20<sup>th</sup> Street West has been signed by the City of Saskatoon's Property Agent with the following terms and conditions:

#### 1. Purchase Price

Purchase price is \$180,000 with full payment to be made on the Closing Date.

#### 2. Conditions Precedent

Approval of City Council by July 18, 2007, authorizing the purchase of the subject property.

#### 3. Other Terms

The Seller may remain in the property after the Closing Date as tenant at a lease rate of \$1 per month, property taxes included, until June 30, 2008. Throughout this period, the Seller will be responsible for all utility charges and maintenance of the property.

The Seller shall keep the lands in the present state of repair or better, up to the date of vacating the property.

The Seller can remove the following items upon vacating the property:

- a) personal property, and
- b) non-attached items.

Upon signing of the agreement, the City of Saskatoon shall have access to the land as required for purposes of soil sampling or other similar work provided such activities do not unduly interfere with the business activities of the Seller.

The City of Saskatoon is responsible for all survey subdivision, Environmental Reports and Information Services Corporation disbursements in respect to the registration of the transfer of title from the Seller to the Buyer save and except for the discharge of any encumbrances which is the responsibility of the Seller to discharge

#### 4. Closing Date

Closing Date of this transaction shall be August 1, 2007, or such other date as is agreed to in writing by both parties.

#### 5. Possession Date

Possession shall coincide with the Closing Date.

#### 6. Adjustments

Taxes and all other adjustments shall be made as of the Closing Date.

# 7. Legal Costs and Disbursements

Each party shall be responsible for its own legal costs.

# 1415 20<sup>th</sup> Street West

An Offer to Purchase 1415 20<sup>th</sup> Street West has been signed by the City of Saskatoon's Property Agent with the following terms and conditions:

## 1. Purchase Price

Purchase price is \$290,000 with a deposit of \$10,000 within 10 days of approval by City Council. The balance is to be paid on the Closing Date.

#### 2. Conditions Precedent

Approval of City Council by August 13, 2007, authorizing the purchase of the subject property.

#### 3. Other Terms

The Seller may remain in the property after the Closing Date as tenant at a lease rate of \$1 per month, property taxes included, until June 30, 2008. Throughout this period the Seller will be responsible for all utility charges and maintenance of the property.

The Seller shall keep the lands in the present state of repair or better, up to the date of vacating the property.

The Seller can remove the following items upon vacating the property:

- a) personal property,
- b) non-attached items,
- c) tanning beds,
- d) salon chairs, and
- e) salon displays.

Upon signing of the agreement, the City of Saskatoon shall have access to the land as required for purposes of soil sampling or other similar work provided such activities do not unduly interfere with the business activities of the Seller.

The City of Saskatoon is responsible for all surveys, subdivision, Environmental Reports and Information Services Corporation disbursements in respect to the registration of the transfer of title from the Seller to the Buyer save and except for the discharge of any encumbrances which is the responsibility of the Seller to discharge.

#### 4. Closing Date

Closing Date of this transaction shall be September 4, 2007, or such other date as is agreed to in writing by both parties.

#### 5. Possession Date

Possession shall coincide with the Closing Date.

#### 6. Adjustments

Taxes and all other adjustments shall be made as of the Closing Date.

# 7. <u>Legal Costs and Disbursements</u>

Each party shall be responsible for its own legal costs.

With the purchase of 1405 and 1415  $20^{th}$  Street West, plus the Wolfe properties, the Community Services Department believes that a redevelopment could proceed in substantial conformance with the approved Pleasant Hill Concept Plan (See Attachment 2) without the property at 1407  $20^{th}$  Street West. The Land Branch will continue to negotiate for the purchase of 1407  $20^{th}$  Street West and report back to City Council in due course.

#### **OPTIONS**

- 1. Purchase the properties at 1405 and 1415 20<sup>th</sup> Street West. This recommended option will allow the substantial redevelopment of this block in accordance with the Pleasant Hill Revitalization Concept Plan.
- 2. Decline to purchase these properties. Should City Council decide not to proceed with these purchases, the City of Saskatoon would not purchase the balance of the Wolfe properties and the existing uses would remain along 20<sup>th</sup> Street West. The Administration does not recommend this option. The Pleasant Hill Revitalization Concept Plan envisages a high density mixed use development on this site. Such a use would add considerable value to the revitalization effort by creating a new development on 20<sup>th</sup> Street West and add much needed new housing stock to the area.

#### **POLICY IMPLICATIONS**

There are no policy implications.

# **FINANCIAL IMPACT**

The City of Saskatoon has secured funding for the Pleasant Hill Revitalization Project through an Urban Development Agreement. The agreement stipulates that funding will be provided for Land Branch costs which include:

- a) Patrick Wolfe's property;
- b) Other Properties along 20<sup>th</sup> Street;
- c) Demolition Costs;
- d) Rezoning;
- e) Subdivision; and
- f) Other fees.

Total estimated Land Branch costs were \$2,005,012. An appraised value of \$220,000 was obtained in 2003 for the properties along 20<sup>th</sup> Street West. Since that time, property values have risen dramatically. In negotiations with the property owners of 1405 and 1415 20<sup>th</sup> Street West, it was recognized that the current owners will be searching for new property within Saskatoon in a hot real estate market. Added to this, is an inconvenience factor associated with moving. In the case of the owner at 1415 20<sup>th</sup> Street West, this is currently a hair and tanning salon with an established clientele from the area. Relocation of such a business can be difficult and it may suffer business loss if alternative space cannot be found within the area.

It is the opinion of the Land Branch that the values and terms of the sale, which have been agreed to, are fair and reasonable in today's real estate market and in consideration of the current high cost of securing an alternate property.

It should also be noted that the purchase of the Patrick Wolfe properties along 20<sup>th</sup> Street West is conditional upon the successful purchase of 1405, 1407 and 1415 20<sup>th</sup> Street West. The value of the Wolfe Properties has been locked in at 2003 appraisal values.

# <u>Section B – CORPORATE SERVICES</u>

B1) Benchmarking the Competitiveness of Canada's CMAs (File No. 430-1; CK. 3500-1)

**RECOMMENDATION:** that the City of Saskatoon participate in the Conference Board of

Canada's Benchmarking Initiative through a contribution of \$5,000

from the general government budget.

ADOPTED.

The Conference Board of Canada is interested in developing a new annual publication, using inhouse benchmarking expertise, that will analyze the competitiveness of Canada's 27 census metropolitan areas (CMAs). This initiative will analyze and benchmark the features that make Canadian cities attractive to highly-skilled works and business investment. The benchmarking exercise will focus on six categories: the economy; innovation; environment; education and skills; health; and society. The categories are drawn from the Conference Board of Canada's soon-to-be published *How Canada Performs* that benchmarks the nation's performance against that of other countries. Approximately 40 indicators will be developed. Canada's 27 CMAs will be ranked and graded. Twenty-seven U.S. cities will also be benchmarked in order to produce a second ranking of 54 North American cities.

Both the Proposal and Backgrounder to this initiative are attached. The Proposal outlines the rationale, focusing on the relationship between quality of life and attracting talented workers and immigrants. The Backgrounder provides additional details including the proposed indicators.

The City of Saskatoon has been asked to participate in funding this initiative through a contribution of \$5,000. Your Administration is already involved in a number of benchmarking initiatives, including The Federation of Canadian Municipalities Quality of Life Reporting System. As indicated in both the Proposal and Backgrounder, The Conference Board of Canada is aware of this initiative, but feels their product is unique by offering a more comprehensive analysis.

Your Administration feels the information resulting from this benchmarking initiative will be of value to the City of Saskatoon from both a marketing and recruitment standpoint. In addition, the following cities have agreed to participate through funding: City of Vancouver, City of Surrey, City of Calgary, City of Toronto, City of Halifax. The City of St. John's and The Ontario Ministry of Municipal Affairs and Housing have both shown interest. # **BACKGROUND**

At its meeting held on January 8, 2007, City Council during consideration of the award of tender for overpass construction at the Clarence Avenue/Circle Drive interchange, resolved, in part:

- that City Council approve an increase of \$5.58 million to Capital Project 2018 Clarence Avenue/Circle Drive Interchange to a total of \$19.88 million;
- 2) that the Administration report prior to April 30, 2007 on the recommended source of funding.

In addition, the Administration agreed to report periodically, based on its report to City Council on March 13, 2006 on:

- the status of the build-out of the commercial development in Stonebridge;
- the status of the incremental tax revenues generated from the new development to be allocated to the unfunded capital costs of the project; and
- the status of the interchange levy to be allocated to the unfunded capital costs of the project.

# **REPORT**

Your Administration received confirmation from the Province of Saskatchewan that the City of Saskatoon will receive \$5,000,000 in capital funds to assist in the construction of the interchange at Clarence Avenue and Circle Drive. With this funding in place, we are now in a position to provide City Council with the total funding strategy as follows:

The following provides the status of the build-out of the commercial development area, as well as the funding from incremental property tax revenues and the interchange levy.

As of May 31, 2007, building permits have been issued for 30,105 square meters, or 55% of the commercial development, while construction is 28.5% completed. The construction portion is the Walmart retail outlet of 15,575 square meters.

In regards to the status of incremental property taxes generated from the new commercial development, \$47,902.92 was levied and transferred to capital project in 2006, while in 2007, this amount (as of May 31) was \$84,301.55, for a total of \$132,204.47. This amount is attributable only to the land assessment. The building portion of the tax levy will be processed as supplementary taxes within the next few weeks. At the time of this report, the amount of the building assessment was still unknown. It is expected that a total of \$5.6 million is required from incremental property taxes, as outlined in the funding plan.

The project also identified that \$2.954 million is required from the interchange levy, to be funded to the project at a rate of \$400,000 per year. While earth movement began in 2006, the construction phase of the interchange commenced in 2007, and thus the first allocation of the levy will be applied in the current year.

# **REPORT**

The following enquiry was made by Councillor Penner at the meeting of City Council held on October 16, 2006:

"Could I please have a report indicating what safety/traffic calming measures can be put in place on Cambridge Crescent, next to the park"

A report was submitted to City Council on December 4, 2006 (Attachment 1), advising that in order to proceed with traffic calming in the Cambridge area, Infrastructure Services would need to conduct a traffic study in the spring of 2007, and would report back to Council with the information and its recommendations.

#### **REPORT**

Cambridge Crescent is a local roadway with an expected traffic volume of between 1,000 to 3,000 vehicles per day and a posted speed limit of 50 km/hr. It is surrounded by residential housing and is adjacent to Glacier Park in the College Park neighbourhood.

A traffic volume and speed study was conducted in May of 2007 to determine the need for traffic calming devices. The speed study measures the 85<sup>th</sup> percentile speed (the speed at which 85 percent of the vehicles are travelling at or less than) and the traffic volume indicates the average daily traffic. The result of the study indicates that the average daily traffic (ADT) was 195 vehicles per day and the 85<sup>th</sup> percentile speed was 44.71 km/hr.

The five-year (2002-2006) collision report indicates that there was one collision, which was caused by icy road conditions. There were no injuries or fatalities reported.

Because the traffic volumes are well within the typical volumes for a local roadway, and the 85<sup>th</sup> percentile speed is below the posted speed limit, the Administration does not recommend traffic calming devices on Cambridge Crescent at this time.

D4) Enquiry – Councillor G. Wyant (November 6, 2006) Traffic Calming –Molloy Street (File No. 6320-1)

**RECOMMENDATION:** that the information be received.

# **BACKGROUND**

The following enquiry was made by Councillor Wyant at the meeting of City Council held on November 6, 2006:

"Would the Administration please report on the feasibility of installing traffic calming on Molloy Street. The residents have seen a steady increase in vehicles on this road travelling at increased speeds."

# **REPORT**

Molloy Street is classified as a local roadway that can typically be expected to carry traffic volumes of between 1,000 to 3,000 vehicles per day. It runs east and west, connecting Russell Road to Silverwood Road. Right-of-way is assigned by stop signs on Molloy Street at Russell Road and Silverwood Road. Traffic on all other intersecting streets must yield to Molloy Street.

Traffic volumes and speed studies were taken at two different locations along Molloy Street. Speed studies measure the 85<sup>th</sup> percentile speed (the speed at which 85 percent of the vehicles are travelling at or less than). The posted speed limit on this street is 50 km/hr. The traffic counts and speed results are indicated below.

# Molloy Street Traffic Volume and Speed Study Results Date of Study: May 11 – 17, 2007

It is ideally desirable to have the 85<sup>th</sup> percentile speed no more than 5 kilometres above the speed limit. As shown above, the measured speed of vehicles travelling along Molloy Street is within the acceptable guidelines.

The five year collision report (2002-2006) along Molloy Street between Russell Road and Silverwood Road indicates that there were four collisions, none of which involved pedestrians. There were no injuries or fatalities reported.

Because the traffic volumes are within the expected range of vehicles for a local roadway, and the 85<sup>th</sup> percentile speed is within the posted speed limit range, the Administration does not recommend traffic calming devices on Molloy Street at this time.

Traffic Calming – Broadbent Avenue

**RECOMMENDATION:** that the information be received.

# **BACKGROUND**

The following enquiry was made by Councillor Wyant at the meeting of City Council held on January 22, 2007:

"Would the Administration please report on the feasibility of installing traffic calming measures on Broadbent Avenue. The residents have seen a steady increase in vehicles on this road travelling at increased speeds. A small boy in a stroller was hit recently by a car that had lost control."

#### **REPORT**

Traffic calming is a way of reducing the adverse impact of motor vehicles by using physical measures. It encourages motorists to slow down, thereby reducing collisions; enhancing safety for pedestrians; and reducing short-cutting. Traffic calming is often used to reduce excessive speeding or excessive traffic volumes as a result of short-cutting.

Broadbent Avenue is a local roadway with an expected traffic volume of between 1,000 to 3,000 vehicles per day and a posted speed limit of 50 km/hr. It is surrounded by residential housing and runs north to south between Adilman Drive and Molloy Street.

A traffic volume and speed study was conducted in May of 2007 to determine the need for traffic calming devices. The speed study measures the 85<sup>th</sup> percentile speed (the speed at which 85 percent of the vehicles are travelling at or less than the speed limit) and the traffic volume indicates the average daily traffic. The result of the study indicated that the 85<sup>th</sup> percentile speed was 46.8 km/hr and the average daily traffic (ADT) was 265 vehicles per day.

The five-year (2002-2006) collision report indicates that there were two collisions. One occurred in 2004 involving a vehicle, and the other in 2006 involving a pedestrian.

Because the traffic volumes are within the typical volumes for local roadways, and the 85<sup>th</sup> percentile speed is below the posted speed limit, the Administration does not recommend traffic calming on this street at this time.

E1) Enquiry – Former Councillor T. Alm (May 23, 2006) Anti-Idling Programs and Exhaust Pollution (File No. CK. 7300-1)

**RECOMMENDATION:** that the information be received.

ADOPTED.

The following enquiry was made by former Councillor Alm at the meeting of City Council held on May 23, 2006:

"Would Administration please report on anti idling programs that are currently operating in other Canadian Municipalities. Would you also bring forward recommendations to implement a vehicle anti idling program to reduce exhaust pollution in Saskatoon. Perhaps we could also refer this item to the Environmental Advisory Committee for their consideration."

#### **REPORT**

There are currently several municipalities in Canada that have municipal bylaws that discourage or limit idling within the municipalities including Moncton, Hamilton, Welland, London, Windsor and Toronto. Several other city administrations across Canada have indicated that they are currently working on formal bylaws for their municipality.

Most cities have bylaws or "rules" that limit, discourage or penalize employees that unnecessarily idle vehicles. The cities of Regina, Thunder Bay, Winnipeg and Calgary have corporate policies that require employees to shut off and lock vehicles that are not occupied. Other municipalities currently follow The National Research Council's Fleetsmart Program "Idling Gets You Nowhere". The City of Saskatoon is working to develop a policy that will educate our employees and allow for compliance.

Passenger transportation is responsible for 18 per cent of Canada's total greenhouse gas emissions. In Saskatchewan 43 per cent of our personal emission comes from our vehicles. For every litre of gasoline used, the average car produces about 2.4 kilograms of carbon dioxide.

There are currently a number of Idle-Free of Anti-Idling policies in various branches of the City. The Administration is working to develop a corporate policy and ensure corporate compliance with this policy as part of our Energy and Greenhouse Gas Management Plan and our Environmental Management System. The Environmental Services Branch is also investigating Idle-Free policies and bylaws in other municipalities.

The Environmental Services Branch has been working with the Saskatoon Environmental Society on a Turn it Off – Be Idle Free campaign in two Saskatoon elementary students (Attachments 1 and 2). School zones have been targeted for several reasons including:

- Waiting for or picking someone up is the most common time for drivers to idle. This project will therefore target drivers who are picking up children from elementary schools at the end of the day.
- Children are susceptible to the negative effects of car exhaust because they are shorter and therefore closer to vehicle's tailpipes and they breathe faster than adults and inhale more air per kilogram of body weight.
- Reducing engine idling also improves visibility in school zones, especially in winter conditions.
- A campaign in Toronto found that more than a third of parents idle their vehicles while
  waiting to pick up their children. A vehicle idling for 10 minutes a day uses more than 100
  litres of gasoline per year. By turning engines off at school sites, parents can be part of the
  solution.

In 2005, a "One Ton Truck Challenge" (Attachment 5) was developed in the southeast Horticultural Program (7-1 ton trucks). Although the challenge was not originally focused on anti-idling/mileage reduction the results in this area were impressive. The program was reviewed in October, and the results are as follows: an overall reduction of 3% in fuel consumption (approximate fuel savings of \$2,000) and a 12% reduction in kilometres traveled. The program was reviewed and an increased implementation plan was discussed for 2006. The program was expanded to the S.E. Turf District in 2006 - the mileage reduction averaged 10% from the base.

Saskatoon Transit initiated an Engine Idle Shut Down Program, which was in place from June 1 to September 30, 2004 (Attachment 3). The program was designed to ensure the passengers safety and comfort would not be compromised. Program data showed the following results

- Fuel usage was reduced by .90 litres per 100 kilometres travelled as compared to the previous year.
- A reduction of 4,396 litres used to travel the same distance.
- Damaging engine idle time was reduced by as much as 1,395.5 hours.
- No safety or passenger related complaints were reported.
- Green House Gas (CO2) reduction of 11, 869.2 kilograms or 11.87 metric tones
- It was determined that implementation could save as much as \$8,797.00 in 2005.

The proposed stages for Idle-Free implementation include:

- ensuring corporate compliance and demonstrating leadership within the corporation;
- public education;
- implementation and enforcement of Idle-Free bylaw and programs in school zones; and
- adoption and enforcement of a community bylaw.

The Administration is developing a "Vehicle and Equipment Idle Minimization Policy" that will be rolled out within the Corporation. Public education will continue through community partnerships and the City's Communication Branch. Each additional step listed above would be presented to Executive Committee for discussion prior to implementation.

Saskatoon Transit during the summer of 2007.

# **REPORT**

Saskatoon Transit is seeking approval for the following promotional events to occur over the summer of 2007.

- **1. Fringe Festival,** August 2 -11 ("Buttons on the Bus" promotion) As a trial project, Saskatoon Transit, in partnership with the Fringe Festival, will allow patrons of this event to board any regular service Transit bus simply by displaying a "Fringe 2007" button. This promotion will be in effect at various times throughout the event in coordination with available Transit service:
  - 6:00 p.m. until 1:00 a.m. on August 2, 3, 7, 8, 9, and 10
  - 12:00 noon until 1:00 a.m. on August 4 and 11
  - 12:00 noon until 10:00 p.m. on August 6 and 7.

Parking and traffic congestion in the Nutana area have been long-standing complaints of area residents during the Fringe Festival. This proposed trial project will provide Fringe patrons with an alternative transportation mode which should help alleviate some of the parking and traffic concerns. Ridership counts will be taken to determine the level of usage.

2. Cruise Weekend is another highly successful event that takes place in the downtown area each summer. Upwards of 40,000 people converge on the downtown to look at the various automobiles on display on the Sunday of Cruise Weekend. Parking and traffic as a result of this event has been a concern; therefore, Saskatoon Transit, in partnership with Rawlco Radio, is proposing to offer free service on Sunday, August 26 to again offer citizens an alternative transportation mode to attend this great event. This too will be a trial project, with ridership counts taken to gauge its success.

**3. Folkfest,** August 16, 17 and 18 - Service will remain as last year with three routes servicing 16 pavilions with park and ride locations at Centre Mall, Market Mall, and Lawson Mall Terminals. Patrons may also board any regular service Transit bus simply by showing their Folkfest passport as fare from 3:00 p.m. until 1:00 a.m. on Thursday and Friday, and from 11:00 a.m. until 1:00 a.m. on Saturday. Again, ridership counts will be taken to evaluate usage.

These three promotional services will help alleviate parking and traffic concerns throughout the city, as well as promote Saskatoon Transit as the best way to travel.

# FINANCIAL IMPACT

There is minimal cost involved for all three of the above promotions.

# Section B – OFFICE OF THE CITY SOLICITOR

B1) Enquiry - Councillor B. Dubois (December 4, 2006) Smoking Outside of Civic Buildings (File No. 185-3)

# that the recommendations of the City Manager, as outlined in this report, be adopted for buildings under the direct management of City Council and a formal policy be prepared; and 2) that all Boards be requested to adopt similar policies for their buildings, recognizing that there may be unique circumstances for individual buildings. ADOPTED.

Councillor Dubois made the following enquiry at the meeting of Council on December 4. 2006:

"Would the Administration please report on imposing a "No Smoking" policy directly outside (so many feet away from the building to be determined) civic buildings such as TCU Place, Credit Union Centre, City Hall, Mendel Art Gallery, Libraries, Police Station, etc."

On February 12, 2007, our Office wrote to the City Manager, the Saskatoon Board of Police Commissioners, the Saskatoon Public Library Board, and the Boards of the Mendel Art Gallery, TCU Place and Credit Union Centre. We asked that all of them respond regarding a potential smoking ban around all entrances to their buildings of a distance of 3-9 metres depending on circumstances.

Everyone has responded. Everyone is in favour of implementing (by policy) smoking bans around all of their building entrances. The majority proposed a distance of at least six metres.

The City Manager has recommended the following for civic facilities managed directly by City Council:

- 1. For main entrances to a civic building, providing sufficient room is available, a smoking ban distance of nine metres from the main entrance be established.
- 2. For secondary entrances with sufficient room, a smoking ban distance of six metres be established.
- 3. That non-obtrusive, but appropriate signage be used.

The City Manager had also recommended that the smoking area in the back of City Hall be moved to meet these guidelines.

From the responses received, most Boards are looking at a policy similar to the recommendations of the City Manager, recognizing that there may be physical circumstances where a ban of a shorter distance is all that is possible.

The following is a report of the Temporary Committee on Accessibility, dated June 6, 2007:

"The Committee has discussed the issues surrounding the establishment of an Accessibility Advisory Committee, and has concluded that a permanent Committee should be established for the following reasons:

- 1. The existing complaint-driven process for dealing with accessibility issues in the community is not working. This process is confrontational and does not get the required results.
- 2. There is a desire for the process to be proactive and not reactive.
- 3. There is a need to "champion action" rather than "provoking action".
- 4. There is also a need to better manage and coordinate a proactive action plan.
- 5. There was a consensus that ongoing engagement of stakeholders should be the foundation of a proactive action plan.

The Committee also received a draft of Terms of Reference (Mandate and Composition) from the community of common interest for people with disabilities. The Committee has made a few adjustments to the Terms of Reference to recognize that the City's mandate is towards improving accessibility to City of Saskatoon services, facilities and infrastructure.

Attached is a copy of the revised Terms of Reference (Mandate and Composition) which has resulted from this collaborative effort (Attachment 1). The Committee believes that the Terms of Reference reflect the goal of the community of common interest for people with disabilities, as well as the city.

The Temporary Committee on Accessibility wishes to provide for the appropriate public consultation and is therefore recommending that this take place prior to the July 16, 2007 meeting of City Council. Your Committee is also recommending that the Temporary Committee on Accessibility remain in place until the new committee is established on January 1, 2008 in order to move forward with development of an Action Plan, which is described under No. 1) of the Duties and Responsibilities in the attached Terms of Reference. This will provide continuity and ensure that steps are being taken to continue moving forward with the accessibility mandate."

Your Committee is pleased to support the above recommendations. Mr. Robin East, Chair of the Temporary Committee on Accessibility, has undertaken public consultations regarding the above recommendation and will be in attendance at this meeting to speak to the matter.

# **RECOMMENDATION:** that the information be received.

The following enquiry was made by former Councillor Hnatyshyn at the meeting of City Council held on October 16, 2006:

"Would the Administration please report on the health and safety issues related to outdoor fire pits."

The following enquiry was made by Councillor Dubois at the City Council meeting held on June 11, 2007:

"Would the Administration please report on the number and nature of complaints received by Saskatoon Fire and Protective Services regarding the use of backyard fire pits and also include the feasibility of requiring fire pits to be extinguished by 11:00 p.m. similar to the requirement of the current noise bylaw."

#### **BACKGROUND**

In the past, Saskatoon Fire and Protective Services (SFPS) responded to many complaints about people igniting fires in their back yards, either in fire pits, burning barrels, holes dug in the ground, outdoor brick fireplaces, metal fire boxes, wood burning hot tubs, or other similar devices and configurations. These back yard open fires were often used for social gatherings, general family outings, to keep bugs away, and a variety of other reasons. Until 1993, SFPS requested all fires that were not in approved barbecues be extinguished. If the party did not extinguish the fire, the Department extinguished it. Unfortunately, this often put SFPS in the position of expending resources to resolve neighbourhood disputes rather than investigating actual fire hazards. In 1993, the Department changed its approach and became more tolerant of backyard fires. If a property owner had the fire contained within a non-combustible container, if it was not a fire hazard, and if it was apparent that it was not bothering the neighbours, it was allowed to continue. On May 24, 1994, City Council passed a bylaw re-introducing fire pits which had been previously banned. The decision was made at the time because of public pressure on City Council.

Although outdoor fires are permitted within the City of Saskatoon, residents must use common sense to ensure the safety of our community and adhere to the following regulations:

- 1. Fires must be contained within a non-combustible appliance constructed of material such as cement, brick, or metal of at least 18 gauge, and covered with a heavy gauge metal screen with opening no larger than 13 mm.
- 2. The size of the fire box of any outdoor burning facility shall not exceed .61 cubic metres.
- 3. Only seasoned wood and charcoal are acceptable forms of fuel for outdoor fires (material such as rubbish, garden refuse, plastics and manure shall not be burned).
- 4. All fires shall be responsibly supervised at all times.
- 5. No person shall light an outdoor fire when the weather conditions are conducive to creating a running fire or allow the smoke from the fire to be a nuisance to another person. Where the smoke from an outdoor fire causes an unreasonable interference with the use and enjoyment of another person's property, the fire shall be extinguished immediately.

#### **REPORT**

The issue of outdoor fires has again become the subject of recent communications to Council. Although the popularity of backyard fires appears to be on the rise, SFPS has not seen a corresponding increase in the number of complaints about them. In 2006, the Department received 317 burning complaints compared to 112 up to June 15, 2007. It should be noted that these complaints include all types of illegal fires involving a person burning in their back yard (i.e. burning barrels, piles of leaves, fire pits, etc.). In researching information for this report, the writer checked with a number of retail outlets to determine the popularity of fire pits or patio fireplaces. The Canadian Tire Store at Preston Crossing sold just over 600 in 2006 and has sold just over 600 in the period May 1 to June 15, 2007. The Home Depot has sold just over 300 in the same time period in 2007. The use and enjoyment afforded by the approved use of fire pits and fireplaces is gaining in popularity as evidenced by the increase in sales of these items.

It has been suggested that possible amendments be considered such as minimum distances from various property features such as bedroom windows, doors, or even property lines. With the average size of lots in Saskatoon, minimum distances would be difficult to enforce. Also many properties have already installed legal fireplaces and fire pits in accordance with the Bylaw.

With respect to the feasibility of outdoor fires in approved containers or pits being extinguished by 11:00 p.m., once again this would be very difficult to enforce. Your Administration is of the opinion that as long as the requirements of the current bylaw are being followed, the time of day is irrelevant. As mentioned previously, in many cases the cause of a complaint is more often a dispute with neighbours or the noisy activities around the fire, not the actual fire itself.

With respect to health issues around outdoor burning, the Bylaw requires that where drifting smoke causes an unreasonable interference with the use of another person's property or a nuisance to another person, the fire shall be extinguished immediately. Your Administration does understand that this nuisance can result in health concerns for certain individuals.
