ADMINISTRATIVE REPORT NO. 3-2007

Section B – CORPORATE SERVICES

B1) Debenture Bylaw 8575 and TCU Place Loan Authorization Bylaw, 2007, No. 8576 (File No. 1750-1)

RECOMMENDATION:

- 1) that the offer of RBC Capital Markets Inc. and CIBC World Markets Inc. (City's fiscal agents) be accepted and that His Worship the Mayor and the City Clerk be authorized to execute same;
- 2) that City Council consider Debenture Bylaw No. 8575 which conforms to the terms and conditions of the sale, and specifically authorizes a \$9,645,000 one to fifteen-year serial debenture issue to be dated February 14, 2007;
- 3) that City Council consider TCU Place Loan Authorization Bylaw, 2007 No. 8576 which outlines the specific terms of principal and interest repayment for TCU Place's share of the debenture issue;
- 4) that the General Manager, Corporate Services Department, the City Solicitor, and the City Treasurer be instructed to take all such steps as may be necessary so as to give effect to the debenture issue and sale; and.

5) that the City Solicitor be instructed to prepare the appropriate loan agreement with TCU Place and that His Worship the Mayor and the City Clerk be authorized to execute same.

BACKGROUND

At its meeting held on December 18, 2006, City Council authorized the General Manager, Corporate Services Department, to accept the terms of a \$9,645,000 debenture sale from the City's fiscal agency, subject to the approval of the appropriate Debenture Bylaw. The total borrowing requirement was comprised of TCU Place's share of \$7,730,000 and the City's share of \$1,915,000. Proceeds of the debenture borrowing will be used to replenish specific civic reserves. In 2005 and 2006, civic reserves were used as a source of interim funding to finance construction of the TCU Place expansion. A substantial amount of the interim financing was packaged as a loan to TCU Place to pay for their portion of construction costs. The Loan Authorization Bylaw essentially outlines the specific terms of loan repayment as it applies to TCU Place's share of the debenture issue. TCU Place is repaying its share of the debenture through incremental revenues flowing from the expansion.

REPORT

The Investment Committee has held ongoing discussions with the City's fiscal agents with respect to debenture issuance. The City's fiscal agents had indicated that borrowing costs remain at very attractive levels despite the recent increase in interest rates. Interest rates remain close to historical lows. Furthermore, the City's fiscal agents commented that the market demand for high-quality, municipal issues remain relatively strong.

On January 24, 2007, the General Manager, Corporate Services Department, with the support of the Investment Committee, accepted an offer from the City's fiscal agents to purchase \$9,645,000 par value City of Saskatoon debentures at an all-in-cost of 4.67%. The debenture issue, to be dated February 14, 2007, is structured as a one to fifteen-year serial issue with principal amounts maturing each year, February 14, 2008 to February 14, 2022, inclusive. The interest rates for the debenture issue range from a minimum of 4.20% to 4.70%

Due to the need for a timely submission of the appropriate documentation to finalize this transaction, the General Manager, Corporate Services Department, requested the City Solicitor to draft the required Debenture Bylaw and Loan Authorization Bylaw for City Council's consideration and approval at today's special Council meeting.
