RECOMMENDATION:

- 1) that City Council approve a post budget increase of \$500,000 to Capital Project 1135 Civic Buildings Comprehensive Maintenance Program, to a total of \$3,885,000;
- 2) that the \$500,000 increase to Capital Project 1135 be funded from the Civic Buildings Comprehensive Maintenance Reserve;
- 3) that the tender submitted by ICBM Services Ltd. for Contract 8-0054 TCU Place Air Handler Replacement, at an estimated cost (including G.S.T.) of \$1,299,005, be accepted; and
- 4) that His Worship the Mayor and the City Clerk execute the contract documents, as prepared by the City Solicitor, under the Corporate Seal.

BACKGROUND

Capital Project 1135 – Civic Buildings Comprehensive Maintenance Program includes all labour, materials and supervision required to replace the two main heating/cooling ventilation fan units that serve the Sid Buckwold Theatre and the Centennial Hall areas within TCU Place. The Theatre and the Hall are closed to bookings from July to September to allow this work to be performed.

REPORT

Tenders for Contract 8-0054 for the replacement of two main heating/cooling ventilation fan units at TCU Place closed on May 7, 2008. One bid was received from ICBM Services Ltd., with a total bid price, including G.S.T., of \$1,299,005, approximately \$500,000 over budget.

The estimated total cost for the completion of all work related to this project is outlined below:

Air Handler Replacement	\$1,237,148 (bid received)
Asbestos Removal	\$120,000 (estimate only)
New Mechanical Room Access Door	\$10,000
Consulting Fees / IS Project Fees	\$80,000
Contingency	\$50,000
Total Estimate	\$1,497,148

The equipment scheduled for replacement has past its useful service life, and the air conditioning unit in Centennial Hall is currently undergoing emergency repairs. The Facilities Branch will be closely monitoring the situation to allow the facility to maintain operations until the planned July 2008 shut down period.

The project is very challenging due to a number of issues including scheduling; the magnitude of the size of the ventilation units; and confined access to the work area; as well as asbestos insulation/fire protection materials which are located adjacent to and attached to these units.

ICBM Services Ltd. has requested that an acceptance of bid letter be received by May 12, 2008 in order for the fan units to be ordered in time to meet the facility shut-down schedule.

The Administration is recommending that the bid submitted by ICBM Services Ltd. be accepted, due to the work they have done in the past in this facility (convention expansion and kitchen improvement projects), and the need to meet the critical schedule requirements of the project.
