F1) 2009 Capital Budget Capital Project 2326 - Access Transit Facility Award of Tender for Bus Storage Building (File No. CK. 665-1; IS 954-08-2 & 7305-1)

RECOMMENDATION:

- that the tender submitted by Graham Construction & Engineering, for Contract No. 9-0038, for the Bus Storage Building, at a total estimated cost of \$5,264,351.40 (including G.S.T. and P.S.T.) be accepted;
- 2) that an increase to the budget of \$750,000 be funded through a reallocation from available federal/provincial grant funds; and
- 3) that His Worship the Mayor and the City Clerk be authorized to execute, on behalf of the City of Saskatoon, under the Corporate Seal, the contract documents, as prepared by the City Solicitor.

REPORT

Capital Project 2326 – Access Transit Facility, identifies a new building to store Access Transit buses, conventional buses, equipment for bus washing, fuelling and fluid dispensing, and renovation of the existing Access Transit building to add dispatch offices. The new building will be adjacent to the existing Access Transit facility and will be LEED Certified.

Tenders for Contract No. 9-0038, Bus Storage Building, were received and opened on April 7, 2009, from the following eight companies:

The bids were reviewed by the representatives from consulting firm Robb Kullman Engineering, the Facilities Branch, and Purchasing Services. The low bidder Graham Construction & Engineering is acceptable to the City of Saskatoon.

FINANCIAL IMPACT

The approved Transit Facility funding in Capital Project 2326 - Access Transit Facility is \$5,275,000.

The net cost to the City of Saskatoon for the tender submitted by Graham Construction & Engineering, including the noted separate prices, is as follows:

There are also engineering fees and project management fees associated with this work, which when combined with the construction tender price will exceed the approved budget for this project. However, the recommended tender price includes the increased building size to allow for storage of an additional 30 traditional buses, which was not included in the original budget submission. The increased building size will protect buses currently stored outdoors from severe temperatures and attenuate noise that is affecting residents in the Caswell area. The estimated total project cost, including the traditional storage component, was \$7,235,000. Based on the tender prices submitted, the new estimated cost is \$5,987,742. Your Administration is recommending that the difference between the original budget and the new total project cost of \$750,000 be funded through a reallocation from available federal/provincial grant funds.

There will be an estimated operating budget impact for 2010 of \$250,000 for the annual building operations, building maintenance, building utilities, and Civic Buildings Comprehensive Maintenance Reserve contribution.
