- b) provide for termination of each Agreement in the event that either payment referred to in a) is not received.
- 2) that the City Solicitor be instructed to draft the necessary amending agreement; and
- 3) that His Worship the Mayor and the City Clerk be authorized to sign the amending agreement.

City Council, at its meeting held on June 22, 2009 approved an extension of the Construction Requirement in its Sale Agreement with Lake Placid River Landing Inc. for the sale of Parcel Y in River Landing Phase I. The Construction Requirement, which requires Lake Placid to complete all excavation required for the project, was extended to June 30, 2010, provided that payment in full for the site was received by 5:00 p.m., August 17, 2009. The Amending Agreement entered into pursuant to Council's resolution provides that the date for payment may be further extended by the City.

As Council is aware, payment was not received from Lake Placid by the date and time specified in Council's resolution. However, prior to the deadline for payment, the City received a request from Lake Placid to extend the time for payment to October 31, 2009. A copy of a letter from the Lake Placid Developments (Saskatchewan) Inc. outlining the request and the reasons therefore is attached (Attachment 1).

Lake Placid has represented to the Administration that its financing for the project has been approved, but that various administrative processes involving the international transfer of funds remain to be completed. The City has received, through Lake Placid, a Certificate of Incorporation and a Notice of Registered Office for Seremia Ltd., who is Lake Placid's lender. We have also received documentation showing that Seremia Ltd. has a bank account with Barclays Bank PLC in Nicosia, Cyprus.

As Council will be aware, interest has been accruing on the outstanding balances of the purchase prices for both Parcel Y and the Lane adjacent to Parcel Y under the two sale agreements. The amount of this accrued interest to August 31, 2009, is \$193,770.48 for Parcel Y and \$20,426.71 for the Lane, totalling \$214,197.19.

Administration is prepared to recommend an extension of the time for payment to 5:00 p.m., October 30, 2009, (October 31 is a Saturday). The extension would be conditional upon Lake Placid paying the accrued interest noted above by 5:00 p.m., August 31, 2009. In the event that this payment is not received, both sale agreements would be at an end and Lake Placid would forfeit the deposits paid under the Parcel Y agreement. This would occur without a further resolution of Council. Similarly, if payment of the full balances owing under each agreement is not received by 5:00 p.m. on October 30, 2009, both agreements would also be at an end without a further resolution of Council.
