GROUP GOLF BOOKING REGULATIONS

20 Golfers or Less

- an updated number of participants is required 10 days in advance, at which time a green fee payment can be made for that number of golfers, which will be discounted 15%. This payment will have their \$200. deposit deducted. Groups not prepaying 10 days in advance are NOT eligible for any green fee discount.

- prepaid groups have to update to a confirmed number 72 hours in advance.

- refunds will be issued 72 hours in advance for groups that have overpaid.

If this size of group prefers to pay individually, their \$200. deposit will remain on-site until after the event and MAY be used to pay for golfers confirmed 72 hours in advance but not showing.

ONLY prepaid gas carts will be guaranteed.

21 – 140 Golfers on a Draw Start

- an updated number of participants is required 10 days in advance, at which time a green fee payment is due for that number of golfers. Green Fee payments made 10 days in advance will be discounted 15%. This payment can have their \$200. deposit deducted if requested by the group's organizer. Deposits not deducted will be left on-site to secure bookings for the following year.

- groups not prepaying 10 days in advance are NOT eligible for any green fee discount, and if not paid for all required tee times at least 72 hours in advance will only be guaranteed two tee times.

- prepaid groups have to update to a confirmed number 72 hours in advance

- refunds will be issued 72 hours in advance for groups that have overpaid.

ONLY prepaid gas carts will be guaranteed.

120-144 Shotgun Start Events

- payment for a minimum of 120 golfers and 60 carts is required at least 10 days in advance. The Green Fee portion of this payment will be discounted 15% and can have their \$500. deposit deducted if requested by the group's organizer. Deposits not deducted will be left on-site to secure bookings for the following year.

- pre-payments for more than 120 may be refunded down to 120 if notice is given at least 72 hours prior to the booking.

1. Groups that have overpaid will only be entitled to a refund if they have contacted the golf course at least 72 hours prior to their booking. Refund requests with less than 72 hours notice MAY be processed if cancelled bookings are able to be re-booked prior to the event, and are at the discretion of the golf course manager.
2. Groups not prepaying their green fees, or not notifying the pro shop at least 72 hours prior to their event will have their bookings cancelled with no refunds for any prepaid fees. Only groups paying at least 10 days in advance will be entitled to the 15% green fee discount.
3. Refunds or Rainchecks may be issued in part or in full should the event be cancelled due to inclement weather on the day of the event. These types of refunds would be at the discretion of the golf course manager. All attempts will be made to reschedule groups that are cancelled due to weather prior to issuing refunds or rainchecks. Our regular raincheck policy is in effect once a group is already on the golf course and the weather causes the golfers to discontinue play. This policy allows for full rainchecks for those that have not completed 3 holes, and 9 hole rainchecks for 18 hole players that have not completed 3 holes on the back 9.
4. On a weekend or legal holiday, 18 hole draw start events cannot begin before 10:00 a.m. on an 18 hole course. 9 hole events on the 18 hole course at Holiday Park golf course cannot start until after 3:00 pm on Fridays, Saturdays, and Sundays.
5. The event co-ordinator is responsible for supplying a current list of players, grouped in foursomes at least one day prior to the event. We would appreciate at least one weeks notice for events that may require: Hole in One Yardage Requirements, Tables, Chairs, Hole and Tee Marker Placement Requests, Sponsor Sign Placement, Closest to the Line Competitions, and Long Drive and Closest to the Pin Markers.
6. Unacceptably slow players will be asked to play the forward tees, or pick up and move forward without completing a hole to facilitate proper pace of play.
7. Golf course rules and proper etiquette as defined by the Royal Canadian Golf Association, the City of Saskatoon, and the Saskatchewan Liquor and Gaming Authority must be adhered to, and will be strictly enforced. The City of Saskatoon Municipal golf courses reserves the right to discontinue alcohol service to any guest who appears to be intoxicated.
8. Wildwood and Silverwood Golf Courses are non-licensed facilities. Alcoholic beverages on these premises are not permitted at any time. Holiday Park Golf Course is a licensed facility. Only alcoholic beverages purchased from the Beverage Cart or the Lounge may be consumed on the golf course, as prescribed by the Saskatchewan Liquor and Gaming Authority regulations. Beverage cooler chests are not permitted on the golf course. Those that insist on attempting to, or consuming their own alcoholic beverages on the golf course, or it's premises, will be removed without the possibility of any refunds for prepaid fees and/or rentals, and subject to court imposed fines and penalties up to \$10,000.
9. Golfers are expected to wear proper golf attire at all times including a full bodied shirt and suitable shorts or pants. Gentlemen are recommended to wear shirts with sleeves; ladies may wear sleeveless shirts. Shirts must be worn at all times. Exposed midriffs, strapless or halter tops, and bathing suits are not permitted. For your own personal safety, suitable footwear must be worn at all times which may include soft-spike golf shoes, running shoes, sandals or soft-soled shoes. To prevent damage to the golf course, no heels over one half inch or boots of any kind are permitted. Playing in bare feet is not permitted.
10. All 18 hole players must proceed to the tenth hole without delay after finishing the ninth hole of play, with a maximum break of 5 minutes.
11. The City of Saskatoon assumes no responsibility for the loss or damage of personal property or for the safety of golf course users. The event is financially responsible for any and all damages to the municipal golf facility including the course, equipment and golf carts, and agree to reimburse the City of Saskatoon for any such injury or damages done.
12. The City of Saskatoon and its municipal golf courses reserve the right to cancel or suspend playing privileges, without refund, to anyone or the entire group for non-compliance of any of the above rules and regulations, or for any action which is abusive or offensive to the property, facility, its patrons and employees.
13. It is the responsibility of the event organizer to ensure all participants are aware of these rules and regulations.

In consideration of providing group booking services we hereby release the City of Saskatoon from any and all claims. We agree to protect, hold harmless and indemnify the City of Saskatoon, their employees and agents against all losses, damages, claims, demands and actions arising directly or indirectly in any matter whatsoever in connection with the tournament and shall pay all costs, expenses of any such claim or litigation. We further agree to abide by the golf course regulations and assume financial liability for any damage to the facilities, furniture and equipment or the loss of furniture and equipment when caused by negligent or abusive treatment.
