

## Accessible Parking Permit Subsidy

### Required Information and Documents (COPIES ONLY - these are NOT returned to you):

To be eligible for the Accessible Parking Permit Subsidy placard users must be a Saskatoon resident and possess a valid and current SaskAbilities Accessible Parking placard. Additionally, the placard user's household income must fall below the applicable Low Income Cut-Off (LICO) amount.

- You must submit a **COPY** of last year's **Income Tax Notice of Assessment** for the placard user **AND** their spouse/partner. We do not accept any other income document. If you need a copy of your Income Tax Notice of Assessment, call 1-800-959-8281 and it will be mailed to you. Ask the Tax office for the '**Option C Form - Income & Deductions**'. **Make sure** that the amount from line 15000 of the Notice is equal or lower than the Low Income cut-off numbers on the back of this form under **Do I Qualify?**
- If **SECTION ONE** of the Notice of Assessment has the placard user's name and current physical address, please provide that page for proof of Saskatoon Address.
- ☐ **COPY** of proof of Saskatoon address showing current name and address. Example: current utility bill, government issued identification.
- ☐ **COPY** of valid and current SaskAbilities Accessible Parking placard.

**It takes a minimum of 3-4 weeks to approve the subsidy.** Incomplete applications take longer to process.

**Incomplete applications** are returned to you with instructions on what is missing. Applications are processed in the order received to ensure fairness. **Make sure you have checked the Income cut-offs on the back of form to see if you qualify.**

- You must wait to receive your subsidy approval before purchasing a permit at the discounted rate.
- The form must be signed for it to be considered a complete application.

## Details about this program:

Following a review of the Accessible Parking Permit Program, changes were made to the fee to purchase the permit. To minimize the financial disruption for permit users, a subsidy is being offered to users that qualify based on the LICO amount. Users who qualify will be eligible to purchase one Accessible Parking Permit for 50% of the permit price. Users will need to re-apply every year to receive the subsidy

## Required Documents:

- You must submit a **COPY** of last year's **Income Tax Notice of Assessment** for the placard user **AND** their spouse/partner (if you have one). We do not accept any other document as proof of income. If you do not have a copy of the placard user's Income Tax Notice of Assessment, you can get one by calling 1-800-959-8281, and it will be mailed to you. Ask the Tax office for the 'Option C Form - Income & Deductions'.
- This program is **ONLY** for Saskatoon residents who possess a valid and current SaskAbilities Accessible Parking placard.
