### Monthly Rates (Effective Feb 1, 2026)

The City has historically set its rates to match those established by SaskPower. This is to ensure there are no inequities between utility customers regardless of whether their property is within the SL&P or SaskPower franchise area.

*Note: Carbon Charge collection is temporarily paused*

Request for meter dispute test	\$220 per test. Charges refunded if meter fails test.
Request for research: Customer initiated and covering immediately preceding 12 months	No charge
Request for research: Customer initiated and covering periods in excess of the immediately preceding 12 months	\$25 for each year researched
Self-Generation Application	\$300
Self-Generation Interconnection Study	Actual cost
Self-Generation Interconnection Upgrades	Actual cost
Polyphase/Transformer-Rated Bi-Directional Meter for Self-Generation	Actual cost
Service Tamper Charge	\$400 or actual cost, whichever is greater.
