2019/2020 City of Saskatoon eBill Promotion Contest: Official Contest Rules

- 1. The 2019/2020 eBill Promotion Contest ("Contest") runs from December 1, 2019 until February 15, 2020. ("Contest Period").
- 2. No purchase is necessary to enter. The City of Saskatoon eBill service ("eBill") is a City of Saskatoon service offered free of charge.
- 3. Each eligible new customer activated on eBill during the Contest Period will be automatically entered into the Contest. All existing City of Saskatoon eBill customers are automatically entered and included in the Contest.
- 4. The contest winner must be a current or new eBill subscriber at the date of the draw for which they have been selected as the winner.
- 5. Chances of winning a prize are dependent on the number of eligible entries at the time of the prize draws. There will be (2) prize draws: each for a \$250 credit to be applied to the eBill customer's March 2020 City of Saskatoon utility bill account. Prizes to be drawn on February 17, 2020. Chosen winners must correctly answer a time limited mathematical question before being declared a winner.
- 6. This Contest is subject to all applicable federal and provincial laws.
- 7. The City of Saskatoon is the sole judge and decision maker regarding any dispute about the application or interpretation of the Rules or any other aspect of the Contest and the judgement or decision of the City of Saskatoon will be final.

How to Enter:

There is no purchase necessary to enter the eBill Promotion Contest. All new customers subscribing to eBill, along with existing eBill subscribers will automatically be entered into the eBill promotion Contest for the (2) prize draws on February 17, 2020.

Eligibility:

8. The Contest is only open to Saskatchewan residents. The contest winner must be a current or new eBill subscriber as at the date of the draws for which they have been selected as the winner.

The Contest is **not open** to the following:

Management of the City of Saskatoon <u>Corporate Revenue Division</u>, or members
of their family with whom they reside with at the same eBill address.

Prizes:

The Corporate Revenue Division will draw for (2) prizes on February 17, 2020.

- 1. Prizes drawn for: (2) prizes of a \$250 credit to be applied to (2) ebill subscriber's March 2020, City of Saskatoon utility bill account.
- Prize draw will include all existing customers already on the eBill service, and all new eBill customers who signed up during the promotional period December 1, 2019 to February 15, 2020.
- 3. The City of Saskatoon reserves the right to make a substitution for the prizes in whole or in part in the event that any prize or component thereof is unavailable.
- 4. If a winner cannot be reached by written notice/ phone call within 14 days of the draw date, he/she will be deemed to have forfeited his/her opportunity to win, and a new winner will be chosen.
- 5. By entering the Contest, entrants are deemed to have read and agreed with these Rules and release the City of Saskatoon, its employees and agents and the prize providers from any and all liability resulting from the participation in the Contest and any use of the prizes.
- 6. Only the winners selected in the Draw from the eBill promotion Contest will be contacted by the City of Saskatoon.
- 7. The City of Saskatoon will make the final determination on the eligibility of all entries.
- 8. As a winner, you consent to the publication of your name in various communication platforms as reasonably determined by the City of Saskatoon for a period of 60 days after the Contest.

Prize Redemption and Exchange:

- 1. All prizes must be accepted as awarded, are not redeemable for cash and are non-transferable.
- 2. The two winners will be notified by way of written notice, and/or telephone call. The winner must present identification verifying name and address.
- 3. The City of Saskatoon is the sole sponsor of the eBill Promotion Contest.
