The use of the Land is limited to one of the following:

1. Pasture land (fencing and water reservoir required)
2. Breaking the land for crop production

The Land requires the installation of a water reservoir and livestock fence.

It would be the responsibility of the successful bidders to break or fence the Land.

Bids must be accompanied by a certified cheque or bank draft payable to the City of Saskatoon for 10 percent of the submitted bid Should the successful bidder not lease the above Land, the deposit will be forfeited. Deposits will be returned to unsuccessful bidders.

All bids are irrevocable for a period of 14 days from the tender closing date. All submitted tenders become the property of the City of Saskatoon until such time as the tender is either awarded or rejected.

Bidder is responsible to familiarize themselves with the land prior to submitting a bid.

Bids must be for all 160 acres of land as noted above.

Conditional and multiple bids will not be accepted..

The highest or any bid will not necessarily be accepted.

Bidders who are either a Councillor or Official with the City of Saskatoon must identify they are employed by the Municipality on the front of the sealed bid.
