**WHAT WE KNOW** 

## We know most businesses and organizations send their organics to landfills

Only 23% of businesses and organizations reported composting all or some of their organic material. The top reasons for not composting included having a small amount of organic waste, lacking space, and not having enough time.<sup>1</sup>

### Residents want businesses and organizations to do their part

Almost 70% of residents support banning organics from business garbage bins.<sup>2</sup>

#### We can find solutions

Cities including Calgary, Halifax, and Metro Vancouver all have organics requirements for businesses and organizations. We intend to learn from them, work with local waste haulers and processors, and listen to your ideas.

# Waste from businesses and organizations is managed differently

Private haulers collect waste from most businesses and organizations. Requirements for organics are unlikely to change who collects waste.

#### WHY DO WE NEED THIS?

### 25% of what is thrown out could be composted

98% of organic material is food waste.3

### Composting organics has many benefits

Materials can be turned into valuable compost, while saving energy, water, and lowering greenhouse gases.

### Organics don't decompose properly in landfills

When buried in a landfill without oxygen, organics can take a long time to decompose. When they eventually break down they release powerful greenhouse gas emissions (methane) and a liquid runoff (leachate).
