
Removal of Municipal Reserve Designation – 421 Central Avenue



HAMPTON VILLAGE BUSINESS PARK - PROPOSED CONCEPT PLAN AMENDMENT

Saskatoon City Council will consider amendments to the Hampton Village Business Park Concept Plan proposed by Catterall & Wright Consulting Engineers on behalf of Kahkewistahaw First Nation. The map amendments are shown on the map below and consist of the following:

- Reconfigure Development Sites: to accommodate changes to roadways and servicing;
- Change of Land Use: Approx. 4.4 ha (10.8 ac) redesignated from Business Park to Light Industrial and approx. 0.3 ha (0.7 ac) redesignated from Municipal Reserve to Utility to accommodate the sanitary sewer lift station;
- Road Network Reconfiguration: Adjustments to the road network throughout including a shift to the intersection of Gallagher Street and Markham Avenue to the south;
- Storm Water Management: To accommodate changes to the roadway network and land use plan, adjustments to area grading and a redesign of the centralized storm water facility are proposed. A second storm water facility has been added in the northeast corner of the plan to assist in the management of runoff.
- Adjustment to Municipal Reserve: The layout of the proposed Municipal Reserve area is adjusted to accommodate the amendments listed above and to accommodate the sanitary
