The Standing Policy Committee on Finance will consider a report from the Administration during the Regular Meeting of the Standing Policy Committee for Finance to be held on Wednesday, December 3, 2025, at 2:00 p.m., in Council Chambers, City Hall.

The report recommends that the City of Saskatoon enter into a renewal of lease agreement with **POW City Kinsmen Club of Saskatoon** for Sutherland Memorial Hall located at:

• 1112 Central Avenue

The lease would allow the Kinsmen Club to continue operating the City-owned Sutherland Memorial Hall for a further lease term of 5 years. Any income generated from hall rentals in excess of the amounts reasonably required to operate the hall would be retained within a fund for future hall operating and maintenance expenses. Net income over \$5,000 would be transferred to the City. The Kinsmen Club would continue to be responsible for utilities and operating costs.
